Three Rivers Division Officer Candidates Sought

Three Rivers Division Members interested in candidacy for a Division Officer, through the Nominating Committee Process, are sought.

The two-year term for all current Three Rivers Division officers will expire at the close of the June 3, 2025 Governing Board Meeting.

The nomination process will identify a recommended slate of officers, but any Division member not included within the recommended slate may still be nominated for any office “from the floor” at the Governing Board meeting (providing each nominated member is present and consents to his/her nomination).

The Three Rivers Division offices that are open for candidacy are as follows:

IASB Director

- The IASB Director shall be a member of the IASB Board of Directors and shall report to the Division regarding activities of the IASB Board of Directors.

Chair

- The Chair shall be the chief elective officer of the division, preside at Division meetings and shall be a member ex-officio of all committees except the Nominating Committee.

Vice Chair

- The Vice Chair shall assist the Chair and shall act as a Chair in the temporary absence of the Chair.

Resolutions Chair

- The Resolutions Chair shall represent the Division on the IASB Resolutions Committee and shall give a Resolutions Committee report, as needed, at Division meetings.

Nominating Chair

- The Nominating Chair shall lead the Nominating Committee in selecting a slate of candidates to be presented at the biennial Governing Board meeting.

Four (4) Directors-at-Large positions

- The Director-at-Large shall act as liaison to Governing Board representatives, provide assistance and guidance to the Chair and Vice Chair as needed, and greet attendees at Division meetings.
