Elementary School

Our LES summer school started this week. All students in grades K-5 have access to math and reading lessons using an online program called iReady. Approximately 170 students that received interventions (those with an IEP and/or Tier 2 and Tier 3 interventions) in either math and/or reading were invited to participate in summer school with additional remote instruction from a teacher. We have 85 students that have signed up for the additional remote instruction. All students can sign up for a conference with a teacher to review their progress and get any of their questions answered.

Junior High School

Remote learning summer school successfully began on June 15th. In addition, a summer choice board has been distributed and posted on our website for all of our students to work on this summer to stay engaged.

Summer curriculum work is in progress. A highlight of the work being done is a committee reviewing potential ELA curriculum/programs to pilot next year.

High School

We are pleased to announce that starting **July 1, 2020**, Lisle High School will resume Behind-The-Wheel instruction for all Driver Education students who were enrolled in the class during the second semester of 2020. It is important that families understand the procedures and all participants adhere to the health and safety requirements provided by the Secretary of State and IDPH. Per Illinois Law, there will be two students and one instructor in the vehicle at all times. In addition, students will need to follow the guidelines below:

- Students will wear a facemask for the entirety of the BTW lesson.
- Students will sign a form prior to driving that indicates he/she is free of symptoms of illness.
- Students will not have access to the school building.
- Parents will remain at school until both drivers are confirmed to drive for the lesson. If for any reason one student is unable to drive, the lesson will be rescheduled for both drivers.
- Any student showing signs of illness should be kept home, and parents should contact the instructor to reschedule.

Please be assured that we are committed to student and staff safety. Therefore, we will follow the guidelines provided by the Illinois State Board of Education as shown below:

- Only two students and one instructor per vehicle
- Face coverings must be worn, unless medically contraindicated.
- Prohibit eating and drinking in the vehicle.
- Open the windows whenever possible.
- Do not make any stops during the training that are not applicable to Driver Education
- Complete hand hygiene with soap and water or hand sanitizer, as appropriate, before and after driving and, at the minimum, upon completion. Hand sanitizer should be placed in each vehicle.

- Clean and disinfect the steering wheel, door handles, seat belt fastener, controls/dials that the driver would encounter, keys, etc. in between each Behind-The-Wheel session.
- Conduct regular routine cleaning and disinfecting of the seats.
- Social distancing guidelines should be followed when not inside the vehicle.

Food Service

Meal services for students have continued with the help of our friends at Aramark. During the Remote Learning time period, more than 2,000 meals were distributed.

Meals are available for pick up for all children under the age of 18, or still enrolled in school. Food Service will continue Mondays & Wednesday through July 31 and can be picked-up from Lisle High School from 11:00am-1:00pm.
