

# MEMBERSHIP AGREEMENT

## RAMPAGE BOXING GYM

This Membership Agreement (the "Agreement") is entered into and made effective as of the date of final signature below (the "Effective Date"), by and between Rampage Boxing (hereinafter referred to as the "Club") and the individual named below (hereinafter referred to as the "Member").

### 2. MEMBERSHIP FEES & BILLING CYCLE

The Member agrees to pay a recurring membership fee of \$50.00 USD every three (3) months (the "Quarterly Fee") to maintain active membership status at the Club.

The initial payment of \$50.00 USD is due upon the execution of this Agreement.

Subsequent payments of \$50.00 USD will automatically be billed or must be paid manually every three (3) months on or before the corresponding calendar day of the renewal month (each, a "Due Date").

### 3. ALLOCATION AND USE OF FUNDS

The Club explicitly covenants and guarantees that all financial allocations derived from membership dues shall be handled with absolute fiscal exclusivity:

Direct to Club: 100% of the funds collected from the Member's \$50.00 USD quarterly payment shall be directed entirely to the Club's operating accounts.

Exclusive Facility Purpose: All collected funds shall be utilized solely and exclusively for the Club itself. This includes, but is not limited to, the direct support of gym operations, physical facility maintenance, utility costs, trainer fulfillment, boxing equipment acquisition, and improvements directly benefiting the gym environment. No portion of these funds shall be allocated to external entities, personal distributions, or any non-club-related expenditures.

#### **4. LATE PAYMENT & SUSPENSION OF BOXING PRIVILEGES**

Timely payment is strictly required to maintain facility access and training privileges. The following terms govern past-due accounts

**IMPORTANT NOTICE:** If the Member misses a payment or fails to pay the \$50.00 USD Quarterly Fee by the designated Due Date, the Member's right to utilize the gym facilities, participate in training sessions, attend classes, or engage in boxing activities of any kind will be IMMEDIATELY SUSPENDED.

**No Entry Policy:** A Member with an outstanding balance will be barred from entry to the training ring, floor, and equipment area, and will not be permitted to box until all overdue funds are paid in full to the Club.

**No Partial Credits:** The recurring 3-month billing cycle timeline will not be altered, paused, or prorated to account for days missed due to suspension resulting from non-payment.

**Account Reactivation:** Membership and boxing privileges will be restored immediately upon the Club's successful receipt and processing of the total outstanding balance.

#### **5. MEMBER CONDUCT & GYM RULES**

The Member agrees to strictly follow all safety regulations, code of conduct requirements, and trainer directions provided by the Club. The Club reserves the right to terminate the membership of any individual who violates safety rules, exhibits unsportsmanlike conduct, or causes disruption to other members or staff.

## 6. ENTIRE AGREEMENT

This document constitutes the entire agreement between the parties regarding membership terms, fund allocation rules, and payment obligations. No verbal modifications or amendments to this contract shall be

valid unless executed in writing by both parties.
