

ORDER calling a public hearing concerning the intent of the Board of Education of Township High School District Number 210, Cook and DuPage Counties, Illinois, to sell not to exceed \$50,000,000 Working Cash Fund Bonds.

WHEREAS, Township High School District Number 210, Cook and DuPage Counties, Illinois (the “*District*”), is a duly organized and existing school district created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the School Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto, including the Local Government Debt Reform Act of the State of Illinois, as amended; and

WHEREAS, the Board of Education of the District (the “*Board*”) intends to sell bonds in the amount of not to exceed \$50,000,000 for the purpose of increasing the working cash fund of the District (the “*Bonds*”); and

WHEREAS, the Bond Issue Notification Act of the State of Illinois, as amended, requires the Board to hold a public hearing concerning the Board’s intent to sell the Bonds before adopting a resolution providing for the sale of the Bonds:

NOW, THEREFORE, Be It and It Is Hereby Ordered by the undersigned President of the Board of Education of Township High School District Number 210, Cook and DuPage Counties, Illinois, as follows:

1. I hereby call a public hearing to be held at 6:00 o’clock P.M. on the 11th day of May, 2026, in the Board Room at the Lemont High School, 800 Porter Street, Lemont, Illinois, in the District, concerning the Board’s intent to sell the Bonds and to receive public comments regarding the proposal to sell the Bonds (the “*Hearing*”).

2. I hereby direct that the Secretary of the Board (the “*Secretary*”) shall (i) publish notice of the Hearing at least once in either the *Lemont Suburban Life* or the *Daily Southtown*, each being a newspaper of general circulation in the District, not less than 7 nor more than 30 days before the date of the Hearing and (ii) post at least 72 hours before the Hearing a copy of said notice at the principal office of the Board, which notice will be continuously available for public review during the entire 72-hour period preceding the Hearing.

3. Notice of the Hearing shall appear above the name of the Secretary and shall be in substantially the following form:

The Board shall not adopt a resolution selling the Bonds for a period of seven (7) days after the final adjournment of the Hearing.
