STAFF RECOMMENDATION: It is recommended that the Board of Trustees approve the proposed revisions to the LOCAL policies included in TASB Policy Update 51, as presented.

BACKGROUND: The Texas Association of School Boards (TASB) periodically issues policy updates to ensure that member institutions' policy manuals remain current with changes in state law, administrative rules, court decisions, and recognized governance best practices. Unlike LEGAL policies, which summarize requirements established by law and do not require Board action, LOCAL policies establish how the Board chooses to implement those legal requirements and therefore require Board approval.

TASB Policy Update 51 is primarily a maintenance update following the adoption of Update 50. The update includes revisions to five LOCAL policies intended to improve governance practices, clarify administrative responsibilities, and align institutional policies with recently adopted state laws and Texas Higher Education Coordinating Board and Department of Information Resources (DIR) rules.

BBC (LOCAL) – Board Members: Vacancies and Removal from Office

This new policy establishes a standardized process for filling vacancies on the Board of Trustees, including procedures for public notice, accepting applications, reviewing candidates, and making appointments. The policy promotes transparency and consistency while ensuring compliance with existing law governing Board vacancies.

BGC (LOCAL) – Councils and Faculty Senates

The policy includes a minor clarification regarding the appointment of faculty council members from each divisional delegation. This revision incorporates the Board-approved local customization adopted earlier this year while maintaining compliance with Senate Bill 37 and preserving the advisory role of the faculty council.

CS (LOCAL) – Information Security

The policy is revised to reflect amendments to Department of Information Resources (DIR) rules implementing House Bill 1500. Specifically, the revisions remove information security assessment components that are no longer applicable to community colleges and clarify institutional information security responsibilities.

FB (LOCAL) – Admissions

The policy is revised to clarify the administration of the Academic Fresh Start program by expressly stating that the College may not award academic credit for coursework that is disregarded for admission purposes under state law.

FDA (LOCAL) – Residency

The policy updates the title of the Residence Status Determination Official to align with newly adopted Texas Higher Education Coordinating Board rules governing residency determinations for tuition purposes. This is a technical revision and does not change the College's residency determination process.

Unlike Update 50, which implemented significant legislative changes affecting institutional governance and operations, Update 51 is primarily a technical and maintenance update intended to refine recently adopted policies, improve clarity, and ensure continued compliance with evolving state requirements.

Administration has reviewed the proposed revisions and recommends adoption of TASB Policy Update 51.

BUDGETARY CONSIDERATIONS: None anticipated. These policy revisions are administrative and compliance-related in nature and can be implemented using existing institutional resources.
