

2026–27 SCHOOL ATHLETICS SPONSORSHIP AGREEMENT

Chick-fil-A® Glenpool is pleased to offer Sapulpa Athletics a sponsorship package that includes a food credit, special school pricing, concession opportunities, and exclusive fundraising events.

In return, Chick-fil-A® Glenpool's Marketing and Events Team will be invited to attend two school athletic events during the 2026–27 school year and receive related game-day advertising opportunities.

FOOD CREDIT: \$3,000.00 (Retail)

- The food credit may be used for team meals or concession purchases.
- The following current retail prices will be applied against the food credit:

Chick-fil-A® Chicken Sandwich: \$4.99

Chick-fil-A® Spicy Chicken Sandwich: \$5.39

- Pickup and delivery are available. *Delivery orders require a minimum of 50 sandwiches.*
- The Athletic Director must provide Chick-fil-A® Glenpool with the names of anyone authorized to use the food credit.
- A current food-credit balance will be provided upon request.
- The food credit expires one month before the final day of the school year to allow time for end-of-year reconciliation.
- Unused sponsorship balances do not roll over to the following school year.

SPECIAL SCHOOL PRICING

Once the food credit has been used, the school may continue ordering at the following special prices:

- Original Chick-fil-A® Sandwich: \$4.00 each
- Chick-fil-A® Spicy Chicken Sandwich: \$4.25 each
- Special pricing is available for pickup or delivery and requires a minimum order of 50 sandwiches.
- The school will also receive 10% off Chick-fil-A® catering trays and boxed meals.
- Orders must be for school-related events and paid for directly by the school.

- Current tax-exempt documentation may be requested when an order is placed.

Please contact Chick-fil-A® Glenpool to confirm availability and work through the details of each order.

CONCESSION PROGRAM

- Chick-fil-A® Chicken Sandwiches may be purchased for resale at school concessions.
- Sandwiches must be sold for no less than the current retail price of \$4.99 each. The school may increase the selling price for fundraising purposes.
- Standard sandwich orders include pickles and one Chick-fil-A® Sauce per sandwich unless other arrangements are made in advance.
- “Provided by Chick-fil-A® Glenpool” signage must be displayed while the sandwiches are being sold. Chick-fil-A® Glenpool will provide the signage.
- Insulated heating bags may be available and must be returned the following business day. Due to potential allergen contamination, these bags may only be used for Chick-fil-A® products.

MOO CREW CAMPUS FUNDRAISING EVENTS

When scheduling allows, the Chick-fil-A® Glenpool Moo Crew may attend a school athletic event with our marketing tent, music, and fundraising games.

- The school will select one school organization to receive the funds raised that evening.
- The selected organization must provide two representatives to assist at the Chick-fil-A® tent before the game and through halftime.
- All money collected through the Moo Crew’s games and fundraising activities will be donated directly to the selected organization.
- Cash proceeds will be converted into a check and available for pickup from Chick-fil-A® Glenpool the following week.

IN-STORE SPIRIT NIGHTS

The school may also request an In-Store Spirit Night at Chick-fil-A® Glenpool.

- Spirit Nights are held from 5:00–8:00 p.m. and must be scheduled at least four weeks in advance.
- Chick-fil-A® Glenpool will donate 10% of eligible sales when guests mention the organization while ordering.

- Purchases may qualify through Dine-In, Carry-Out, Drive-Thru, Catering, or Mobile App orders. A special code will be provided for mobile orders.

- The organization must provide two representatives to host a table throughout the event. Representatives may engage guests after they have ordered but may not solicit participation before the point of sale.

- Optional fundraising activities may include a \$1 Prize Wheel and a \$1-per-ticket raffle. Chick-fil-A® Glenpool will provide 10 free-meal cards as the raffle prize.

- Chick-fil-A® Glenpool will provide one promotional graphic. The school or participating organization is responsible for promoting the event through its available communication channels.
