

AMENDMENT TO SEPARATION INCENTIVE AGREEMENT

This AMENDMENT TO SEPARATION INCENTIVE AGREEMENT (the "Amendment") is hereby entered into and made effective September 14, 2026, by and between the **Board of Education of Dodge County School District 27-0594**, commonly known as **Logan View Public Schools**, referred to herein as the "Board" and "School District" respectively, and **Amy Moeller**, referred to herein as "Teacher." (The Board, the School District, and Teacher may each be referred to in this Amendment as a "Party," or collectively as the "Parties.")

RECITALS

WHEREAS, the Parties entered into that Separation Incentive Program Application and Agreement made effective November 13, 2024 (the "Agreement"); and

WHEREAS, among other terms, conditions, and limitations, the Agreement provided in relevant part that Teacher would be ineligible for parttime or full time employment with the School District "with the exception of limited substitution (maximum of 40 days per school year during SY 2025-26, maximum of 89 days per school year thereafter)"; and

WHEREAS, the School District has a difficult to fill teaching position for the 2026-2027 school year, for which Teacher is well-qualified, and in which Teacher is interested in serving; and

WHEREAS, the Parties intend for the School District to employ Teacher 2026-2027 School Year as reflected in a separate Teaching Contract that the Parties intend to enter into on or about the same date as the effective date stated above;

WHEREAS, the Parties desire to amend the Agreement as provided herein.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants, promises, and conditions set forth herein, the Parties agree as follows:

1
AGREEMENT

1. **Recitals Incorporated Herein.** The foregoing recitals are incorporated herein by this reference with the same force and effect as if the same were set forth in the body of this Agreement section in their entirety.

2. **Amendments.** The Parties agree the last sentence of Section 2 of the Agreement shall be replaced in its entirety and shall now read as follows:

Teacher agrees that with the exception of the 2026-2027 School Year, Teacher will not be eligible for part-time or full-time employment with the exception of limited substitution (maximum of 40 days per school year during SY 2025-26, maximum of 89 days per school year thereafter).

3. **No Other Change.** Except as otherwise expressly provided in this Amendment, all of the terms, conditions, and limitations of the Agreement remain unchanged and in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this AMENDMENT TO SEPARATION INCENTIVE AGREEMENT to be effective as of the date set forth above.
