

**Resolution For United Township High School District 30
Adopting the Budget for Fiscal Year 2027**

WHEREAS, the Board of Education of United Township High School District 30, Rock Island County, State of Illinois, (the “Board”) caused to be prepared in tentative form the budget (the “Budget”), and the Secretary of the Board has made the same conveniently available to public inspection for at least thirty days prior to the final action thereon; and

WHEREAS, a public hearing was held as to such budget on the 14th day of September 2026, notice of said hearing was given at least thirty days prior thereto as required by law, and the Board has complied with all other legal requirements; and

WHEREAS, the Board resolved to approve the Budget on the 14th day of September 2026.

NOW THEREFORE BE IT RESOLVED BY THE UNITED TOWNSHIP HIGH SCHOOL DISTRICT 30 BOARD OF EDUCATION, COUNTY OF ROCK ISLAND, STATE OF ILLINOIS, AS FOLLOWS:

Section 1: The Superintendent, in partnership with the CSBO, was designated to prepare the Budget for fiscal year 2027.

Section 2: That said budget was made available in such proposed form to public inspection on July 21, 2026, at least 30 days prior to final action therein.

Section 3: That notice of the availability of said Budget for public inspection was given by the publication in The Dispatch / Rock Island Argus, being a newspaper generally circulated in District 30.

Section 4: This resolution shall be in effect upon its passage, approval, and publication as provided by law.
