**Background Information:**

Stakeholder input plays a vital role as we continue to shape and strengthen the practices, policies, and education provided to our students and community. The District Advisory Council (DAC) is a group of stakeholders who serve in an advisory capacity to the FISD School Board and district leadership. DAC members support their respective committees by reviewing and offering feedback on key district-wide initiatives, educational goals, performance objectives, instructional programs, student support services, and compliance-related matters.

In addition to committee service, DAC members will have opportunities to contribute to the development of FISD's strategic plan and engage in learning experiences related to various district operations.

The application window for District Advisory Council committees was open to staff, students, parents, and community stakeholders from August 1, 2026 to August 31, 2026. From the applications:

- Student members were selected by their school principal
- Staff members were selected by the facilitators of each DAC committee
- Parents and community members are recommended by DAC facilitators for appointment by the Board

Regarding the District Library Advisory Committee, SB 13 requires that each Board member have an equal opportunity to appoint voting members. Therefore, each Board member individually appointed one voting member and one alternate non-voting advisory member. The attached committee list notes the Board member who appointed each voting member.
