Luling Independent School District Board of Trustee's Proclamation:

WHEREAS, the crime of domestic violence and teen dating violence violates an individual's privacy, dignity, security and humanity, due to systematic use of physical, emotional, sexual, psychological and economic control and/or abuse including abuse to children and the elderly,

WHEREAS, the problems of domestic and teen dating violence are not confined to any group or groups of people, but cut across all economic, racial and societal barriers, and are supported by societal indifferences, and

WHEREAS, the impact of domestic violence is wide ranging, directly affecting individuals and society as a whole, here in this community, throughout the United States and the world, and

WHEREAS, the Luling Independent School District, the Caldwell County Sheriff's Office, and the Caldwell County District Attorney's office are partnering with the Hays-Caldwell Women's Center to promote Domestic and teen dating violence awareness in our schools, and our community,

NOW THEREFORE, I, Keith Conley, by virtue of the authority vested in me as the President of the Luling ISD Board of Trustee's, do hereby proclaim the month of October to be *National Domestic and Teen Dating Violence Awareness Month* and in recognition of the important work done by domestic violence programs, and the Hay's Caldwell Women's Center, I urge all students, staff and community members to actively participate in the scheduled activities and programs to work toward eradicating domestic violence, improving victim safety and holding perpetrators of domestic abuse accountable for their actions against individual victims and our society as a whole.
