Board Bylaw 9311, Board Policies:...Prior to adoption, policies shall normally be given two readings by the Board. At its second reading, the policy may be adopted by a majority vote of all members of the Board.

Issue Summary:

Administration recommends that the NSBSD Board of Education approve the second reading for adoption of the following policies:

BB 9320, Meetings: Updates Board meeting requirements, including language requiring Board members participating remotely to attend from a private location that allows Board business to be conducted without interruption and maintains confidentiality when necessary.

BP 4020, Drug, Tobacco, and Alcohol-Free Workplace (All Personnel): Updates the District's drug, tobacco, and alcohol-free workplace policy, including definitions and expectations regarding prohibited substances, tobacco and nicotine products, and employee responsibilities.

BP 4112.1, Contracts (Certificated Personnel): Updates the process for issuing certificated personnel contracts.

BP 5119, Children of Military Families: A new policy addressing educational barriers faced by children of military families and providing flexibility related to enrollment, placement, activities, graduation requirements, and transitions in accordance with Alaska law.

BP 6111, School Calendar: Updates school calendar requirements, including site and CSAC involvement, community needs, instructional days, holidays, workdays, and inservice days.

BP 6145, Extracurricular and Cocurricular Activities: Updates student eligibility requirements for extracurricular and cocurricular activities.

BP 6145.2, Interscholastic Competition: Updates the District's policy governing interscholastic athletics.
