

**RESOLUTION #922-26**

**WHEREAS**, the Board of Education of Community Consolidated School District 89, DuPage County, Illinois, is authorized to employ educational support personnel and to define their employment duties pursuant to the Illinois School Code;

**WHEREAS**, the Board honorably dismissed some of its educational support personnel at its meeting of March 16, 2026, in order to decrease the number of educational support personnel employed by the Board and discontinue some particular types of educational support services; and

**WHEREAS**, because of staffing needs in the District, it is necessary to recall a staff member honorably dismissed into a position for which they are qualified.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of Community Consolidated School District 89, DuPage County, Illinois, as follows:
