Part 96. Rules Governing Grading and Course Credit

Subpart 1. Definitions

6 CAR § 96-101. Definitions.

As used in this part:

(1) ~~(A) "Additional training plan (ATP)" requires Advanced Placement (AP) and Pre-AP teachers to attend appropriate College Board training.~~

~~_____ (B) Teachers in the plan have up to three (3) years to complete this requirement;~~ "Accelerated learning" means an organized method of learning that enables students in grades kindergarten through grade twelve (12) to meet individual academic goals and graduation requirements while pursuing higher levels of skill development, including without limitation the following coursework:

(A) A College Board pre-Advanced Placement course;

(B) A College Board Advanced Placement course;

(C) An International Baccalaureate Diploma Programme course;

(D) A Cambridge Advanced International Certificate of Education course;

(E) A concurrent credit course; and

(F) A substantively similar course or program approved by the Division of Elementary and Secondary Education;

(2)(A) "Accelerated learning course" means college-level courses offered by an approved institution of higher education that, upon completion, would qualify for academic credit in both the institution and the public high school.

(B) Accelerated learning courses extend beyond those explicitly required to meet state graduation requirements and are identified as weighted courses within the Course Code Management System;

(3)(A) "Accelerated Learning Guide" means the Division of Elementary and Secondary Education guide designated to help districts implement accelerated learning with consistency, transparency, and strong student support.

(B) The Accelerated Learning Guide can be accessed via the Division of Elementary and Secondary Education's website;

~~(2)(A)-(4) "Advanced Placement (AP) course" courses are those courses taught following guidelines as provided for Advanced Placement courses by the College Board.~~
means a college-level course authorized by the College Board to be offered by high schools or course providers that allows students an opportunity to take a standardized examination that may result in postsecondary-level credit;

~~—————(B) Advanced Placement courses provide the opportunity for students to take a national examination through which they may qualify for college/university level credit;~~

~~—————(3) "Advanced Placement" course means a high school preparatory course for a College Board Advanced Placement Exam that:~~

~~—————(A) Incorporates all topics specified by the College Board and the Educational Testing Service on the syllabus for a given subject area; and~~

~~—————(B) Is approved through the College Board and Educational Testing Service;~~

~~(4)(5) "Approved institution of higher education" means an institution of higher education that~~ is approved by the Division of Higher Education to offer a concurrent

~~credit program meets the requirements of the definition under Arkansas Code § 6-85-402; and is either:~~

~~(A) A state-supported two-year or four-year institution of higher education;~~

~~(B) A private, nonprofit two-year or four-year institution of higher education that has its primary headquarters located in Arkansas and is eligible to receive Title IV federal student aid funds; or~~

~~(C) Institutions of higher education approved by the Division of Higher Education as a concurrent credit course provider that are not location in Arkansas;~~

~~(6) "Cambridge Advanced International Certificate of Education course" means a course authorized as a Cambridge International Advanced Subsidiary Level one-year program and Cambridge International Advanced Level two-year course that allows students an opportunity to take a standardized examination that may result in postsecondary-level credit;~~

~~(5)(7) "College Board" means the College Board and Educational Testing Service, a mission-driven which is a not-for-profit nonprofit organization;~~

~~(6)(A)(8)(A) "College Board Advanced Placement Exam" means a standardized exam designed to measure how well a student has mastered the content and skills of a specific AP course.~~

~~(B) A College Board Advanced Placement Exam is administered by the Educational Testing Service on behalf of the College Board;~~

~~(7)(A)(9)(A) "College courses" are courses means a course that are is offered and taught under the direction of an accredited institution of higher education.~~

~~(B) Students may qualify for concurrent credit or dual credit for such courses.~~

~~(C) For a concurrent college course to receive a weighted grade, it must be approved through the process described in this part;~~

~~(10) "Computational thinking" means the cognitive process and problem-solving methodology used to formulate and design solutions in a way that can be executed by a computing system;~~

~~(8)~~(11) "Computer science credit" means one (1) unit of credit earned through the completion of a course or courses approved by the State Board of Education and Division of Elementary and Secondary Education that meets the requirements of Subpart 7 of this part;

(12)(A) "Computer science-related career and technical education course" means a dynamic course of study that equips students with foundational knowledge and in-demand technical skills in computing.

(B) The course should foster computational thinking, problem-solving, and collaboration, preparing students to:

(i) Integrate these concepts into any profession;

(ii) Pursue continued postsecondary education; or

(iii) Enter the technology workforce;

~~(9)~~(13) "Computer science teacher" means an individual who holds an Arkansas teaching license or technical permit that includes a computer science certification, endorsement, approval, or technical permit code that meets the Division of Elementary and Secondary Education's requirement for a computer science teacher;

(14) "Computing" means the study of algorithmic processes and the machinery that executes them;

(15)(A) "Concurrent credit course" means a college-level course offered by an approved institution of higher education that upon completion would qualify for academic credit in both the institution of higher education and a public high school.

(B) Each school district must have on file a current written, signed memorandum of understanding with the institution of higher education it seeks to offer concurrent enrollment;

(16) "Credit by Demonstrated Mastery (CDM)" means the process by which a student may earn credit for a high school course by demonstrating an understanding of the content without course enrollment or without meeting the minimum of one hundred and twenty (120) clock hours as required by the Rules Governing Standards for Accreditation of Arkansas Public Schools and School Districts, 6 CAR pt. 61;

~~—————(10) "Division" means the Division of Elementary and Secondary Education;~~

(17)(A) "Dual enrollment course" means an enrollment program allowing high school students to take college-level courses for college credit at approved institutions of higher education.

(B) High schools may give students course credit upon completion of a dual enrollment course;

~~—————(11) "Elementary school" is a school having any combination of one (1) or more grades from kindergarten through grade six (K-6);~~

~~—————(12)(A) "Endorsed concurrent enrollment course" means a college-level course offered by an institution of higher education in this state, that upon completion would qualify for academic credit in both the institution of higher education and a public high school that:~~

~~—————(i) Is one (1) of the four (4) core areas of:~~

~~—————(b) English;~~

~~—————(c) Science; and~~

~~—————(d) Social studies;~~

~~—————(B) This definition does not affect the ability of school districts to award concurrent credit for those courses that comply with the requirements of Arkansas Code § 6-18-223;~~

(13)(18) "High school" means any Arkansas public school, including an open-enrollment public charter school, that provides instruction to students in grades:

(A) Nine (9);

(B) Ten (10);

(C) Eleven (11); or

(D) Twelve (12);

~~(14)~~(19) "~~Home-schooled~~Home school student" means a student ~~legally enrolled in an Arkansas home school attending school provided by his or her parent, guardian, or person standing in loco parentis pursuant to Arkansas Code § 6-15-503;~~

~~(20)~~(A) "Honors course" means a course offered to accelerate student learning and build a strong academic foundation for more advanced course work.

~~(B)~~ "Honors courses" are courses designated by the Division of Elementary and Secondary Education to provide the following:

~~_____ (19) "Private institution" is defined as an institution of higher education accredited by the:~~

~~(22)(A)(24)~~ "Weighted credit" means additional quality points for designated ~~AP and IB~~ courses that will be contingent upon meeting the requirements set forth in Subpart ~~64~~ of this part.

~~(B) "Weighted credit" also means additional quality points for courses approved by the Division of Elementary and Secondary Education that meet or exceed the standards of a comparable AP course or for approved career and technical education (CTE) courses, as set forth in Subpart 4 of this part; and~~

~~(23) "Weighted Credit and AP Training Approval Committee" means a review committee composed of Division of Elementary and Secondary Education program directors and advisors with AP and content expertise, including but not limited to personnel in the Division of Elementary and Secondary Education's curriculum and gifted and talented offices.~~

Subpart 2. ~~Uniform grading scales~~ Uniform Grading Scales

6 CAR § 96-201. Purpose.

(a) The purpose of this ~~part~~subpart is to establish the uniform grading ~~scales~~scale to be used by all public ~~secondary~~ schools and open-enrollment public charter schools in the state ~~for regular courses~~.

(b) This ~~part~~subpart establishes the numeric value given to each letter grade for the purpose of determining grade average in all public ~~secondary~~ schools and open-enrollment public charter schools in the state for ~~regular all~~ courses except for those courses designated as eligible accelerated learning courses and courses approved for weighted credit.

~~(c) This part provides an optional grading scale for public elementary schools.~~

6 CAR § 96-202. Grading scale and numerical values.

~~(a)(1)(a)~~ The ~~following~~ uniform grading scale ~~is to~~shall be ~~the~~used for the purposes of awarding graduation credit by all public schools and open-enrollment public

charter schools in the state for all courses, except for those courses designated as eligible accelerated learning courses and courses approved for weighted credit.

~~—————(A) Uniform Grading Scale and numeric values for secondary schools; and~~

~~—————(B) Optional Uniform Grading Scale for elementary schools.~~

~~—————(2) Grades earned in courses will be assigned the following numeric values when such courses are used to compute student grade point average.~~

(b)(1) Each letter grade shall be given a numeric value for the purpose of determining grade point average.

(2) This uniform grading scale may be used by all public schools and open-enrollment public charter schools provided the coursework meets the grade level standards.

(3) Except for those courses designated as eligible honors courses approved for weighted credit, the numeric value for each letter grade shall be:

A 90 – 100 = 4 points

B 80 – 89 = 3 points

C 70 – 79 = 2 points

D 60 – 69 = 1 point

F 0 – 59 = 0 points

~~(b)(1)(c)(1)~~ (c)(1) Student grades ~~should~~shall reflect the knowledge and skills of the Arkansas academic standards demonstrated by the student through ~~class assignments, tests, presentations, and projects that reflect the Arkansas academic standards.~~any of the following methods:

(A) Class assignments;

(B) Tests;

(C) Presentations; and

(D) Projects.

(2) The purpose of grading is to communicate how well a student has achieved the learning objectives or criteria for a class.

(c) A public school district may use:

(1) The grading scale in this section in the public school district's or open-enrollment public charter school's elementary schools; or

(2) Standards-based grading.

(d) Methods for recording and reporting competency without the associated coursework may be used as long as the public school district or open-enrollment public charter school has ~~ana~~ Division of Elementary and Secondary Education approved ~~CDM application~~ Credit by Demonstrated Mastery plan, 6 CAR § 96-301.

6 CAR § 96-203. Report cards.

(a)(1) Every public school district or open-enrollment public charter school shall provide a report card for each student reflecting the student's grade or performance in each class in which the student is enrolled.

(2) The report card shall be:

(A) Mailed to the last known address of the student;

(B) Given to a parent, guardian, or person standing in loco parentis at a parent-teacher conference; or

(C) Sent home with the student.

(b) The report card shall be provided at the end of each grading period but no fewer than four (4) times each school year.

(c) Parents, guardians, and persons standing in loco parentis shall not be required to provide postage or self-addressed envelopes to receive a report card.

Subpart 3. ~~Flexibility in awarding high school course credit~~ Competency-Based Credit

6 CAR § 96-301. Awarding Credit by Demonstrated Mastery.

~~—(a) Credit by Demonstrated Mastery is the process by which a student may earn credit for a high school course by demonstrating a deep understanding of the content without:~~

~~_____ (2) The minimum of one hundred twenty (120) clock hours required by the Standards for Accreditation of Arkansas Public Schools and School Districts, 6 CAR pt. 61.~~

~~(b)(1)(a)(1)~~ A public school district or open-enrollment public charter school may submit a Credit by Demonstrated Mastery (CDM) application plan for approval to the Division of Elementary and Secondary Education to award units of high school course credit based on a demonstration of subject matter competency instead of, or in combination with, completing hours of classroom instruction.

(2) Weighted credit is not available for CDM.

(3) The plan shall include a method for recording credit received through CDM on a student's transcript.

~~(e)(b)~~ Students shall demonstrate mastery through a multiphase assessment process, consisting of:

(1) Phase 1: A standard examination assessing course standards; and

(2)(A) Phase 2: At least one (1) artifact that requires the student to apply knowledge and skills relevant to the content standards.

(B) Students who are unable to meet the established minimum score in Phase 1 shall not progress to Phase 2.

~~(d)(c)~~ The CDM process is designed to allow students to:

(1) Demonstrate competency of a required graduation credit; and

(2)(A) Provide the opportunity for the student to take additional courses.

~~_____ (B) The CDM process:~~

~~_____ (i) Is not designed for whole groups of students; and~~

~~_____ (ii) Shall not replace the general accelerated pathways provided for advanced students.~~

~~(e)(d)~~ Each public school district and open-enrollment public charter school ~~district~~ shall form a committee to review submissions of work to determine if the student has demonstrated sufficient competency to meet the standards for credit in the course.

~~(f)~~(e) Upon approval, a public school district or open-enrollment public charter school~~district~~ shall not be in violation of any requirement in the Rules Governing Standards for Accreditation of Arkansas Public Schools and School Districts, 6 CAR pt. 61, that units of credit be awarded for a minimum number of clock hours if the public school district or open-enrollment public charter school~~district~~ awards units of credit based on a demonstration of subject matter competency instead of, or in combination with, completing hours of classroom instruction if the awarding of credit is in compliance with the public school district's division's approved plan.

~~(g)~~(f) The Department of Education and its divisions~~division~~ shall monitor schools offering CDM to ensure compliance with this part.

Subpart 4. ~~Courses for weighted credit~~Weighted Credit

6 CAR § 96-401. General provisions.

(a) ~~The~~Beginning with the 2025-2026 school year, the following weighted scale is to be used for:

- (1) ~~Advanced Placement~~Eligible accelerated learning courses; and
- (2) ~~Courses offered under the International Baccalaureate Diploma Programme; and~~ Other eligible courses approved by the Division of Elementary and Secondary Education for weighted credit.
- ~~(3) Division of Elementary and Secondary Education approved weighted courses.~~

(b) The division shall consider the following criteria in implementing the weighted scale:

(1) Standards;

(2) A numeric value for the purpose of determining grade point averages; and

(3) Weight given to the numeric value as provided in 6 CAR § 96-202(b)(3).

(c) Beginning with the 2027-2028 school year for the anticipated 2031 graduating class (2027-2028 freshman class) and all subsequent graduating classes, the following weighted 6.0 credit scale shall be implemented in accordance with the division's guidance found in the Accelerated Learning Guide:

A 90 – 100 = 6 points

B 80 – 89 = 5 points

C 70 – 79 = 4 points

D 60 – 69 = 2 points

F 0 – 59 = 0 points

~~(b)(d) Courses~~Additional courses approved by the ~~Division of Elementary and Secondary Education~~division for weighted credit ~~must~~shall:

(1) Meet or exceed the standards of a comparable ~~Advanced Placement class~~eligible accelerated learning course; ~~or~~

(e)(1) Public school districts and open-enrollment public charter schools may refer to the division's Accelerated Learning Guide for additional guidance pertaining to weighted credit.

(2) The division's Accelerated Learning Guide shall be posted on the division's website.

~~(a) A local school district board of directors may adopt a policy to allow high school students in the public school district to take~~The Division of Elementary and Secondary Education in collaboration with the Division of Career and Technical Education may approve a career and technical course within an approved career and technical pathway for weighted credit if the course:

~~(1) College courses for weighted credit equal to the numeric grade awarded in Advanced Placement courses~~Exceeds the academic standards for a nonweighted course in a pathway; and

~~(2) Courses offered under the International Baccalaureate Diploma Programme; and~~Leads to an approved industry-recognized certification or concurrent credit.

~~(b) If a local school board adopts such a policy, the district shall apply to the Division of Elementary and Secondary Education's Weighted Credit and AP Training Approval Committee for approval of concurrent enrollment college courses to be designated as a weighted course, under Subpart 5 of this part.~~The Division of Career and Technical Education shall:

(1) Review new and existing career and technical pathways to determine which courses within the career and technical pathways meet criteria for weighted credit; and

(2) Publish a list of approved career and technical pathways annually by January 1.

~~(c) An application shall be reviewed for approval to assign a numeric grade value, that may include weighted credit, based on the following Criteria used to determine what courses within a career and technical pathway shall receive weighted credit shall include without limitation the consideration of career and technical pathways that:~~

Subpart 5. ~~Concurrent credit~~Concurrent Credit

6 CAR § 96-501. Enrollment guidelines ~~for students enrolled in grades 9-12.~~

(a)(1) Any eligible student who is enrolled in ~~grades nine (9) through twelve (12)~~ in an Arkansas public school district or open-enrollment public charter school shall be ~~eligible to~~ may enroll in ~~a publicly supported community college, technical college, four-year college or university, or private~~ an approved institution of higher education in accordance with the ~~rules adopted by the college or university~~ enrollment policies of the institution and the Division of Higher Education. –

(2)(A) ~~If an Arkansas public college or university or private institution of higher education requires a college course placement score greater than a score of nineteen (19) on the ACT, a comparable score on the SAT, or an equivalent measure, the public school~~ A student ~~must~~ shall meet that institution's concurrent admissions and course placement requirements.

(B) ~~Districts should consider the ACT benchmark readiness scores in addition to the minimum requirement for proper identification and~~ Institutions may use a variety of factors and measures beyond a standardized test score when determining proper placement of students in college coursework.

(C) Procedures and standards for placement are outlined in the Arkansas Higher Education Coordinating Board Student Placement into General Education Credit Course Policy, 6 CAR pt. 365 and the Concurrent Enrollment Policy located on the Division of Higher Education's website.

(1) Be of high quality;

(2) Meet or exceed the curriculum/academic standards and requirements established by the State Board of Education; and

(3) Be made available in a traditional classroom setting, a blended learning environment, or an online-based or other technology-based format that is tailored to meet the needs of each participating student.

(c) The Division of Elementary and Secondary Education shall designate the computer science and computer science-related career and technical education courses

that may be completed in grades eight through twelve (8-12) for computer science credit.

(d)(1) A course shall be approved as a computer science or computer science-related career and technical education course that meets the graduation requirements if its core learning objectives and student work require the creation of computational artifacts.

(2) The course content shall require students to consistently design, develop, analyze, and debug their own algorithms, programs, or scripts to solve problems, automate processes, or analyze data.

(3) Courses may focus on a variety of modern domains including, but not limited to:

(A) Software development;

(B) Cybersecurity;

(C) Data science;

(D) Artificial intelligence; and

(E) Physical computing (e.g., robotics).

(4) A public school may request approval for a course not designated by the division through the course approval process established by the division.

(5) Interdisciplinary courses, such as those in precision agriculture or computational science, that meet the core requirement in this section may be approved.

(d) A course shall not be approved under this section if its primary focus is:

(1) The use of preexisting software applications for the intended use without also requiring students to create original programs and scripts;

(2) Computer-aided drafting that does not include a substantial component of student-created scripting or programming;

(3) The assembly, maintenance, or repair of computer hardware; or

(4) Digital literacy, digital citizenship, or keyboard skills.
