**3.A. High Quality Materials**

What are Instructional Materials? What is the Instructional Materials Review and Approval (IMRA) Process? The TEA IMRA rubric. He reviewed the district’s process

for accessing / attaining high quality instructional materials. He reviewed the critical deadlines and requirements. Also reviewed was the funding for the instructional materials.

### **3.C. Athletic Update**
