Dear Dr. Green,

Throughout March, April, and May 2026, formal bids were received for BP 48 University K-12 Addition and Renovation. The project scope includes a new gymnasium, cafeteria, natatorium, classroom and administrative spaces as well as rework of existing campus parking, drives, and athletic fields. Renovations to the existing auditorium and associated fine arts classrooms are included as well.

Alternates 1, 5, 9, 10, 11, 12, 14, 17, 20, and 25 were accepted and incorporated into the project and are identified in the bid tabulation.

The attached bid tabulation lists all the bid proposals received. After a review of all bid proposals, post bid reviews were conducted to verify the proposals were inclusive of the scope of work and schedule. The collective Bond Team (Barton Malow Builders, Plante Moran Realpoint, Fanning Howey Associates Inc. and Southfield Public Schools) has reviewed the proposals and is prepared to recommend the following actions concerning the award of contracts:

The total contractor award amount for Bid Package BP 48 University K-12 Additions & Renovations is \$85,232,315.04.

The contingency amount for Bid Package BP 48 University K-12 Additions & Renovations is 10% of project total value. Total contingency amount is \$8,523,231.50, bringing the construction total to \$93,755,546.54.

This project will be funded by Bond Funds.
