Memo: FY 27 Budget Memorandum – Establish Budget Hearing

In accordance with 35 ILCS 200/18-50, 105 ILCS 5/2-3.27 et seq, 105 ISCS 5/17-1, 105 ILCS 5/17-1.2. and Dixon Public Schools #170 Board Policy #2:20 *Powers and Duties of the School Board* and #4:10 *Fiscal and Business Management*, the Board of Education is required to approve the FY 27 budget by September 30, 2026. Under the law, the Board is required to establish a budget hearing date, hold a required public hearing and offer opportunity for public comment, and authorizes the Board to amend the budget through the same process at a later time.

The budget serves as a financial plan which is designed to accomplish the District's goals as well as providing required financial and programmatic information for state, local and federal governmental bodies. Approval of the budget provides the district with the ability to expend funds and gives the district taxing authority. On August 19, 2026, the Board is asked to establish a public budget hearing for 6:00 p.m. on September 23, 2026, preceding the regularly scheduled meeting of the Board.

Please note the following in accordance with 35 ILCS 200/18-50, 105 ILCS 5/2-3.27 et seq, 105 ISCS 5/17-1, 105 ILCS 5/17-1.2.

- The Proposed Budget for FY27 will be placed on display in the unit office of DPS #170 on August 20, 2026. This is the date following the Board of Education meeting in which the proposed budget has been presented to the Board of Education and a public hearing was established.
- The proposed budget will be on display for more than 30 days from August 20, 2026 to September 23, 2026.
- A public notice of the hearing and the display of the budget will be placed in the local newspaper, which is attached to this memorandum.
- At the required Budget Hearing an opportunity for public comment will be offered. At the conclusion of the public hearing the Board of Education will enter into the regularly scheduled Board of Education meeting. During this meeting the Board of Education will be asked to take official action on the approval of the FY27 budget.

Recommendation:

- It is the recommendation of District Administration that the Board of Education of Dixon Public Schools #170 establish a Public Hearing for September 23, 2026 at 6:00 p.m., preceding the regularly scheduled meeting of the Board of Education.

Dixon Public Schools, in cooperation with the community, will provide students with a comprehensive educational program that produces well-educated, self-sufficient, and involved citizens.
