RECOMMENDATION:

Administration is recommending the proposed boundary changes effective the 2023-24 school year. These boundary changes are necessary to balance enrollment at these impacted schools. Meetings were held with parents of students affected by these boundary changes.

Bonnie Garcia

The boundary for B. Garcia Elementary School starts at the intersection of St Hwy 359 and Cuatro Vientos Rd. South along Cuatro Vientos Rd to Wormser Rd. East and north along Wormser Rd to include Wright Ranch, Lago del Valle and Concord Hills to St Hwy 359. West on St Hwy 359 to the point of beginning.

Killam

The boundary for Killam Elementary School starts at the intersection of E Saunders St (Hwy 59) and Casa Blanca Lake Rd. East along Saunders St to Al Barrera Dr. South along Al Barrera Dr to include Towne East Subdivision and Ponderosa Subdivision to Clark Blvd. East on Clark Blvd to Loop 20. South on Loop 20 to St Hwy 359 (excluding the Dorel Apts). West along St Hwy 359 to S Ejido Ave. North along Ejido Ave to Saunders St (excluding New Heights Subdivision) and east to the point of beginning.

Salinas

The boundary for Salinas Elementary School begins at the intersection of S. Ejido Ave and Pine St. East along Pine St to Ave Los Presidentes (including only students living south of Ave Los Presidentes) to Cuatro Vientos Rd. South along Cuatro Vientos Rd to Lomas del Sur Blvd. West on Lomas del Sur Blvd to S Ejido Ave. North on Ejido Ave to the point of beginning.

Ruiz

The boundary for Ruiz Elementary School begins at the intersection of St Hwy 359 and Ejido Ave. South along Ejido Ave to Pine St. East along Pine St to Ave Los Presidentes. South and east along Ave Los Presidentes (including only students living north of Ave Los Presidentes) to Cuatro Vientos Rd. North along Cuatro Vientos Rd to Hwy 359 and west to the point of beginning.

United South Middle

The boundary for United South Middle School begins at the intersection of S. Ejido Ave and ST Hwy 359. East along Hwy 359 to Cuatro Vientos Rd. South along Cuatro Vientos Rd to Wormser Rd. West along Wormser Rd to S. Ejido Ave and north to the point of beginning.

Antonio Gonzalez Middle

The boundary for A. Gonzalez Middle School begins west of the property line of Del Phina Rd and Hwy 359. West along Hwy 359 to Ejido Ave. North along Ejido Ave to E. Ash St. East on Ash St to area east Eucalyptus Ave. North along Eucalyptus Ave to US Hwy 59. East along Hwy 59 (including all Ranchitos) to the UISD boundary including only students residing south of Hwy 59. South along the UISD boundary to a point parallel to Clark Blvd. West along Clark Blvd to the area west of Del Phina Rd and south to the point of beginning.
