Description: SchooLinks serves as an online platform providing high school students with resources for college applications, college recommendation letters, college cost analysis, and a scholarship center featuring a financial aid calculator. Furthermore, the platform offers opportunities for career exploration, internships, and career matching.

Additionally, SchooLinks equips school counselors with a dashboard to monitor student data, including personal graduation plans and future scheduling, while tracking college, career, and military readiness.
