Topic: Approval of CSP 055-2015 Construction of Main Security Stations at Various UISD Campuses Phase I

Recommendation:

The Administration recommends awarding CSP 055-2015, Construction of Main Security Stations at Various UISD Campuses Phase I, to the best and lowest proposer, Vision Construction Co., Inc., in the amount of \$300,945.04. The proposal includes a base proposal in the amount of \$256,995.04, a contingency allowance amount of \$35,000.00 and Alternate No. 2 in the amount of \$8,950.00. Staff has complied with all applicable federal, state and local purchasing policies and procedures in obtaining pricing information for the items listed above. Staff is recommending the awards based on being the best value to the district.

Rationale:

The main objective of these building enhancements is to provide a safer and more secure campus environment for our students and staff. The first phase of this district-wide project entails the construction of a security station at the main entrance of seven elementary schools:

- 1) Bonnie Garcia Elementary School
- 2) Borchers Elementary School
- 3) Centeno Elementary School
- 4) Col. Santos Benavides Elementary School
- 5) Fasken Elementary School
- 6) Killam Elementary School
- 7) Malakoff Elementary School

These stations will provide a designated central location for campus peace officers or security guards at the schools' main entrances, to ensure a restricted and secure access and main campus entrance control and to better monitor all security surveillance cameras throughout the campuses.

Budgetary Information:

This project is part of PHASE II of the 2013 Bond Construction Program, to be funded through the Funding Plan of Phase II Series 2015 Bonds. Budget Amount for Construction of Main Security Stations at Various UISD Campuses Phase I (Seven Campuses): \$274,522.00 for seven elementary schools.
