- ECISD will monitor the Project and share resulting reports (including data on the Metrics) with Chevron on an annual basis. Further, ECISD and Chevron will collaborate on site visits and in evaluating the Project (while respecting ECISD’s role as the manager of the Project).
- Chevron and ECISD will coordinate directly on strategic issues, as well as the development and communication of key messages. Neither entity may use the logo or name of the other party in communication materials without prior written consent.
- If the Project needs to be modified in a significant manner, ECISD will notify Chevron of the needed change and ECISD and Chevron will discuss the alternatives available and determine an appropriate mutually agreeable modification.
