

FACILITY USE AGREEMENT BETWEEN SHAWNEE PUBLIC SCHOOLS AND SHAWNEE FAMILY YMCA

This agreement is made on the 4th day of May, 2021 by and between **Shawnee Family YMCA**, hereafter referred to as "**YMCA**" and the **Shawnee Independent School District I-93**, hereafter referred to as "**Shawnee Schools**".

1. The **YMCA** agrees to provide space in the swimming pool and locker rooms for use by **Shawnee High School** Swim Team. The purpose of facility use will be for swim team practice.
2. Team practice will be approximately two (2) hours per day each Monday through Friday. The swim team coach will be responsible for signing in each day the team is present at the **YMCA**.
3. **Shawnee Schools** is responsible for ensuring that adequate liability insurance is purchased and maintained for operation of the swim team. Furthermore, **Shawnee Schools** shall include the **YMCA** as additional insured. **Shawnee Schools** shall fully indemnify the **YMCA**, its staff and volunteers from all claims, damages, losses, actions, cost and judgements arising out of the use of the **YMCA** facilities.
4. It is the responsibility of **Shawnee Schools** to provide personnel to properly supervise the swim team. said personnel shall be responsible for ensuring that all swim team students follow all policies/procedures set forth by the **YMCA**. The **YMCA** will also provide a certified lifeguard during practice times.
5. All equipment owned by the **YMCA** and used by **Shawnee Schools** shall be returned to the proper storage area the end of each day. Equipment owned and operated by **Shawnee Schools** may be stored in the proper storage located in the **YMCA** facility.
6. **Shawnee Schools** agrees to provide facility space for use by the **YMCA** to conduct little league activities including but not limited to basketball practice (Union St Gym), basketball games (Union St Gym), basketball tournaments (MS Gym, PAAC), indoor soccer practices (Union St Gym), Track practices and track meet (SHS Track).
7. **YMCA** practices will be scheduled through the **Shawnee Schools** Athletic Director or Assistant Director.
8. The **YMCA** is responsible for ensuring that adequate liability insurance is purchased and maintained for the operation of youth league practices and games. The **YMCA** shall fully indemnify **Shawnee Schools**, its staff and volunteers from all claims, damages, losses, actions, cost and judgements arising out of the use of **Shawnee Schools** facilities.
9. It is the responsibility of the **YMCA** to provide personnel to properly supervise the youth league practices and games. Said personnel shall be responsible for ensuring that all players and coaches follow all policies and procedures set forth by **Shawnee Schools**.
10. The term of this agreement will be for the 2021-2022 school year.
