##### III.1. District Conversion Charter Applications

- III.1.a. Pulaski County Special School District DRIVEN  
School of Opportunity**

Pulaski County Special School District staff Rachel Blackwell, Nina Holub, Todd Esota, and Dr. Justin Lutrell appeared before the panel, delivered a presentation about the proposed charter, and answered panel member questions.

It was moved by Dr. Tina Moore, and seconded Dr. Crystal Beshears-Duncan to approve the application for charter. The motion passed 4-0.

**III.1.b. Little Rock School District Hall High**

Little Rock School District staff Dr. Jermall Wright, Dr. Shay Loring, and Carlton McGee appeared before the panel, delivered a presentation about the proposed charter, and answered panel member questions.

It was moved by Dr. Crystal Beshears-Duncan and seconded by Ms. Toyce Newton to approve the application for charter. Dr. Beshears-Duncan then moved to rescind the motion, and Dr. Tina Moore seconded the motion. The motion passed unanimously.

Additional discussion on the application followed.

The chair deferred the decision on the application until January.
