The canvass shall take place on Tuesday, May 16, 2023, beginning at 12:00pm., in the Board Conference Room of the Comal Independent School District Support Services building, 1404 IH 35 North, New Braunfels, Texas. In accordance with Section 67.004, Texas Election Code, two (2) members of the Board of Trustees shall constitute a quorum for purposes of canvassing the election.**

Previous board action relating to this item: On March 30, 2023, the Board declared unopposed candidate Jason York elected from Single-Member District 3 in accordance with Section 2.053 of the Texas Election Code.

Future action anticipated: Annually

Background information: The results of the May 6, 2023, Trustee Election in Single-Member District 4 will be presented at the meeting. The Board of Trustees must canvass the election, approve the election returns, and declare the results. The Comal County Clerk administered the election and provided the data. Under Election Code § 67.004, only two members of the Board of Trustees will constitute a quorum for purposes of conducting the canvass. No other District business is permitted by the Board at this meeting unless there is a full quorum (4 members) present and other business has been properly posted on the meeting notice.

Due to no opposition to candidate Jason York in Single-Member District 3, the trustee election in that SMD was canceled as required by law and Mr. York was declared elected to office on March 30, 2023.
