Subject: Fence Project – Safe Routes to School Grant

Recommendation:

The Superintendent recommends the Board of Education approve a motion to not install a fence along the west side of the secondary athletic complex.

Statement of Purpose/Issue:

The fence project is one of several included in the Safe Routes to School Grant.

Budget Impact:

The cost of installation of the fence is covered by the Safe Routes to School Grant.

Historical Perspective:

The installation of a fence along the west side of the secondary athletic complex is one of the projects approved in the Safe Routes to School Grant. The purpose of the fence is to prevent unauthorized access to district property. Facilities & Policy Advisory Committee members met with the neighbors who are impacted by the fence. Following that meeting, the committee recommended that the Board schedule a special meeting regarding the installation of the fence. The committee does not recommend installation of the fence. The special meeting will allow for discussion prior to a decision by the full Board whether to proceed with the installation.

Discussion of Options:

The Board may chose to either continue with installation of the fence or remove it from the list of projects approved under the Safe Routes to School Grant.

Rationale for Proposal:

After a lengthy discussion with citizens whose property would be impacted by the fence, the advisory committee saw the value of the fence, however, it felt the fence installation should not be a priority at this time.

Safe Routes to School Grant Projects

1. Resurfacing of Winans walking track and teaching station
2. Pedometers, bicycle racks, locks and pamphlets – COMPLETED
3. Add connectors making walkable community
4. Flashing stop signs, cones and jackets for crossing guards – COMPLETED
5. Refuge island on Snow Road
6. Add sidewalk to east side of Snow Road
7. Add fencing along Winans border
8. Add sidewalk on east side of Chanticleer Trail – EATON COUNTY ROAD COMMISSION DID NOT SUPPORT THIS COMPONENT
