**RESOLUTION AUTHORIZING NOTICE TO BAR INDIVIDUAL FROM SCHOOL
DISTRICT PROPERTY**

WHEREAS, the Board of Education of Collinsville Community Unit School District No. 10, Counties of St. Clair and Madison, Illinois, has the responsibility to manage and operate the schools of said District; and

WHEREAS, the Board of Education has the power to exclude persons from district property for a period not to exceed one year pursuant to Section 5/24-24 of The School Code; and

WHEREAS, the Board of Education has received information, reports, and recommendations from its administrative staff regarding the conduct of Kenneth Averett which indicate that his conduct toward and in the presence of district employees, parents and students has been violent, threatening and intimidating; and

WHEREAS, in an open session hearing before the Board of Education on Wednesday, October 30, 2013, the Board of Education offered Averett an opportunity to respond to the allegations that he engaged in violent and threatening conduct towards district employees, parents and students; and

WHEREAS, the Board of Education has determined that sufficient reasons and causes exist to bar Averett from district property for a period of one year and that such reasons and causes have a detrimental effect on students and school district employees; and

WHEREAS, the Board of Education hereby finds and determines that, based on its Finding of Fact, the best interests of the school district requires the immediate exclusion of Averett from all school district property for a period of one year based upon the charges set forth in the Notice of Charges and Hearing dated October 16, 2013;

NOW, THEREFORE, Be It Resolved by the Board of Education of Collinsville Community Unit School District No. 10, Counties of St. Clair and Madison, Illinois, as follows:

Section 1: That Kenneth Averett be barred from all school district property for a period of one year and that he be issued a Notice of Bar substantially in the form of, and for the causes and reasons set forth in the Exhibit, attached hereto and made a part hereof.

Section 2: That the President and Secretary of the Board of Education are hereby authorized and directed to send said Notice of Bar to Kenneth Averett by regular and certified mail, return receipt requested.

Section 3: That the Superintendent or his designee shall also deliver a copy of said Notice of Bar to the local law enforcement authorities.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage.

NOTICE OF BAR

Dear Mr. Averett:

You are hereby notified that at a special meeting of the Board of Education of Collinsville Community Unit School District No. 10, Counties of St. Clair and Madison, State of Illinois, held on October 30, 2013, a resolution was duly adopted by a majority of the Board of Education to bar you from entering onto all Collinsville Community Unit School District No. 10 property for a period of one year from the date of this letter. This bar letter applies to all school district property and any location used for any school district business, including but not limited to Kreitner Elementary School, 9000 College Street, Collinsville, Illinois 62234, and any location in which home athletic and/or extracurricular events are conducted.

This bar letter is being imposed because it was determined that you engaged in the following violent and threatening conduct:

1. Multiple teachers reported seeing you walk down the sidewalk near Kreitner Elementary School and past multiple classroom windows shouting in an aggressive and violent manner "Mother Fucker, I'm going to get you Fucker" to a person at the east end of the school parking lot.
2. Before reaching the east end of the school parking lot, you turned south and walked down to the entrance road of Kreitner Elementary School, continued to shout and use profanity in an aggressive and threatening manner, and took off your shirt.
3. As a result of your conduct, Police Office Eric Danford was required to come on to campus to ensure the security and safety of students and staff during dismissal. It was determined that you are the former boyfriend of a current parent.
4. This is your second offense for using aggressive and threatening behavior on the campus of Kreitner Elementary School. This is also your second offense using threatening and aggressive profanity around students, teachers, and parents.

If you enter upon Collinsville School District property in violation of this directive, we will immediately contact law enforcement officials to remove you and we will file criminal trespass charges against you.
