The purpose of this email is to request your participation on the Compensation Analysis Steering Committee. Our first meeting is tentatively scheduled for Tuesday, October 22 at 4:15 pm in the Central Office Conference Room. ### BACKGROUND:

In August, the Board of Education directed the administrative team to complete a formal compensation analysis project. As is outlined below, the purpose of this project is to collect, analyze, and interpret employee compensation data. Based on the data collected and district priorities, recommendations for compensation model adjustments may be given to the Board of Education for consideration.

The focus for the 2019-20 school year will be Certified Staff (i.e. Teachers) and Special Education paraprofessionals. Other support staff will be analyzed in subsequent years. At this time, the Board of Education has decided not to hire a third-party consultant to support the collection and interpretation of the data.

### COMPENSATION ANALYSIS STEERING COMMITTEE

To promote stakeholder engagement throughout the compensation analysis project, a steering committee is being formed. While not actively involved in the data collection, the committee will guide this process by recommending comparable districts and data sources. Once the data is collected, the steering committee will participate in the interpretation of the data.

### STEERING COMMITTEE

The committee will be made up of a diverse groups of stakeholders. We intentionally varied the makeup to include representatives from all buildings, employee types, and levels of experience at RFSD.

### 2019-20 PROJECT GOALS

1. Collect accurate compensation data for certified staff and special education paraprofessionals at River Falls School District and mutually agreed upon comparable districts.
2. Review and classify certified staff and special education paraprofessional positions.
3. Develop a consistent process for interpreting compensation data.
4. Based on data collected and district priorities, recommend compensation model adjustments to the Board of Education.
5. Support the communication of compensation analysis project to all employees.

### PROJECT TIMELINE

September, 2019	Form ad-hoc Compensation Steering Committee—all stakeholders represented.
October, 2019	Initial meeting to review committee goals, guide the data collection components, and determine the compensation data points to be collected.
Nov-Dec, 2020	Human Resources Department collects data and provides Steering Committee Members with monthly progress updates.
January, 2020	Human Resources Department completes data collection. Steering Committee meets to review data.
March, 2020	Compensation data will guide 2020-21 Wage Offers (within current compensation models)
June, 2020	Based on data collected and district priorities, recommend compensation model adjustments to the Board of Education (may require several meetings in April, May, and June.)
July, 2020	Seek Board of Education approval for recommended adjustments to compensation models.
August, 2020	Develop communication plan
January, 2021	Complete employee group listening sessions and individual employee meetings
May, 2021	Use revised compensation model to set 2021-2022 wage offers
