### Board of Education Report



The school year is off to a great start, the students and staff have done a wonderful job of transitioning back from summer. We are really starting to hit our stride in our classes and with our activities. Our doors are always open if you would like to stop by and visit or just say hello.

#### **1. MAP (Measure of Academic Progress) Testing:**

The past few weeks we have been MAP testing our 9th-12th grade students in the area of Math, Language Arts, Reading, and Science. Each year print those reports out and staff will use that data to help better guide our classroom instruction in those areas. Those reports are also printed and shared with our parents during our upcoming Parent/Teacher Conferences, which will be held on September 15th and 16th.

#### **2. Parent/Teacher Conferences-September 15th and 16th:**

Parent Teacher Conferences will be held at the high school on Wednesday, September 15th from 3 to 6 p.m. and Thursday, September 16th from 3 to 8 p.m. The high school will hold our conferences in the Commons Area. Families may request individual Zoom Conferences with teachers as needed.

#### **3. Art Club:**

The Art Club will have their first scheduled meeting on September 21st. We will elect officers and schedule events for the year. We will also design this year's Art Club shirt. This year we plan to spend the first semester creating ornaments and crafts to sell in December for a fundraiser. We will also be organizing our second semester Art Club trip to a local museum.

#### **4. Special Education Department attends Transition Workshop:**

On Wednesday, September 1st, Becky Mousel, Julie Ratka, Michelle ten Bensel, and Taylor Turecek attended a transition workshop at ESU #11. New regulations within the law have required a complete overhaul of how we write IEP's and provide services for transition students. LB 527 requires students with a developmental disability to have transition services in place at the age of 14. The Nebraska Department of Education has provided additional guidance that states all students with a disability who are 14 years of age shall receive these transition services. The Transition-Focused IEP training provided direction as well as examples of how to write these IEP's and provide services for all of our transition-aged students with disabilities. We are diligently working to ensure the daunting task of updating our IEP's by the deadline of November 26th is met.

#### **5. Industrial Tech Department:**

After a year's hiatus, the Tech Club had its annual Football Kick-off bar-b-que at the first home game, a big win against Fairbury. This event is a major fundraiser for the club. This year the setup changed, using the new concessions stand as a serving area. The weather was warm, but the turnout was fantastic! Smoked brisket, pork loin, brats, and hotdogs were served, along with "Carl's beans", a favorite of everyone. The kids also helped sell "white out" shirts provided by the football team.

We will now begin planning for the tech club trip, which was also cancelled last year. We will be trying to go to Denver, to tour the three professional sporting venues; Mile High Stadium, Pepsi Center, and Coors Field. Scheduling all three is always a challenge. Hopefully we will be taking the trip between football and basketball seasons.

#### **6. Staff Work Day at Pioneer Village-September 24th**

Over the last few months there has been a buzz around Minden about the newly developed Pioneer Village Revitalization Project. On September 24th at 2:30 p.m. the Minden Public Schools staff will be doing our part to help bring back the shine to our beloved Pioneer Village. **ACTIVITY DIRECTOR REPORT**

As we head into September all sports have multiple competitions under their belt. I encourage athletes, coaches, students, parents and patrons to demonstrate good sportsmanship at our home and away games this year by announcing sportsmanship reminders at the beginning of contests and encouraging everyone to support our athletes, coaches and officials in a positive manner. Our first softball, volleyball, and football home contests were fantastic. We had a great number of fans and the support was a difference maker for the overall experience of all students involved.

The varsity football team won their first game against Fairbury and really played well. They played Boone Central on the road and played well but lost a close game. Our next home game is Friday, Sept. 10th vs. Adams Central. The high school team has 44 players. The jv team defeated Cozad for their season opener and lost a close game to St. Paul last night but it looked like all players were enjoying their opportunity to compete. **Measures of Academic Progress (MAP)-**

MAP, or the Measure of Academic Progress, is a computerized adaptive test which helps teachers, parents, and administrators improve learning for all students and make informed decisions to promote a child's academic growth. The data from these MAP tests will help us plan differentiated instruction and interventions for students. Students will complete fall 2021 testing on Friday, September 10, 2021. Once testing is complete the staff and I will evaluate each student's progress and share additional cohort data in the next board report.

**Parent- Teacher Conferences-**

Parent- teacher conferences will be held at C.L. Jones Middle School on September 15 3:00-6:00pm and September 16 3:00-8:00pm. Conferences for students in 4-5th grade will be held in the homeroom teacher's classroom and scheduled for specific days/ times. Conferences for students in 6-8th grade will be held in the CLJMS main gym. If parents/ families are unable to attend conferences in-person, please email Mrs. Jensen at [chelsey.jensen@mindenwhippets.org](mailto:chelsey.jensen@mindenwhippets.org) for alternative conference options.

Each student's Measures of Academic Progress (MAP) growth information will be sent home on September 13, 2021. If you have questions about the MAP report, please bring it to conferences to discuss with your child's teacher(s).

**Minden Public Preschool:** The Public Preschool has had a fantastic start to the school year. Total enrollment in the preschool is currently at 32 students. The new space at East Elementary has allowed for increased daily collaboration and support between staff members in order to efficiently and effectively serve students. It has also broadened the opportunities the students are able to take part in. For example, students now take part in P.E. with Mr. McCarthy twice a week increasing their physical activity, strengthening their large motor skills, and having yet another positive role model/teacher in their lives.

**MAP testing:** The Measurement of Academic Progress was completed by students in grades kindergarten through third in the areas of math, language usage, and reading. These results are used to guide instruction, measure academic effectiveness, and to monitor the progress of each student. This assessment also meets the screening requirements set under the Nebraska Reading Improvement Act. When students do not score at the threshold number for this assessment, a plan is developed to help support this student. An amazing statistic that proves the effectiveness of the instruction at East is that 97% of students met the state's threshold.

Other information worth highlighting include:

58% of first graders scored above the 75th percentile in math

77% of kindergarten students scored above the 50th percentile in reading

**Computer Science:** Mrs. Widdifield will be teaching a computer science class to kindergarten through third grade students once a week this school year. She'll be teaching a variety of skills to students. For example, kindergarten students will start with the basics of just how to use a mouse and drag and drop all the way up to third graders learning how to code using algorithms and sequences.
