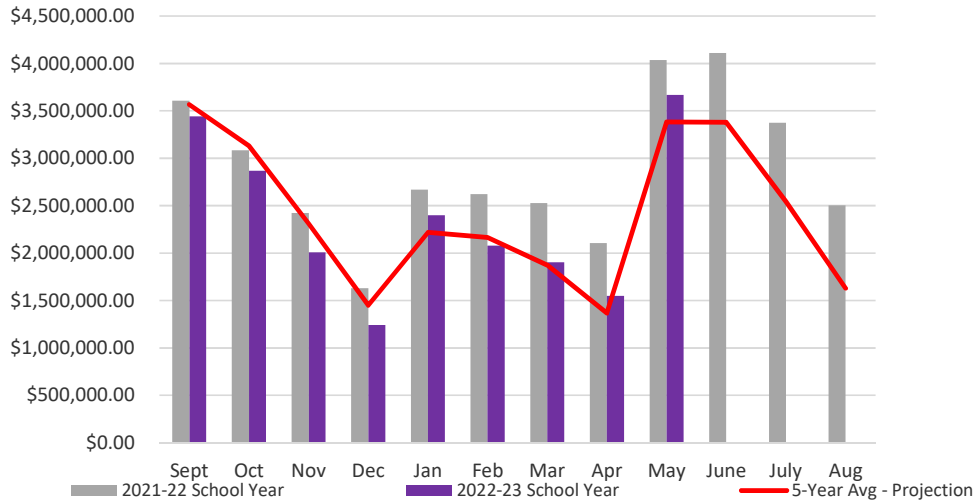

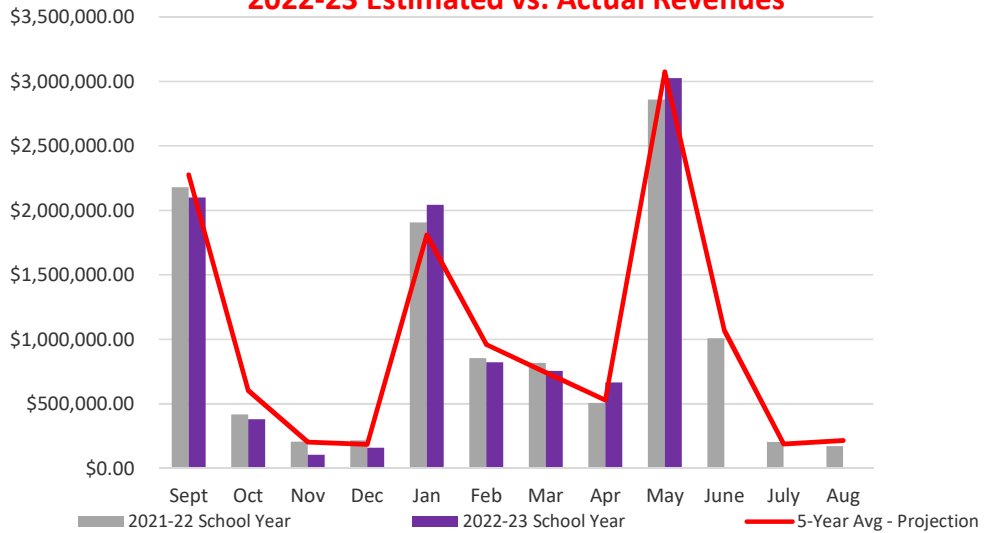

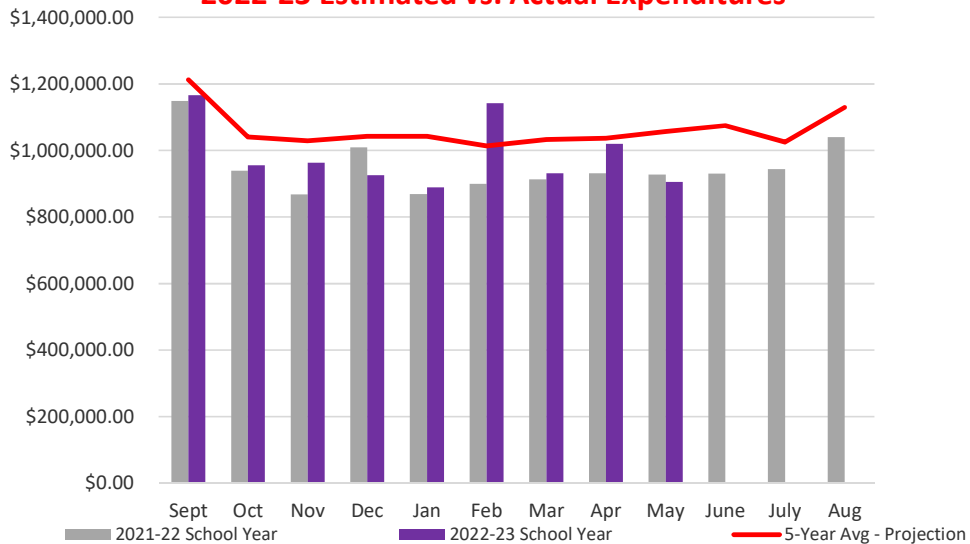
2022-23 Estimated vs. Actual General Fund Balance

Do you want to know more about 7th & 8th Grade Math options?

7th grade math courses

Math7- A traditional middle school mathematics course at the 7th grade level.

Pre-Algebra7- Upper level math course, meant to challenge students that exceed seventh grade norms in mathematics. This course is aligned with the Pre-Algebra course offered at the high school level.

8th grade math courses

Math8- A traditional middle school mathematics course at the 8th grade level.

Pre-Algebra 8- An upper level math course, aligned with the Pre-Algebra course offered at the high school level, meant to challenge students that exceed eighth grade norms in mathematics.

Algebra8- Upper level math course, aligned with the Algebra course offered at the high school level. This course is meant to challenge students that exceed eighth grade norms in mathematics and will require ample practice time outside of class.

Students will not earn high school credits for completing upper level courses while in middle school. However, taking these courses while in middle school gives students the opportunity to take higher level math courses while in high school.

How is placement determined?

Mathematics rubrics are used to determine student placement into upper level mathematics courses. These rubrics focus on three main areas-

- 1) Previous School Year's Mathematics Course Final Semester Average
- 2) Previous School Year's Mathematics Course Study Skills
- 3) Spring MAP Math Scores

The middle school math instructors and Mrs. Jensen meet to analyze individual student assessment results by identifying strengths/ weaknesses in each of these areas. Scoring in each area on the mathematics rubric determines each student's recommended math course option for the next school year.

SUMMER CAMPS UPDATE:

On May 31st, the volleyball team had 35 girls from grades 7 to 12 attend a setter/libero camp hosted by Ed Rowse, Jensen Rowse, Ali Lovin, and myself. It was a great day! There are also 85 girls signed up for the youth volleyball camp scheduled for June 20th through the 22nd!

Kierra Antillon, Jainalynn Sharkey, and Brooke Carr took part in the Masonic All Star Marching Band which runs in conjunction with the Shrine Bowl. Students selected get to stay at UNK and attend the camp for free. They spend 4 days rehearsing the music and their marching skills to prepare for 3 performances. They have a public performance Friday night, perform in a parade Saturday morning, and perform pep band songs and a halftime show during the Shrine Bowl game. Over 70 schools were represented with around 160 members in the band.

Football camp was also held for all youth future Whippet football players. The coaches and high school players worked with the kids to teach them fundamentals of football and have a great deal of fun. There were 70 kids who attended the youth football camp!

Basketball camp included 60 girls grades 2-8 this year. Grades 2-5 attended from 1:00-2:00 and grades 6-8 from 2:00-3:30. I have been busy finalizing schedules for all of our activities for the 2023/2024 school year. Finalizing the contracts and lining up officials for all of our home contests is a focus area for me right now. Many of those items are complete with some holes to fill in certain activities. Our coaching staff is mostly complete for next year as well with one remaining spot to fill for the high school track/field staff.

The following is a “**year in review**” of the 2022-2023 school year with important “**did you know?**” added to each month.

August

The first day of school was August 11th. Prior to students attending, teachers welcomed students and families into our building to meet the staff and make themselves at home. Did you know this is the second year that our **Preschool** has been under the roof of East Elementary? We are required to have 35 square feet per child and one adult per 10 children. Students qualifying for special education attend for free, families who qualify for free/reduced lunch attend on a sliding scale, and other families pay \$120 per month. On Fridays, our early childhood special education teacher and speech/language pathologist serve children younger than three years old who qualify for services in their homes.

September

September brought Parent/Teacher conference collaboration time. Nearly 100% of families attend our conferences. Did you know that our school is required to complete a **reading screener** during the first thirty days of school? This is why we make sure the DIBELS assessments and MAP assessments are completed before September is complete. In addition to meeting the academic needs of children, East Elementary serves (on average) **80 breakfasts and 150 lunches per day**. Important to know...**during the 20 school days in September East Elementary served roughly 3,000 hungry stomachs lunch.**

October

Our first quarter was wrapped up in October with report cards going home to parents. The Minden Fire Department educated students about fire safety during this month of fire safety recognition. Did you know that we are required to complete a **fire drill every month and a tornado drill, internal drill, and external evacuation drill every semester?** These are just a snippet of the ways we work to keep kids safe under our care. We also look out for the kids in our community outside of the school day. Through the backpack program, we send **home meal packs on Fridays** to families who apply and need the extra food over the weekend.

November

This is the month of Thanksgiving, and we have so much to be thankful for at our school. Did you know that we gather around the table once a month as a staff for a **potluck**? This is one way we set time aside in order to build positive staff relationships in our school. Another positive relationship we value outside of our building is the relationship we have with Family Physical Therapy, in particular Stacey Isaacson. Another fact...**Minden Public Schools provides students who qualify for the medically based services of speech, physical, and occupational therapy services at no cost to the family.** Speech services are provided by our two employed and licensed Speech/Language Pathologists, and physical and occupational therapy services are contracted through Family Physical Therapy.

December

Did you know that we greatly value collaboration with parents? During the month of December, the staff at East and the Preschool had 23 **parent meetings** whether through the SAT process, multidisciplinary team meetings, or individualized education plan meetings. These meetings took place either before or after school and happened at the same rate throughout the entire school year.

January

A new year brings new goals and who doesn't love to celebrate reaching goals?! Did you know that each month every staff member is asked to celebrate one student who has reached a goal of showing consistent integrity? Then I send home a **"positive principal note"** recognizing their accomplishments to their parents.

February

Parent/Teacher conferences, book fair, and building tours, oh my! February was sure a busy month for being the shortest month of the year. Did you know that during this month Mr. Widdifield and I began meeting with and learning about the **Community for Kids grant** project team. Together, we completed and submitted an application for the community of Minden and we were chosen as recipients. **We look forward to this opportunity to build childcare and early childhood education in the community of Minden.**

March

During the month of March, we took part in the **continuous improvement process**. This involved an external team of educational professionals evaluating our school district from top to bottom. Did you know...**Our district received**

exemplary feedback and was reminded of how amazing Minden Public Schools really is. Community meetings for a potential bond project for East Elementary/MPS also filled the calendar.

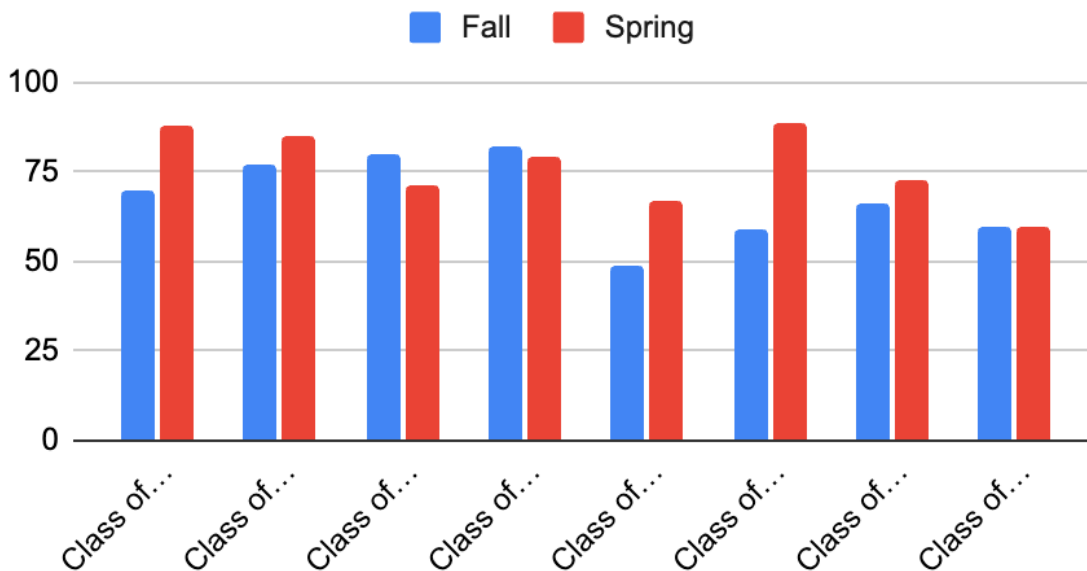
April

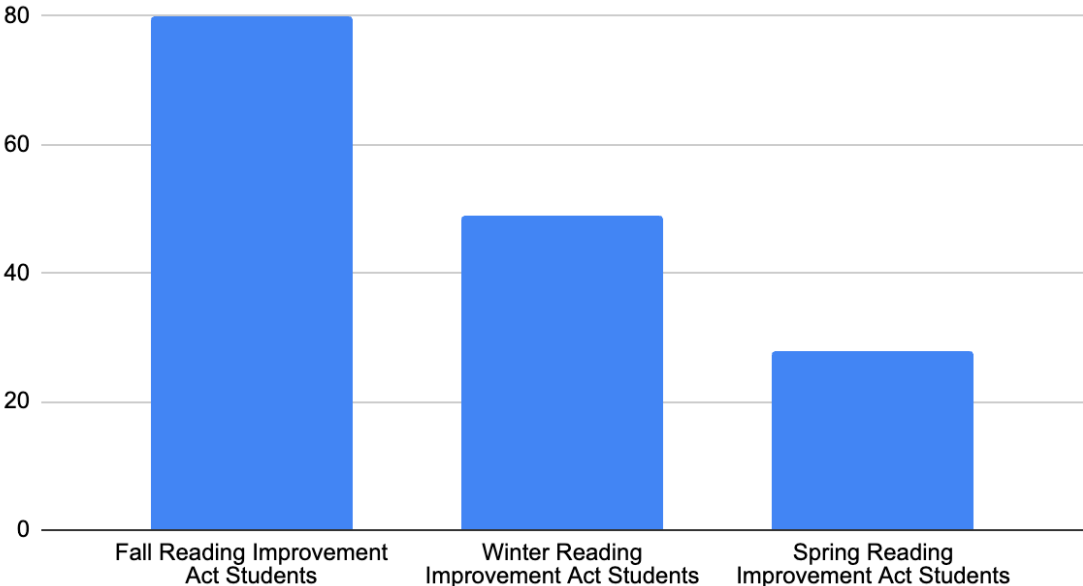
May
