6. **Presentation: FY23 Budget**—Mr. Robinson highlighted the budget details stating a 5% increase in salaries was included and purchased supplies/materials are up 3%. As member districts are also discussing, there are concerns about inflation and its effect going forward through the year as well as struggles with staffing. Administration is anticipating increases in all insurance policies, and in particular, cyber and liability coverage. New personnel include a Communications Coordinator and an Asst. Director of Business Services/CSBO.
