1. Call Meeting to Order

Board Chair Jay Trost called the Regular School Board Meeting to order at 5:30 p.m.

2. Pledge of Allegiance

The Pledge of Allegiance was recited.

3. Early Items

a. Presentation: Native American/Tribal Histories Units

The Native American/Tribal Histories Units presentation by Christine Zellmer was rescheduled for later in the summer. Superintendent Helena Chirinian noted that the district would like the presentation to take place when more people are present to hear it.

b. Presentation: Updates to BHSD Strategic Plan and Goals

Superintendent Helena Chirinian briefly discussed the 2026-2029 BHSD Strategic Plan, which was included later on the agenda for Board action. Chirinian noted that the Board members present had been involved in the process and were familiar with the direction of the plan. She stated that the plan was included in the agenda packet and that she would soon begin work with the Oregon Department of Education on related goals.

4. Citizen Input

No written public comment was received in advance of the meeting. No audience members submitted a request to speak, and no citizen input was provided.

5. Budget Hearing

Board Chair Jay Trost opened the Budget Hearing at 5:33 p.m.

Trost stated that, as required by ORS 294.453, the governing body must hold a budget hearing on the date specified in the public notice to receive citizens' comments on the budget documents as approved by the Budget Committee on May 26, 2026.

No public comment was received in advance of the hearing, and no members of the public were present or requested to comment on the budget.

Board Chair Jay Trost closed the Budget Hearing at 5:33 p.m. The budget adoption was addressed later under Action Items.

7. District Reports and Information

a. Comments from the Superintendent

Superintendent Helena Chirinian briefly reported that the Brookings-Harbor School District received notice that it was awarded a Seismic Safety Grant for one part of Brookings-Harbor High School. She stated that the grant amount was approximately \$2.4 million and that additional details would be discussed later. The grant will support seismic improvements to the high school auditorium/music room and science wing.

8. Action Items

a. Approve BHSD 17C 2026-2027 Budget Adoption

Janece Payne made the motion to approve the BHSD 17C 2026-2027 Budget. Trish Walker seconded the motion. There was no discussion.

The Board considered Resolution No. 2026-003, adopting the budget, making appropriations, imposing the tax, and categorizing the tax for the 2026-2027 fiscal year.

The resolution adopted the budget for fiscal year 2026-2027 in the total amount of \$31,758,823. The budget is on file at 629 Easy Street in Brookings, Oregon.

The resolution made appropriations for the fiscal year beginning July 1, 2026, including:

General Fund 100:

The resolution listed total appropriations for all funds as \$28,127,270, total unappropriated and reserve amounts for all funds as \$3,631,553, and the total adopted budget as \$31,758,823.

The resolution imposed ad valorem property taxes upon the assessed value of all taxable property within the district for tax year 2026-2027 at the permanent tax rate of \$3.2494 per \$1,000 of assessed value. The tax was categorized for purposes of Article XI, Section 11b as subject to the Education Limitation, with a permanent rate tax of \$3.2494 per \$1,000.

b. Approve Curriculum Adoption — Social Studies K-5, McGraw Hill IMPACT Social Studies

The curriculum had previously been presented to the Board as aligned with Oregon social sciences standards, offering digital and print access, literacy integration, inquiry-based instruction, differentiation supports, and connections with the district's existing Wonders ELA curriculum.

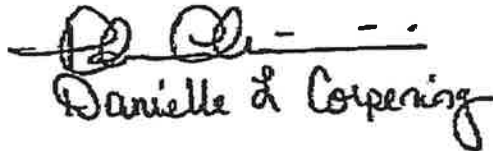
