**RESOLUTION CANVASSING RETURNS OF VOTES
OF SCHOOL DISTRICT GENERAL ELECTION**

BE IT RESOLVED, by the School Board of Independent School District No. 2397, as follows:

1. It is hereby found, determined, and declared that the general election of the votes of the district held on November 3, 2020, was in all respects duly and legally called and held.
2. As specified in the attached Abstract of Votes Cast, a total of 6,681 voters of the district voted at said election on the election of three (3) school board members for four (4) year term vacancies on the board caused by expiration of term on the first Monday in January following the general election as follows:

3. Kelsey Schwartz, Brian Sorenson, and Steven Cross, having received the highest number of votes, are elected for four (4) year terms beginning the first Monday of January, 2020.
4. The school district clerk is hereby authorized to certify the results of the election to the county auditor or each county in which the school district is located, in whole or in part.
