Nebraska's delegation lauds Trump after State of the Union

Nebraska's Republican congressional delegation lauded President Donald Trump and his policies after his State of the Union address Tuesday night.

During Trump's nearly two-hour-long speech, the president set out to convince Americans that the nation is in a better position than ever before under his leadership, declaring that "we're winning so much" while in more off-script moments slamming Democrats for "destroying our country."

Beyond blaming Democrats and former President Joe Biden for continued rising prices and health care costs, Trump spent little time talking about affordability.

"You caused that problem," Trump told Democrats about affordability concerns. He added a moment later, "They knew their statements were a dirty, rotten lie."

A Feb. 4 Pew Research Center report found roughly half of Americans surveyed said that since Trump took office in January 2025, his economic policies have made economic conditions in the U.S. worse. About 71% of U.S. adults surveyed said they are very concerned about the cost of health care while roughly 66% said the same about the price of food and consumer goods and 62% about the cost of housing.

Republican Rep. Mike Flood of Nebraska's 1st District said the speech was a "celebration of President Trump's accomplishments" over the last year, including the

work the president has done to lower costs for Americans.

"While the growth of inflation has come under control, the effects of Biden-era inflation continue to be felt by Americans, who continue to grapple with its impacts. Republicans will stay laser focused on affordability issues in the coming weeks and months," Flood said in a statement following the address.

Flood said the House has already taken steps to address affordability issues by passing legislation aimed at increasing housing affordability by reducing regulations around home construction to incentivize builders and local governments to invest in housing projects. Flood said the House is also preparing a new Farm Bill in the coming days to "update the critical programs that America's farmers and ranchers utilize to feed the world."

"Together, we'll work to deliver on this and much more to ensure that the next generation of American families can live the dream that has helped make our country great for the last 250 years," Flood said. Republican Rep. Adrian Smith said that under Trump's leadership, Republicans have been able to deliver "meaningful tax relief for hardworking Americans across the country."

"Americans have seen lower gas prices, decreased inflation, secure borders and mortgage rates reach a three-year low. While our work is far from over, I am encouraged by the progress we have made and the direction our nation is headed," Smith said in a statement Tuesday.

Sen. Deb Fischer said in a

statement Tuesday she was "pleased to hear" Trump renew his commitment to securing the border and strengthening the economy.

"Tonight, President Trump articulated the success of his policies to rebuild our military, keep our communities safe, lower energy costs and realize the American dream for all U.S. citizens," Fischer said. "I look forward to continuing to partner with him to make America safer, stronger, and more prosperous."

Sen. Pete Ricketts, too, applauded the president's work to "deliver safer streets."

"Securing the border means safer streets. Fentanyl seizures in

our state skyrocketed under the Biden administration. Thanks to @POTUS, border crossings are down 95% and our law enforcement officers have the tools they need to keep Nebraskans safe," Ricketts said in a social media post Tuesday.

When asked about Trump's "finger-pointing" at Democrats during a call with reporters Wednesday, Ricketts said Republicans and Democrats need to come together on issues like housing affordability where both parties agree action needs to be taken.

"Right now, we are just continuing to look for those areas where we have that common ground," Ricketts said, adding that he's worked

on bipartisan foreign relations bills countering China's influence on the world stage.

While Rep. Don Bacon praised the president for economic success, he criticized Trump for doubling down on his tariff approach.

"Article I, Section 8 of the Constitution gives tariff authority to Congress. The Supreme Court's common-sense and straightforward ruling got it right," Bacon said in a statement Tuesday. "Broad-based tariffs are also not smart economic policy, functioning as a tax on American consumers, manufacturers and farmers, and are unpopular nationwide by roughly two to one."

Ahead of president's address, Nebraska Democratic Party Chair Jane Kleeb said in a statement Trump would "undoubtedly lie" about how affordability is under control, saying the speech would be full of "Trump's higher prices, empty wallets and broken promises."

"We remind all Americans that Donald Trump's biggest lie during the campaign trail was that he would unite the country," Kleeb said. "No amount of lies and bragging in front of Congress and the nation can change what his most recent approval numbers confirm — Trump continues to move our country in the wrong direction."

49-year-old Lincoln man injured after exchanging fire with officer

Police are investigating an early Wednesday shooting involving a police officer that injured a 49-year-old Lincoln man.

During a briefing Wednesday morning, Lincoln Police Chief Michon Morrow said: "This is why we train."

An officer was dispatched shortly after 1:30 a.m. Wednesday to an alarm call at the Office Depot near North 50th and R streets. When he arrived, he found a man in the area of a garbage chute behind the store.

"When he arrived, he located a man inside a small access door behind the dumpster near the back dock," Morrow said.

The chute, which is above

ground and leads to the dumpster, could allow entry into the building, Morrow said. It was unknown whether the man had entered the business before the officer arrived.

Morrow said the officer announced himself and gave verbal commands, but the man did not comply.

"The suspect threw a metal object at the officer before firing at him, and our officer then returned fire," Morrow said.

The officer was not injured. Morrow said the man was shot in the lower extremities. He was taken to a Lincoln hospital with injuries that were not considered life-threatening.

Morrow said the 49-year-old man underwent surgery for multiple gunshot

wounds but did not know how many he sustained or what type of gun police believe he was carrying.

"We will say that we're also thankful that he will be OK and that there was no loss of life in this incident," the police chief said.

Morrow said it all happened very quickly. The shots were fired within 90 seconds of the officer's arrival. Morrow did not say how many shots were fired by the officer or the suspect.

She said when the man is released from the hospital he will be booked into jail on suspicion of attempted murder, burglary, felon in possession of a firearm and possibly other charges as the investigation unfolds.

A handgun was recovered near where the man was taken into custody. Morrow said she was unsure what

the metal object was.

At the time of the news conference, Morrow said she was also unsure if the suspect's shot struck anything in the surrounding area.

The officer who fired his weapon was placed on paid administrative leave, standard protocol in officer-involved shootings. Morrow said the man and the officer will be identified at a later date.

The investigation is ongoing and is being led by the Lincoln Police Department with assistance from the Lancaster County Sheriff's Office.

Police are continuing to review body camera footage. Police released still images from the footage, but Morrow said she does not plan to release the full video.

The Office Depot, which

closed at 8 p.m. Tuesday, was open on Wednesday, according to an employee who answered the phone.

Mike Flood backs NU gender policy change

Rep. Mike Flood applauded the University of Nebraska's decision to end a policy recognizing gender identities that differ from a person's assigned sex at birth, backing NU President Jeff Gold's November memo removing that language.

On a call with reporters ahead of Trump's State of the Union address Tuesday, the 1st District representative said he supported stripping out language referencing gender identity.

Signed by former NU President Ted Carter in 2020, the policy directed the university to use an individual's gender identity "where possible in the course of University education, business, and communication."

"I've said this before, biological sex is an immutable characteristic. I think this is a common-sense step that the president of the university took," Flood said.

The NU policy change came just months after Trump signed an executive order to reverse protections for LGBTQ+ students enacted during the

Biden administration.

In January 2025, Trump signed a pair of executive orders declaring the federal government would recognize two sexes — male and female — and instructing federal agencies to end grants that provided funding for "equity-related" projects.

Flood said he thinks the country is slowly backing away from "some of this identity politics stuff that was so divisive under the Biden administration," and that he would support legislation to codify those federal directives into law.

While the memo did remove language pertaining to gender identity, Gold did leave in place the requirement that NU recognize and use an individual's chosen name "wherever possible."

On the call, Flood also said he supports Bob Kerrey's decision last week to step down from his role as board chair of Monolith, a Lincoln-based clean energy company, after emails showing an association with Jeffrey Epstein were made public earlier this month.

Documents released by the U.S.

Department of Justice show the former senator and governor exchanged multiple emails in 2013 and 2014 with Epstein, who was convicted of soliciting a child prostitute in 2008 and later indicted for sex trafficking minors in 2019.

While Kerrey was invited to meet with Epstein several times, he said he did not recall any of those invitations resulting in an actual meeting.

Flood said Kerrey notified the congressional delegation of his decision to resign via letter and, based on that communication, Kerrey resigned because "he did not want to be a distraction from their efforts in Washington."

Following Kerrey's resignation, Nebraska GOP Chairwoman Mary Jane Truemper called on candidates and organizations to return any political contributions received from Kerrey.

In 2025, Kerrey donated approximately \$22,500 to candidates and causes in Nebraska, according to Nebraska Republican Party.

Flood said he has never received a donation from Kerrey and that for candidates who have, it would be a "good idea to send those contributions back."

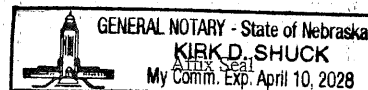
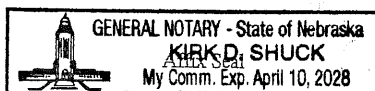
