Nebraska billboards tie Trump to 'Sticker Shock Summer'

One organization wants to make a statement in Nebraska. Political advocacy group Home of the Brave is spending \$15 million on a campaign blaming President Donald Trump for making life more expensive for the American people this summer. "Sticker Shock Summer" includes multiple Lincoln billboards, which read "Why does your summer vacation cost more this year?" next to a picture of Trump. "We are running billboards and video ads across Nebraska throughout the summer, due to the massive price increases being experienced by Nebraskans for gas, groceries and more," according to a news release. "Sticker Shock Summer will center on a simple reality: Summer is supposed to be a season of vacations, barbecues, road trips and a little breathing room. But for millions of Americans, the cost of summer fun has gone up." One billboard sits outside the Sinclair Gas Station on West O Street. An employee at the station's convenience store Git 'n Split said the billboard has turned some heads. While no customers have said anything to her directly, the employee said many people stop to take pictures of it while filling up their tanks.

She also said the store's owner — who is a Trump supporter — is not a fan of the billboard but has no control over what the message is because the billboard is owned by Lamar Advertising Company. A second Trump billboard sits off Van Dorn Street, between Park Boulevard and South Sixth Street. As part of "Sticker Shock Summer," the organization aims to highlight how prices have increased nationwide through an interactive website. Home of the Brave has paid for billboards in 16 states. The campaign also includes three video advertisements and a man-on-the-street style video compilation of people "fed up with gas prices."

The dedication will be from 9:00 to 9:30 a.m. and the rest of the time the public will be able to tour the building. She also shared that some city staff had toured other city buildings for the space optimization project. There were good conversations had while touring regarding renovation. Next week there will be another meeting with the engineers about the current city hall and old fire station renovations.

Water Master Plan Update with Olsson Inc.

James stated that Olsson completed the Water Master Plan in 2019. This is helpful to keep updated for economic development and grant purposes. It needs to be updated again to include the Northwest York Industrial Park. Dr. Crawford stated she believes it is in the city's best interest to waive the public bidding requirement and accept this proposal with Olsson, Inc. to update the city's water master plan. James answered the questions of the council.

STAT. §60-6,356; TO IMPOSE A PENALTY FOR THE VIOLATION OF THIS SECTION; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE FOR THIS ORDINANCE.

Second Reading:

ORDINANCE NO. 2437

AN ORDINANCE TO AMEND CHAPTER 52 OF THE YORK CITY CODE TO ENACT AN ORDINANCE TO PERMIT THE OPERATION OF GOLF CAR VEHICLES WITHIN THE CORPORATE LIMITS OF THE CITY AS AUTHORIZED BY THIS ORDINANCE AND NEB. REV. STAT. §60-6,381; TO IMPOSE A PENALTY FOR THE VIOLATION OF THIS SECTION; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE FOR THIS ORDINANCE.

Conversation was had first between the ordinance committee and the rest of council before being opened up for public comment. Councilmember North stated there were no revisions to the UTV ordinance. The golf car vehicle ordinance added more restrictions on where it was allowable to drive them. Restrictions were added for Grant Avenue and Lincoln Avenue. Councilmember Sheppard addressed the question from the last reading regarding the farm permit. State statute does allow for a farm permit, which is for a 14 or 15-year-old. Once a Provisional Operators Permit is acquired at the age of 16, it is no longer allowable, but allowable again once the Class O license is acquired. Councilmember Postier questioned insurance for these types of vehicles and a slow-moving sign for golf carts. Councilmember Lopez asked about a registration sticker. Conversation was had regarding what a registration process might be. The Mayor stated the public was allowed to speak if anyone so desired. John Biel, 515 E. 18th Street, York, thanked the council for the good discussion. He stated he feels most people will read the state statutes before driving either of these types of vehicles on the streets of York. He feels most who are proponents of this aren't looking to cause problems, they would just like the opportunity to use them. He spoke on safety concerns for underage drivers and golf cart safety upgrades. Duane Grotz, 1018 Road L, York thanked the council for the consideration of this subject. He stated it would make life easier for the farmers. Dan Aude, 1317 Road 15, Geneva, shared he opposed both of these ordinances due to safety concerns. Gale Homes, 129 S. Maine Ave, York, in for these ordinances. He gave the example of having to trailer his UTV a couple blocks to be out of city limits to be able to utilize it. He shared several examples of big cities in Florida that have these types of vehicles on the roadways. There was no other public comment. The third reading of these ordinances will be July 16, 2026.

Public Hearing on A-L Zoning

The Mayor announced this was the time and place for a public hearing for an update on permitted uses with a special use permit in the agricultural district of the city's zoning. Dan Aude shared the A-L zoning was updated a few years ago and this is just adding to the permitted uses for a special use permit for the agricultural zoning. This would allow more types of venues to be created within this district. It was recommended by the Planning Commission. Duane Grotz, 1018 Road L, York, asked about an event that he holds and if it would require a permit. He suggested maybe this ordinance needed more clarification before passage. There was conversation clarifying some of his questions. Dan stated that most ag businesses are exempted from this permitting process. There was no other public comment.

Police chief: Expand staff or cut services

The York Police Department will start reducing services if the City Council doesn't agree to fund the hiring of an additional officer, Chief Ed Tjaden said at a budget meeting Thursday.

Expanding the police force is necessary due to increased calls for service, according to Tjaden.

"When I came in 2017, we handled just shy, I believe, of 8,000 calls for service," he said. "Last year, we did 10,500, and we're on track to keep increasing that over time."

In addition to responding to calls, York police have expanded their presence in other ways.

"There was a very clear mandate, very clear expectations for me that was laid out. ... They wanted us more out in the community, more visible," Tjaden said.

Their community involvement has included the school resource officer program, increased visibility at community events and having officers on various boards and committees.

"We love it, but we're going to burn out," Tjaden said.

Tjaden issued an ultimatum to the City Council.

"If we don't get more staff, I will come to this council and ask, 'Make me a list of the calls and services you don't want us to provide anymore,'" he said.

The department's budget proposal includes \$106,000 for the new officer.

"106,000: Is that all benefits, retirement, all that included, or is that just the base salary that's proposed?" council member Stephen Postier asked.

Tjaden said the \$106,000 would cover the officer's salary and benefits.

He also plans to hire another officer next budget year.

Parks and Recreation Director Cheree Folts and Holthus Convention Center Director Terri Carlson presented their proposed budgets to the City Council on Thursday.

Harrison Park bathroom stalls were damaged twice in May. New cameras would be at Miller, Harrison, Beaver Creek and Levitt parks.

At the convention center, the budget request is for three exterior cameras: at the playground, the east side and the entrance.

"Cars hitting the building, hitting trees — all those things have happened," Carlson said.

The proposed Parks and Rec budget includes a plan to make the bathrooms at Miller Park, Beaver Creek Park and Harrison Park ADA-compliant.

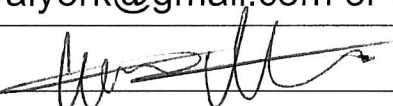

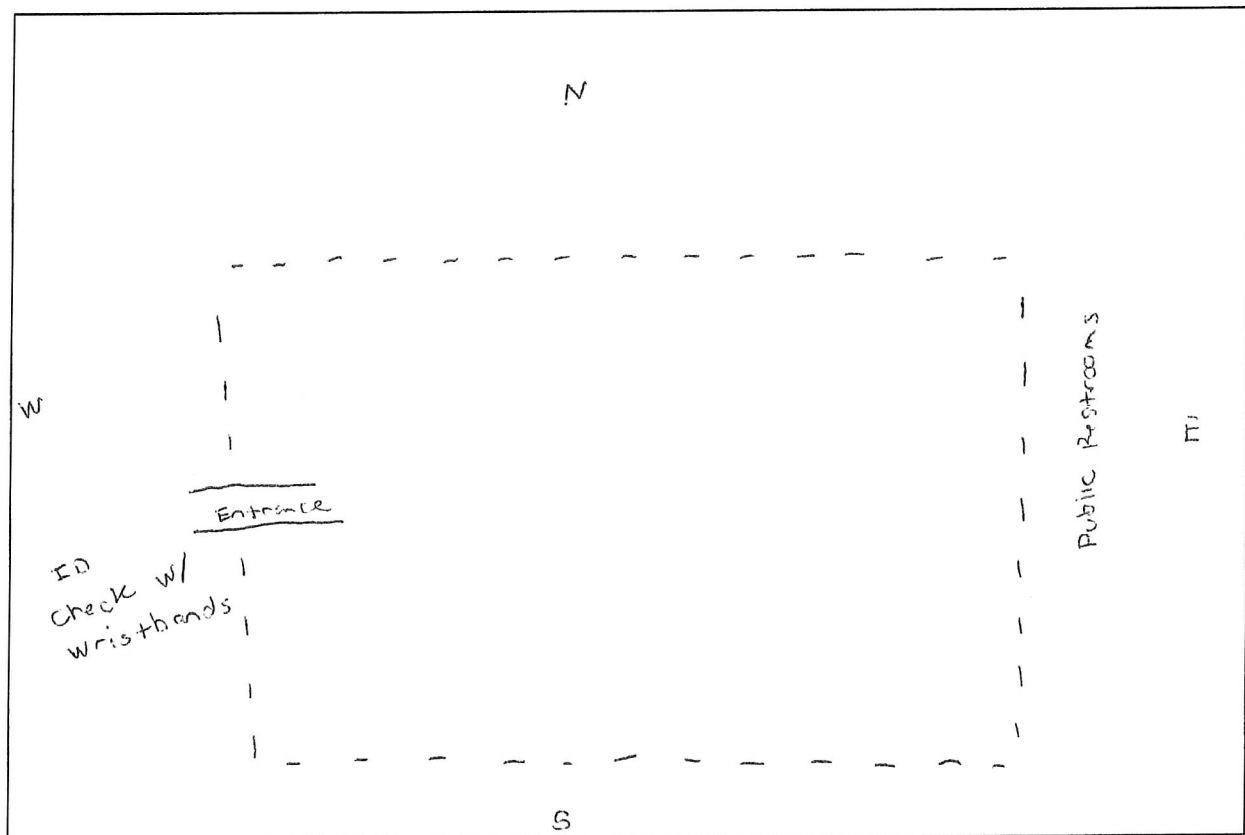

Dear Ms. Crawford,

In coordination with Pat Lusk of Olsson Associates and the NDOT, NPPD has planned a Line Relocation that is compatible with the proposed Pedestrian Bridge across Hwy 81, North of I-80 in York, NE.

NPPD operates and maintains the 7.2/12.5kV Distribution system in York that runs east and west between McDonald's & Arby's Restaurants on the West side of Hwy 81 and continues East to Wendy's Restaurant on the East side of Hwy 81. The Planned Pedestrian Bridge is part of NDOT Project # DPS-93(15), CN 43010 Project Access York, as designed by Olsson Associates.

Reference Two Drawings : 5618392 is NPPD's GIS Map, 2nd Drawing is Olsson Associates AutoCAD : NPPD's plan is to relocate this Electric Feeder Underground which requires pad-mounted Switchgear, Transformers and Junction Modules. Easements for each property will be required and relocation is contingent upon acquisition of them. A Permit to Occupy Hwy 81 right-of-way and under-cross has already been secured.

The Estimated costs for this relocation to the City of York are \$658,582. The costs are based on NPPD's best estimates at the time of execution of this Agreement. Upon completion of work activities, NPPD will bill Customer for actual project costs.

While NPPD will make reasonable efforts to comply with Build America, Buy America (BABA) and/or Buy America requirements as requested by the State, NPPD will not agree to make reimbursement of costs to NPPD contingent on strict compliance with BABA and/or Buy America. If any equipment cannot be purchased in compliance with BABA and/or Buy America regulations, NPPD will contact the City of York to discuss the compliance challenge and shall allow the City and NDOT to work on a resolution to the challenge prior to the non-compliant purchase. Receipt of this letter, and of allowing NPPD to begin the requested work, shall act as an acceptance of the obligation of the City to fully reimburse NPPD for all work completed and materials purchased, provided that any potentially noncompliant purchases have been reviewed by the city and approved, in writing, by the city of York.

If NPPD is delayed in the performance of its obligations under this agreement by reason of its efforts to comply with BABA and/or Buy America, or any other cause beyond the NPPD's reasonable control, the date(s) for completion of such NPPD obligations shall be extended by a period equal to the time lost by reason of such delay. Such an extension shall not constitute a default or breach by NPPD, nor shall it excuse any obligation of the City or NDOT. If 30 days have elapsed following the date NPPD contacted the City regarding the compliance challenge and the challenge has not been resolved to NPPD's satisfaction, as evidenced by writing, NPPD shall have the option to terminate the agreement without any further obligation to the City or NDOT. Notwithstanding termination, NPPD shall remain entitled to reimbursement for all work completed and materials purchased prior to termination.

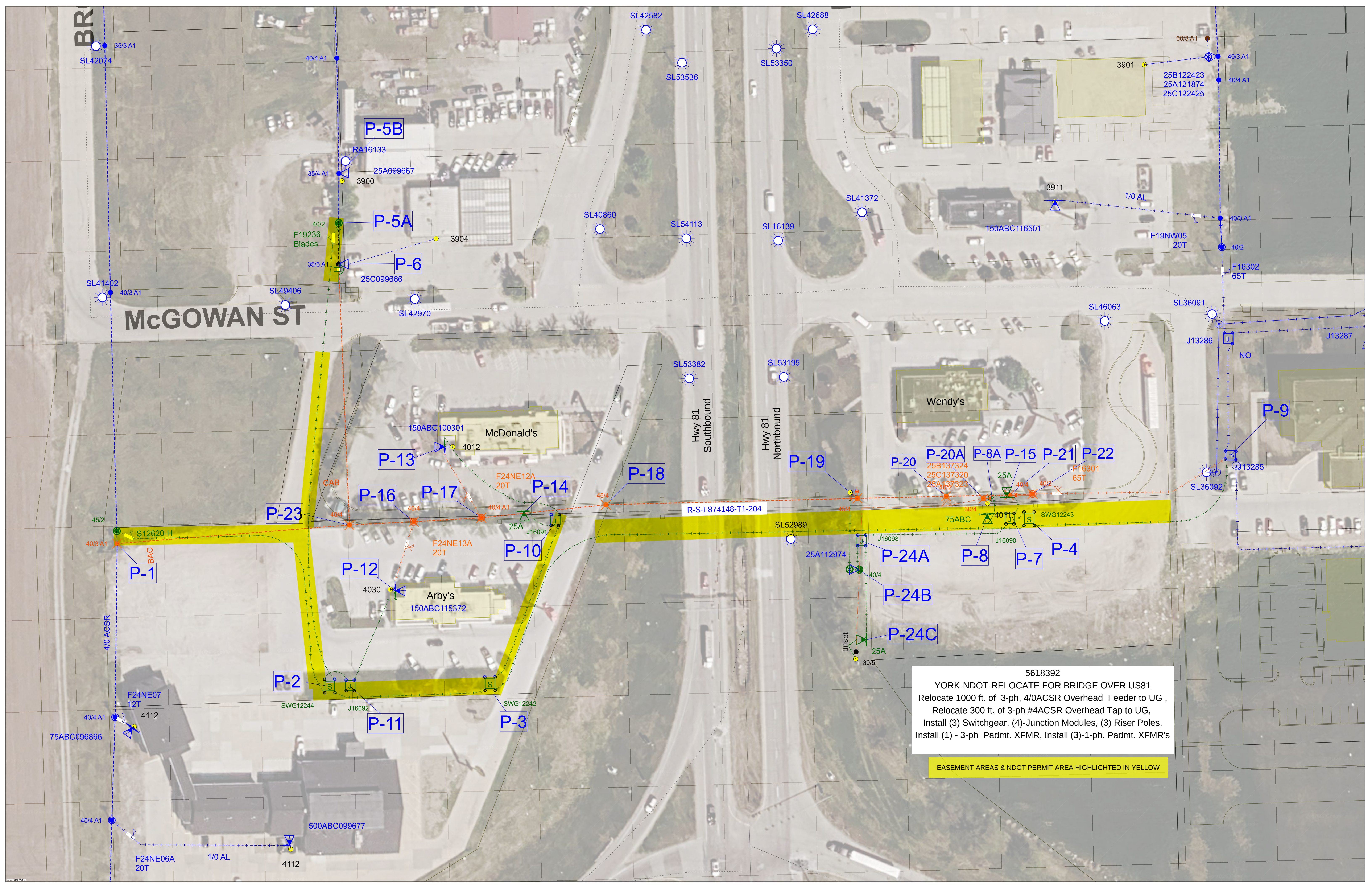
