1. 533: Wellness
Andrea Schaak requested that this policy is updated and has submitted the attached policy for review.
2. 902: Use of School District Facilities and Equipment
This will be a new policy for JPS.
3. 208: Development, Adoption, and Implementation of Policies
4. 420: Students and Employees With Sexually Transmitted Infections and Diseases and Certain Other Communicable Diseases and Infectious Conditions
Adds provision for no cost Hepatitis B vaccinations to employees who have occupational exposure and makes minor grammatical corrections.
5. 509: Enrollment of Nonresident Students
Revisions to the termination of enrollment section based on change to compulsory instruction age.
6. 532: Use of Peace Officers and Crisis Teams to Remove Students With IEP's From School Grounds
Definition of "emergency" amended, use of prone restraints language eliminated, reporting on use of restrictive procedures now required due to legislative change.
7. 615: Testing Accommodations, Modifications, and Exemptions for IEP's, Section 504 Plans, and LEP Students
Gives the new location of the current Minnesota Assessments procedures.
8. 618: Assessment of Student Achievement
Eliminates references to the Profile of Learning and provides updates based on legislative changes.
9. 620: Credit for Learning
Eliminates references to the Profile of Learning.

10. 707: Transportation of Public School Students
Paragraph about transportation for pre-kindergarten children with disabilities amended consistent with statutory language.
11. 805: Waste Reduction and Recycling
Reflects legislative changes.
12. 807: Health and Safety
Note amended to reflect upcoming changes in the law effective for fiscal year 2017.
13. 905: Advertising
Amendment to the restrictions on advertising device placement to reflect statutory language.
14. 101: Legal Status of the School District
These changes reflect updates to the legal and cross references (including changes in statute numbers and/or names, new statutes, rules, or cases), changes to the notes within the policies, and minor corrections.
15. 406: Public and Private Personnel Data
16. 427: Workload Limits for Certain Special Education Teachers
17. 508: Extended School Year for Certain Students with IEPs
