WAVERLY SCHOOL DISTRICT #145 REDISTRICTING RESOLUTION

WHEREAS, Neb. Rev. Stat. § 79-550, and other Nebraska law, permits the Waverly School District #145 Board of Education to divide its territory into wards or districts, and that legal voters of the District elect Board Members by wards or districts; and

WHEREAS, Nev. Rev. Stat. § 32-553(2) requires the Board of Education to draw its own district boundaries and requires the board to follow the precinct lines created by the Election Commissioner or County Clerk after each federal decennial census as nearly as possible; and

WHEREAS, the results of the 2020 decennial census have been reviewed and considered; and

WHEREAS, the Waverly School District #145 Board of Education considered the proposed redistricting plan and has considered any testimony, input, written comments, written reports as received by members of the public; and

WHEREAS, the Waverly School District #145 Board of Education finds the attached redistricting plan to be in the best interest of its patrons and believes that it complies with all state and federal laws and requirements.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED AS FOLLOWS:

1. The existing Waverly School District #145 district boundaries are amended as shown on the map attached hereto as Exhibit "A". Exhibits "A" are incorporated herein and made a part of this Resolution.
2. The Superintendent is authorized and directed to submit this Resolution with the attachments to the Election Commissioner or County Clerk.
3. The newly established districts shall apply beginning with the nomination and election of Waverly School District #145 board members in 2022.




