A meeting of the Board of Trustees of the Amarillo Independent School District will be held on Thursday, October 29, 2020, at 8:00 AM. **Due to health and safety concerns related to the COVID-19 coronavirus, this meeting will not be held in the Board Meeting room, but will be conducted by videoconference.** At least a quorum of the board will be participating by videoconference in accordance with the provisions of Sections 551.125 or 551.127 of the Texas Government Code that have not been suspended by order of the Governor of Texas.
