The purpose of the training is to enhance the effectiveness of the board-superintendent team, and to assess the team's continuing education needs, based on the Framework for School Board Development. As part of the workshop, the Team of 8 will also discuss the District's strategic framework, including vision, mission, goals and core values (Framework for School Board Development, Framework I: Vision and Goals); as well as systems and processes including Board operating procedures and Board committee structure, policymaking, student academic progress and accountability, safety and security plans, and future priorities (Framework II: Systems and Processes)
