**Background Information:**

The Texas Education Agency has established additional requirements for school district budget preparation. As part of these requirements, a school district must amend the official budget before exceeding a functional expenditure category, i.e., instruction, administration, etc., in the total district budget. Attached is a copy of the proposed amendment to the Official Budget identifying details of the request. The following summarizes the effect of the amendment by functional category.

**Summary:**

***Amendment #028: Facilities & Maintenance Department (Fund 199)***

This amendment will reallocate funds from the sale of facilities and land, formerly Indian Spring Middle School, to the facilities account in order to pay for the replacement and modernization of the elevators at the Administration Building. These adjustments are required to appropriately reclassify the budget to the proper expenditure codes per TEA accounting guidelines.

**Background Information:**

Request for Proposal, RFP # 22-1229, Maintenance Supplies, Equipment, and Services have been received for the purpose of creating a list of vendors which can provide supplies, equipment, and services for the Facilities and Maintenance and Custodial Departments. We have received one hundred ninety (190) responses for this initial bid. We received two (2) additional vendors this past month. This list has been attached for your consideration.

In an effort to allow for maximum participation with our Maintenance and Custodial vendors and in light of changes made in 2019 by the Texas Education Agency's, Financial Accountability Systems Resource Guide (FASRG) Module 5 Purchasing, the Purchasing Department has elected to utilize the Extended Period for Multiple Award Contracts as shown in the FASRG excerpt shows.

**3.16.6 Limited Response Period versus Extended Period for Multiple Award Contracts**

Normal procurement practices will allow solicitation responses to be submitted to the district within a limited, specific time period, usually two to three weeks. The district may want to review past policies to determine if a limited response time is in the best interest of the district and the needs of its end users.

Consideration may need to be given to have an extended opening for receiving responses.

- **Limited Response Period.** This choice is considered a normal, formal RFP. Examples include newspaper advertisements and awards made and limited to only the responders that submitted and awarded for the solicitation.

- Extended Response Period. This choice is more informal than a limited response period. The major difference is the date the responses are due. This method allows for responses to be accepted throughout an extended period such as the date of the contract award expiration and awards made periodically. Periodic board approval may also be required. For newspaper advertisements, our District will continue to publicize periodic republication through our website and continue to enlist the assistance of the three (3) Chamber of Commerce's, as received on this first solicitation. The advertisement will address concerns about transparency by announcing the solicitation to new readers even though the statutory requirements were met by the initial publication.

The intent for awarding additional vendors to this bid will be done on an as needed basis. Vendors submitting a response by the end of each month will be submitted for consideration at the next board meeting.

**Fiscal Implications:**

The cost of these items will be charged to the appropriate campus/department budget.

**Background Information:**

Request for Proposal, RFP # 24-1263, Local Retailers' General Merchandise have been received for the purpose of creating a list of vendors from the Greater Waco Area that can provide supplies, equipment, and services for the District on an as needed basis. We have received sixty-six (66) responses for this initial bid. We received one (1) additional vendor this past month. This list has been attached for your consideration.

In an effort to allow maximum participation for vendors currently residing in the Greater Waco Area, as well as new vendors moving into the area, the Waco Independent School District is electing to engage in Extended Period for Multiple Award Contracts as allowed under the Texas Education Agency's, Financial Accountability Systems Resource Guide (FASRG), Module 5: Purchasing, exhibited below.

**3.16.6 Limited Response Period versus Extended Period for Multiple Award Contracts**

Requests for Proposals, RFP # 21-1210, Internet Service Provider (E-Rate) has been issued and awarded to Grande Communication/Astound Business Solutions for the purpose of providing internet service throughout the District. In the RFP, pricing was requested for a three-year period and a five-year period, with bandwidths ranging from five (5) gigabytes to ten (10) gigabytes.

**Background Information:**

Competitive Sealed Proposal, CSP # 26-1309, has been opened and evaluated for the purpose of awarding a qualified vendor to perform the turn-key Re-Roofing project for South Waco Elementary. We received seventeen (17) responses to this solicitation, however two (2) proposers failed to provide all the required documents and as such were not eligible to be considered.

In the request for proposals, we requested pricing for two (2) different types of roofs. The first, base bid # 1, is for a Modified Bitumen Asphaltic Roofing System and base bid # 2 is for a Fully Adhered TPO Roofing System. Bid item #3 has been made obsolete by a change in project approach.

Once the evaluations were completed, the committee ranked the proposers. References were checked for the top three (3) proposers.

After reviewing the pricing and the evaluations, the committee recommends approving the Base Bid # 1 for the Modified Bitumen Asphaltic Roofing System and that negotiations commence with the highest ranked proposer. Attached, for your review is the bid tabulation along with the scoring detail summary sheet.

If agreement cannot be reached with the #1 ranked proposer, the District will cease negotiations with that bidder and move to the next highest ranked proposer as provided for in the CSP selection process.

**Fiscal Implications:**

The cost of these services is \$ 1,430,028.00, and will be charged to surplus bond funds.

**Administrative Recommendation(s):**

The Administration recommends that the Board of Trustees approve the ranking as described above for the South Waco Elementary School re-roofing project and authorize the Superintendent, or her designee, to proceed with contract negotiations as allowed by the competitive sealed proposal delivery method.

### **REVIEW, DISCUSS AND TAKE APPROPRIATE ACTION REGARDING A THIRD PARTY PARTNERSHIP AGREEMENT, ELEMENTARY SCHOOL, UNDER BOARD POLICY**

Dr. Spicer shared that on January 22, 2026, the Waco ISD Board of Trustees approved TEA-recommended updates to Board Policy ELA, Campus or Program Charters: Partnership Charters, which outline the process for partnering with external education organizations. These partnerships support campus operations while maintaining district oversight, with the goal of strengthening student outcomes and expanding educational opportunities. She explained that Waco ISD followed the approved framework, conducting a rigorous selection process including application review, reference checks, and leadership interviews.

Board President, Jose Vidana, entertained a motion. Jeremy Davis made a motion to approve the Third Party Partnership Agreement, Elementary School, Under Board Policy, seconded by Taylor Bledsoe. The motion passed unanimously (6-0).

=====

**Background Information:**

Senate Bill 569 provides school districts with a flexible, fully funded framework to launch virtual and hybrid education models. It repeals the old Texas Virtual School Network (TXVSN) rules and empowers school boards to strategically expand learning options and attract new families.

Three Flexible Implementation Models:

- **Individual Courses:** The district can offer specific virtual or hybrid courses to address local staffing shortages, expand advanced coursework, or support credit recovery without making major structural changes.
- **Full-Time Programs:** The district can launch a full-time virtual or hybrid "program" housed within an existing physical campus. As long as the virtual enrollment remains under 50% of the total district or campus enrollment, no special authorization from the Texas Education Agency (TEA) is required to begin.
- **Full-Time Campuses:** If the district wishes to create a standalone virtual or hybrid school where 50% or more of the students learn remotely, it must apply for formal TEA authorization, a process that opens after rulemaking in Spring 2025.

Students enrolled in these virtual or hybrid models generate Average Daily Attendance (ADA) funding in the exact same amount as students attending fully in-person. For full-time programs, this funding is calculated using the district’s average in-person attendance rate.

Under this law, the district can operate as a statewide "district of choice." This allows the district to enroll students from anywhere across the state of Texas into its virtual program. Doing so provides a significant opportunity to increase overall enrollment and generate non-traditional revenue without the capital burden of building new physical facilities.

By utilizing the "full time program" option above for year one, under SB 569, the School Board has the option to partner with third-party turnkey providers to quickly launch a comprehensive virtual academy. This allows the district to delegate day-to-day operations, human resources, and special education management, while the district retains graduation authority, state accountability ratings, and an ongoing sponsorship fee. After year one, the Board can elect to move to the “Full Time Campus” option with TEA.

**Administrative Recommendation(s):**

Administration recommends that the Board of Trustees approve the search for a potential partnership to act as a whole program virtual instruction provider for a new statewide full-time virtual option under SB 569. Furthermore, the Board approves the School Leadership Team to move forward with due diligence efforts to bring a formal proposal back to the Board in April from a prospective partner for approval to start the “program” option for the 2026 - 27 school year.

**Background Information:**

On January 22, 2026, the Waco ISD School Board of Trustees approved TEA recommended updates to board policy ELA Campus or Program Charters: Partnership Charters, providing the process for Waco ISD to follow when identifying potential partnering education organizations.

This type of partnership allows a school district to collaborate with an external partner to support the operation of a campus while maintaining district oversight and accountability. The intent of this partnership is to strengthen student outcomes, expand educational opportunities and provide additional resources aligned with district goals.

Waco ISD administration would like to explore, negotiate, and authorize a strategic partnership with the Economic Opportunities Advancement Corporation (EOAC) under the Texas Senate Bill (SB) 1882 framework. This partnership seeks to formalize and expand our long-standing relationship with EOAC to operate an integrated Early Learning Innovation Center. By leveraging EOAC’s expertise in federal Head Start standards and Waco ISD’s instructional infrastructure, we can create a "Gold Standard" for school readiness in Central Texas. SB 1882 unlocks an estimated \$1,000–\$1,500 in additional state funding per student. This allows us to maximize taxpayer dollars by blending federal Head Start grants with state incentives.

**Fiscal Implications:**

This will be brought to the School Board in the form of a report item in April, once negotiations are concluded.

**Administrative Recommendation(s):**

Administration recommends that the Board of Trustees approve the administration's ability to explore, negotiate, and authorize a Charter Performance Contract for Head Start services with Economic Opportunities Advancement Corporation (EOAC) of Waco for the 2026 - 2027 school year and beyond.
