The Welch Board of Education of Independent School District I017 of Craig County, State of Oklahoma, met in special session on Monday, January 17, 2023, in the Multipurpose/Board Room in the Delbert Lovelace High School, 707 South Curtis Street, Welch, Oklahoma.

I, the undersigned Clerk of the Board of Education of Welch Public Schools, District I017 of Craig County, Oklahoma, do hereby certify that at least 48 hours prior to the meeting excluding Saturday, Sunday, and holidays, notices of date, time, and place, and at least 24 hours prior to the meeting excluding Saturday, Sunday, and holidays, the agenda of the meeting were posted in prominent public view at the location of the meeting.

The meeting was called to order by President Shane Burgess at 5:30 PM. Members present were President Burgess, Vice President Jesse Highsmith, Clerk Rowdy Layton, Deputy Clerk Brian Mooney, and member Shannon Walker. Superintendent of Schools Jeremy Ramsey was also present.

A quorum was declared.

President Burgess led the Pledge of Allegiance.

There were no visitors present to request Public Participation.

In recognition of January as School Board Recognition month, Superintendent Jeremy Ramsey reiterated that Welch Public Schools is fortunate to have five dedicated individuals who volunteer their time and energy to govern the District and thanked them for their service.

Mr. Ramsey presented the Principal reports as administrators were at several basketball games.

Mr. Ramsey presented information on the Football Concession area water damage and status of the rebuilding of the interior of the concession stand, restrooms, and ticket booth; the conversion of the WPS website by Apptegy with the "go live" date of March 3; area Superintendents will be meeting with Senator Bergstrom on the redundancy of accreditation reports and paperwork for districts and Federal program claims processes; CCOSA meeting in OKC later this month; the drop down screen and electric being installed in the Old Gym with Federal delinquency funds; mid-term adjustment of a positive \$103,198.00 and the administrative staff works to be sure "every kid counts"; and budgetary information for the month of December.
