The Welch Board of Education of Independent School District I017 of Craig County, State of Oklahoma, met in regular session on Monday, December 11, 2023, in the Multipurpose/Board Room in the Delbert Lovelace High School, 707 South Curtis Street, Welch, Oklahoma.

I, the undersigned Clerk of the Board of Education of Welch Public Schools, District I017 of Craig County, Oklahoma, do hereby certify that at least 24 hours prior to the meeting excluding Saturday, Sunday, and holidays, notices of date, time, place, and agenda of the meeting were posted in prominent public view at the location of the meeting.

Rowdy Layton, Clerk of the Board of Education

President Shane Burgess called the meeting to order at 5:30 PM. Members present were President Burgess, Clerk Rowdy Layton, and Member Shannon Walker. Members absent were Jesse Highsmith and Brian Mooney. Administrators present were Superintendent of Schools Jeremy Ramsey and Elementary Principal Kimberley Hall.

A quorum was established.

President Burgess led the Pledge of Allegiance.

Visitors present did not request any public participation.

Kimberley Hall, Elementary Principal, presented information on the activities of the Elementary school for the month of November and through the end of the term in December. Mrs. Ezell's reports for the Middle and High Schools were presented in writing due to her and Mr. Gleaves serving as administrators for the Sooter Basketball Tournament that started this evening.

Superintendent Ramsey reported that documents have been submitted on the Consolidated Monitoring for Federal Programs on time. The department has notified schools being audited that the reviews should be reviewed and finalized by the month of May. Child Nutrition was on site for four days and we are still waiting to complete the audit due to coding issues that are to be discussed between the State Department and Child Nutrition. Overhead Door has been contacted for upgrading crash bars and doors for use of the state security funds. A draft of the school calendar for SY25 is in process, he has been meeting with area superintendents, and will also be coordinating an area professional development day with several schools as was done this year. Shannon Walker was the only candidate to sign up for Seat #4 so there will be no election in the spring. He will officially fill Seat #4 on the Board in April for another five years. Mr. Ramsey then reviewed the revenue and expenditures for the month of November for the General and Building funds.
