Mrs. Hall reported that upper elementary hosted donuts with grownups. Each of the students researched careers and did a presentation about careers. It was great to see so many parents up here and get involved. Fifth and sixth graders competed in regional quiz bowl competition and were unable to move onto the state tournament. All elementary celebrated the 100th day of school, with different activities. Eye screenings were held by Vizivance for all PK-6th grade students and referrals sent home as needed. There was a math challenge for the Super Bowl. The Education Foundation will be hosting a Bingo fundraiser on March 27th this year.

Mrs. Ezell reports that high school has enrolled 3 new students. BPA is hosting college and career readiness this week. Career Tech interviews are this week. High School basketball District playoffs start this week. Tuesday night is the FFA 4H pie supper fundraiser. February 21st is the Spring Livestock Show.

7. Superintendent Report

Mr. Ramsey reports the Redbud allocation is up for a total of \$36,108.00, up \$4600.000 from last year and will be put in the Building Fund. Mr. Ramsey attended the OASA superintendent meeting last week in OKC. There are over 2,000 legislative bills for this session. The big one school is Calendar days. March is normally when the calendar is put out but he is holding off in limbo until more comes out, when these calendar changes will go in effect for schools. He is hoping they will give us at least a year to prepare. The reading Sufficiency plan is coming back. In the future legislation is looking to add apprenticeships to apply toward graduation credits. We should expect to get more FBA funding because it has not been paid out correctly. This is the third year for the school resource officer funding of \$92,000.00 Should continue to receive funding may not be the full amount but the funding is out there. The admin team has been in discussion about staff planning, retirees, and preparing to use the new gym in the next 26-27 school year. The digital sign quotes have been received and will be presented tonight later in the meeting.
