## 2025 PIA Days for Consideration








January 2, 3, 2025 - Winter Break

March 17, 18, 19, 2025 - Spring Break

November 26, 28, 2025 - Thanksgiving

December 23, 24, 26, 2025 - Christmas

The Texas Public Information Act (TPIA) counts business days, which are weekdays (Monday through Friday) that exclude: 

- National holidays 
- State holidays 
- Saturdays 
- Sundays 
- The Friday before or Monday after a holiday that falls on a weekend 
- Optional holidays observed by the public information officer 
- Days the governmental entity is closed to the public for business 
- Days the governmental entity is operating with a skeleton crew
