B. PUBLIC FORUM

Board Chair

During the Public Forum any person may address the School Board on a topic of interest or concern. Listed below are the procedures.

1. Public Forum will follow the Procedural Items on the agenda.
2. Public Forum will be open up to 30 minutes (3 minutes per speaker, 10 minutes per topic, and no more than 3 speakers per topic as a general rule). Comments should be brief, and repetition of public comments already expressed at the same meeting should be avoided.
3. Those wishing to address the Board should fill out the Public Forum Speaker Card and submit the card to the School Board clerk or other district official at the meeting
4. Questions may be asked on any topic, including those on the agenda.
5. School District policy and data privacy laws preclude the Board from publicly discussing personnel matters or data, including information, which, if discussed in a public meeting could violate law or policy. Under School Board Policy 206, complaints or concerns regarding individual school district employees should be presented in writing to school administration and signed by the person submitting the complaint or concern.
6. An attempt will be made to answer questions addressed to the Board. In those cases where an answer is not provided, a phone call from an appropriate school district official will be made as a follow-up.

7. A handout on the purpose of School Board meetings and the meeting process is available at each School Board meeting.

8. Citizens may be asked to address the school board on a particular subject during the discussion of that item.

9. The School Board chairperson will attempt to reasonably honor requests to speak, but shall also exercise discretion with regard to time constraints and therefore may limit the number of requests to speak accordingly.





ISD 108 Promise to Voters









AGREEMENT

This Agreement (“Agreement”) is made this 27th day of March 2023, by and between Independent School District No. 108, Central Public Schools (“District”) and the City of Norwood Young America, Minnesota (“City”) (collectively referred to as “the Parties”).

WHEREAS, the District owns the properties identified as Carver County PID Nos. 580144130 and 580143800 (the “Property”);

WHEREAS, the Property contains a skate park, as shown in the attached Exhibit A (the “NYA Skate Park”), which contains a concrete slab, skating equipment, including ramps and jumps, and a chain link fence surrounding the concrete slab;

WHEREAS, the Parties approved a lease agreement dated July 9, 2001 (the “Lease”), whereby the City leased the NYA Skate Park portion of the Property from the District for a period of ten years;

WHEREAS, the Lease expired on or about July 31, 2011, and has not been renewed;

WHEREAS, the City has continued to operate the NYA Skate Park after the Lease expired;

WHEREAS, the City and District mutually desire to decommission the NYA Skate Park and have the City remove any City-owned equipment from the NYA Skate Park;

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is acknowledged by the parties:

1. **Removal of Equipment.** On or before May 1, 2023, the City shall, at its sole cost and expense, remove all ramps, jumps, and other equipment from the NYA Skate Park. In addition, the City shall, at its sole cost and expense, remove all signage for the NYA Skate Park.
2. **Fencing and Concrete Slab.** The City shall leave the fencing that surrounds the Skate Park. The City shall also leave the concrete slab on the Property. The District accepts the fencing and concrete slab in their as-is condition. The City makes no representations or warranties regarding the condition of the fencing or concrete slab.
3. **Decommission of NYA Skate Park.** On May 1, 2023, or the date that the City removes the equipment from the NYA Skate Park pursuant to Paragraph 1 of this Agreement, whichever date is earlier, the City shall have no further responsibilities with respect to the NYA Skate Park. Upon expiration of the City’s responsibilities with respect to the NYA Skate Park under this Paragraph, the District shall be solely responsible for all aspects of owning the portion of the Property located at the former NYA Skate Park.

4. **Entire Agreement.** This Agreement constitutes the entire agreement between the Parties with respect to the decommission of the NYA Skate Park. Neither the District nor the City have relied on any statements, promises, or representations that are not stated in this document.

5. **Headings.** The headings contained in this Agreement are included for purposes of convenience only and do not affect the meaning or interpretation of this Agreement.

WHEREFORE, the parties hereto have executed this Agreement on the respective dates set forth below. This Agreement will not take effect until approved by the District's School Board and signed by both parties.

WHEREAS Laws of 1957, Chapter 947, Article I, Sec. 2,
provides;

"School districts shall be classified as common, independent, special or associated districts, each of which is a public corporation. Each district shall be known by its classification and each shall be assigned a number by the commissioner so that its title will be school district number,", and,

WHEREAS Laws of 1957, Chapter 947, Article X, Sec. 1,
provides:

"Subdivision 1, As soon as practicable after the passage of this act, the commissioner of education shall, by order, assign an identification number to each district. The assignment shall be made so that each classified district has an identification number which is exclusive to it in its classification.

"Subd. 2. Upon making the assignment of an identification number, the commissioner of education shall forthwith notify the clerk of the district and the county auditors of the counties in which any part of the district lies of the identification number assigned. A certified copy of the order may be recorded in the office of the register of deeds to show the new legal name of the district.


"Subd. 3. From and after the making of the order, the legal identification of the district shall become and be as assigned. All records, correspondence, reports and references to the district shall thereafter refer to the district by its proper title as assigned.", and,

WHEREAS the commissioner of education, acting pursuant to and under the authority granted by the foregoing statutes, has assigned an identification number to each of said school districts as shown on and by Exhibit "A" which is attached hereto and made a part hereof by reference thereto;

NOW, THEREFORE, IT IS HEREBY ORDERED, under and by virtue of the authority granted by the aforesaid statutes, that said school districts, and each of them, shall be, and hereby are, assigned the respective identification number as shown on the attached Exhibit "A", and that from and after the date hereof shall be legally identified by said number so assigned.







WHEREAS on November 3, 2020 voters living within the Central Public School District No. 108 approved a bond referendum for the betterment of school facilities; and

WHEREAS the leadership of the school district provided extensive information to residents about the benefits of its facilities project, including [CLASSROOM, HEALTH, SECURITY AND EFFICIENCY] improvements; and

WHEREAS the school district obtained accurate estimates of project costs from licensed experts prior to approval of the referendum, including contingency funds in case of unforeseen events; and

WHEREAS the leadership of the school district shared these costs of the project and the projected tax impact with local property owners; and

WHEREAS prior to the referendum, the school district received a positive Review and Comment letter from the Minnesota Department of Education, the highest rating available, demonstrating that the project is educationally and financially advisable; and

WHEREAS the school district subsequently followed state law by publicly requesting construction bids for its facilities project, seeking to award contracts based on the lowest bids from qualified contractors; and

WHEREAS as the school district evaluated these bids, it determined that the facilities project was challenged by unprecedented construction inflation, exceeding 25% of pre-referendum estimates for some areas of the project; and

WHEREAS the school district has taken steps to refine the facilities project to respond to this unprecedented construction inflation, but has determined that further changes in project scope will threaten the goal of the betterment of school facilities in the manner that local voters understood;

WHEREAS the Minnesota Legislature has stepped up in the past when school districts have faced unusual circumstances beyond their control that have impacted the quality of their facilities.

THEREFORE BE IT RESOLVED that the elected members of the board of the Central Public School District No. 108 request that the Minnesota Legislature pass Senate File 2615 and House File 2917, assisting local school districts that were affected by unprecedented construction inflation.

Pursuant to due call and notice thereof a record meeting of the School Board of Independent School District No. 108 (Central Public Schools), Minnesota, was duly held on March 27, 2023, at 6:00 p.m, in the Central Elementary School Media Center, 655 SW 7th Street, Norwood Young America, MN 55368.

Member _____ introduced the following resolution and moved its adoption:

RESOLUTION APPROVING PROPERTY TAX ABATEMENT FOR CERTAIN PROPERTY LOCATED WITHIN THE JURISDICTION OF INDEPENDENT SCHOOL DISTRICT NO. 108 (CENTRAL PUBLIC SCHOOLS) AND PROVIDING FOR THE ISSUANCE AND SALE OF NOT TO EXCEED \$2,950,000 GENERAL OBLIGATION TAX ABATEMENT BONDS, SERIES 2023

BE IT RESOLVED by the School Board (the “**Board**”) of Independent School District No. 108 (Central Public Schools), State of Minnesota (the “**District**”), as follows:

Section 1. Recitals.

1.01. The District is considering granting a prospective property tax abatement (the “**Abatement**”) in order to help finance a portion of improvements intended to improve parking options at Central Public Schools through construction and improvements to parking lots at multiple school sites and facilities districtwide (the “**Project**”), all pursuant to Minnesota Statutes, Sections 469.1812 through 469.1815, as amended (the “**Act**”).

1.02. Pursuant to Section 469.1813, Subdivision 1 of the Act, if the benefits to the District of the proposed Abatement at least equal the costs to the District of the proposed Abatement, the Board may grant an abatement of all or a portion of the taxes imposed by the District on an affected parcel of property if it finds that doing so is in the public interest because it will help construct public facilities, or finance or provide for public infrastructure.

1.03. The District has identified 77 parcels located within the District, as described in Exhibit A hereto (the “**Abatement Property**”), which Abatement Property will be benefited by the Project and from which the District proposes to abate a portion of the District’s share

of taxes to help finance the Project, subject to all the terms and conditions of this Resolution and the Act.

1.04. The District intends to pay for the Project through the issuance its General Obligation Tax Abatement Bonds Series 2023, issued pursuant to the Act (the “**Bonds**”), in an original aggregate amount not to exceed of \$2,950,000, issued pursuant to the Abatement Act and Minnesota Statutes, Chapter 475, as amended (the “Municipal Bond Act”), the debt service on which is expected to be paid primarily through the collection of Abatement revenues.

1.05. Pursuant to a resolution adopted on February 27, 2023, this Board authorized the holding of a public hearing to consider approving the Abatement. The notice of public hearing was published in *News & Times*, a newspaper of general circulation in the District, on March 9, 2023. On the date hereof, this Board held and conducted a public hearing on the Abatement, at which the views of all interested persons were heard.

1.06. The District intends to secure the services of an independent municipal advisor to provide bond pricing opinion services for the purposes set forth in Minnesota Statutes, Section 475.60, Subdivision 2(9), as amended, and will therefore be authorized by Section 475.60, Subdivision 2(9) of the Municipal Bond Act to negotiate the sale of the Bonds.

Section 2. Findings.

2.01. This Board finds and determines that the public benefits to the District from the Abatement will be at least equal to the costs to the District of the Abatement, because (a) the Abatement will help finance the Project which will result in the construction of public infrastructure within the District, (b) the Project will provide access to services for residents within the District and (c) the Abatement Property is not and will not be located in a tax increment financing district during the Abatement period and does not include real or personal property that is subject to valuation under Minnesota Rules, Chapter 8100.

2.02. This Board finds and determines that the Abatement is in the public interest and confers public benefits for the reasons described in Section 2.01 hereof.

2.03. This Board also finds it is necessary and expedient to the sound financial management of the District that the District issue the Bonds, in an aggregate principal amount not to exceed \$2,950,000, pursuant to the Act and Minnesota Statutes, Section 475 (the “Municipal Bond Act”), to provide financing for the Project.

Section 3. Actions Ratified; Abatement Approved.

3.01. This Board ratifies all actions of the District's staff and consultants in arranging for approval of this Resolution in accordance with the Act.

3.02. Subject to the provisions of the Act, the Abatement is approved and adopted subject to the following terms and conditions:

(a) The term “**Abatement**” is further defined to mean the District's share of the real property taxes generated from the Abatement Property, in the amounts described in this Section:

(i) The aggregate Abatement paid by the District during the term of this Resolution will not exceed the amount necessary to pay 105% of the principal on the Bonds, up to a maximum of \$3,097,500.

(ii) Notwithstanding anything to the contrary herein, the Abatement payable in any year will not exceed the amount produced by extending the District’s total local tax rate for the applicable year against the total net tax capacity of the Abatement Property, determined as of January 2 in the prior year.

(iii) In accordance with Section 469.1813, Subdivision 8 of the Act, in no year shall the Abatement, together with all other abatements approved by the District under the Act and paid in that year, exceed the greater of 10% of the District's net tax capacity for that year or \$200,000 (the “**Abatement Limit**”). The District may grant other abatements permitted under the Act after the date of this resolution, provided that to the extent the total abatements in any year exceed the Abatement Limit the allocation of the Abatement Limit to such other abatements is subordinate to the Abatement granted by this resolution.

(b) The District will pay the Abatement solely to finance the Project, through application of Abatement amounts toward the principal of the Bonds at the maturity of each Bond.

(c) This Resolution may be modified only with the prior written approval of this Board, and any modification is subject to Section 469.1813, Subdivision 7 and Section 469.1814, Subdivision 4 of the Act.

(d) In accordance with Section 469.1815 of the Act, the District will add to its levy in each year during the term of the Abatement the total estimated amount of current year Abatement revenues granted under this Resolution.

(e) The Abatement shall be subject to all the terms and limitations of the Act.

3.03. The Superintendent, Business Manager, Treasurer or any school board member of the District are authorized and directed to execute and deliver any agreements, certificates or other documents that the District determines are necessary to implement this Resolution and issue the Bonds.

Section 4. Bond Authorization; Sale of the Bonds.

4.01. In accordance with the Constitution and laws of the State of Minnesota, including but not limited to the Act, the Board hereby authorizes the issuance of the Bonds, pursuant to the Act and the Municipal Bond Act, for the purpose of providing funds for the Project and to pledge

the District's full faith and credit and power to levy direct ad valorem taxes and the Abatements to pay the interest of and principal of the Bonds.

4.02. The Board desires to proceed with the sale of the Bonds by direct negotiation with Robert W. Baird & Co., Incorporated, as purchaser or underwriter thereof (the "**Baird**"). Baird intends to purchase the Bonds in an arm's-length commercial transaction with the District. The District's Superintendent or Business Manager and a School Board officer are hereby authorized to approve the sale of the Bonds in an aggregate amount not to exceed \$2,950,000 and to execute a Bond Purchase Agreement with Baird for the purchase of the Bonds, provided the true interest cost (TIC) thereof does not exceed 4.75% per annum and the final maturity does not extend beyond February 1, 2038.

Section 5. Minnesota School District Credit Enhancement Program.

5.01. (a) The District hereby covenants and obligates the District to be bound by and to use the provisions of Minnesota Statutes, Section 126C.55 (the "**Credit Enhancement Act**") to guarantee payment of the principal of, the premium, if any, and the interest on the Bonds when due. The District shall comply with all procedures now or hereafter established by the Minnesota Department of Management and Budget and the Minnesota Department of Education pursuant to subdivision 2(c) of the Credit Enhancement Act and to take such actions as necessary to comply with the Credit Enhancement Act. The Chair of the Board, the Clerk of the District, and the superintendent and the business manager of the District are each authorized to execute any applicable forms of the Minnesota Department of Management and Budget or the Minnesota Department of Education. The Board understands and acknowledges that the provisions of the Credit Enhancement Act shall be binding on the District as long as any Bonds are outstanding.

(b) The District further covenants to deposit with any registrar and paying agent for the Bonds (the "**Registrar**"), at least three (3) business days prior to the date on which any payment of principal of, premium, if any, or interest on the Bonds is due, an amount sufficient to pay such payment or to notify the Commissioner of Education that it will be unable to make all or a portion of that payment. If the District believes it may be unable to pay the principal of, the premium, if any or the interest on the Bonds on the date any such payment is due, the District shall notify the Commissioner of the Department of Education as soon as possible, but not less than 15 business days before the date such payment is due. The District shall authorize and direct the Registrar to notify the Commissioner of the Department of Education if (i) the Registrar becomes aware of a potential payment default with respect to the Bonds or (ii) two (2) business days prior to the date a payment is due on the Bonds the Registrar does not have sufficient funds to make the payment due on such date.

Section 6. Adoption of Ratifying Resolution.

6.01. Upon approval of the sale of the Bonds by the parties described in Section 4 hereof under the parameters set forth in Section 4 hereof, this Board will take action at its next regularly scheduled meeting or a special meeting thereafter to adopt the necessary ratifying resolution, as prepared by Kutak Rock LLP, Bond Counsel to the District. The exact form, specifications and provisions for repayment of the Bonds shall be set forth in a subsequent resolution of the Board.

Section 7. Expiration of Authority.

7.01. If the parties described in Section 4 hereof have not approved the sale of the Bonds to the Purchaser and executed a Bond Purchase Agreement by December 31, 2023, this authority granted in this Resolution shall expire and be of no further force and effect.













- All employees must be paid during E-learning days

- Session ends May 22, 2023
