PUBLIC PARTICIPATION AT BOARD MEETINGS; MEETING RULES

Adopted: September 14, 2021

Revised: November 19, 2024

The Board desires to hear the views of citizens of the District and welcomes public comments at business meetings. Public comments at work sessions or special meetings will not be allowed unless otherwise delineated on the meeting agenda. To ensure the safety, security, and orderly conduct at Board meetings all participants must adhere to these rules and any additional instructions provided by security personnel or meeting facilitators.

Eligibility and priority to address the Board: To ensure the students are prioritized and heard, the Board will allow students to speak first during the public comment portion of the meetings. Students wishing to address the Board must sign up and will be called in the order of registration before other community members.

Process/Procedure:

1. Individuals wishing to address the Board must sign up and will be called in the order of registration.
2. Comments will be limited to agenda item(s).
3. The public comment portion will be limited to 60 minutes unless the Board votes to extend the time. If additional time is approved, it will be at the discretion of the Board and based on the circumstances of the meeting.
4. Each speaker will be allotted up to three minutes to address the Board during public comment. If there are a large number of individuals signed up to speak, the Board reserves the right to reduce the time per speaker to ensure that as many voices are heard within the allotted comment period. If time constraints prevent all individuals from speaking during the public comment period, the Board encourages those unable to address the Board in person to submit their input via emails, written letters, or other formats. All submitted comments will be reviewed by the Board.
5. Speakers should not repeat the same message shared by others. If a speaker's point has already been addressed, comment briefly in support of previous comments and provide any other unique insights.

Prohibited Items: For security purposes, attendees may not bring bags into the meeting room. This includes, but is not limited to: backpacks, purses larger than a clutch, and tote bags. Exceptions will be made for medically necessary items or diaper bags, which are subject to inspection. Employees who are required to attend and work during the meeting are exempt from the bag policy but may be subject to standard security procedures.

Orderly Conduct:

1. All speakers and attendees are expected to maintain respectful and proper decorum during Board meetings.
2. Comments shall be directed to the Board as a whole and not an individual member, staff, or other attendees.
3. Personal attacks, threats, shouting, cheering, snapping, and other distractions or disruptive behavior, will not be tolerated.
4. Clapping after a comment may be allowed unless it is disrespectful or disrupts the flow of the meeting. Attendees are encouraged to keep expressions of support by clapping brief. If attendees disregard this expectation, the Board may temporarily pause the meeting to restore order or remove individuals causing the disruptions.
5. All comments must be age-appropriate, to include kindergarten through twelfth grade, and suitable for a school setting. Speakers are expected to use language and share content that is respectful and appropriate for all ages.
6. Comments containing profanity, vulgarity, or otherwise inappropriate material will not be permitted.
7. Attendees may not bring signs, banners, props, or other similar items/materials into the meeting. Any individual wishing to display any of the items referenced, or demonstrate, should do so in appropriate spaces outside of the meeting room, in compliance with District policies.
8. Media representatives wishing to record the Board meeting will be assigned a designated location to ensure their activities do not disrupt the proceedings or obstruct the view of attendees. All recording equipment must remain within the assigned area for the duration of the meeting.

Enforcement of Meeting Rules: Individuals who fail to follow the established rules for public comments or meeting decorum will receive a warning. If the disruptive behavior continues after the warning, the individual may be removed from the meeting. Repeated violations may result in a ban from attending future meetings as determined by the Board.

The D51 Phoenix Girl's Wrestling Team achieved a historic milestone last month, competing in the 2025 Class 5A Colorado State Girls Wrestling Championship and bringing home the state title!

Under the strong leadership of head coach Chad Dare, the D51 Phoenix Girls Wrestling Team hit the mats with depth, determination, and impressive talent. They clinched the state title despite not having an individual champion, a true testament to the team's overall strength and consistency.

Eight wrestlers placed in the top five of their weight classes, including standout performances by Shylee Tuzon and Claris McCoy, who both finished as state runners-up at 155 and 170 pounds and Violet Gray, who secured 3rd place at 130 pounds.

This marks the first-ever state wrestling title for the program—a well-earned award for the hard work, perseverance, and grit these student-athletes have shown over the past few seasons. Their success reflects not only the growth of girls wrestling in Colorado but also the high bar this team has set for the future.

As a 5'9" point and shooting guard, Olivia has been a key player for the Wildcats throughout her high school career. She hit a major milestone this season by scoring her 1,000th career point during a win over Denver North, where she put up 19 points. Over 95 varsity games, she's averaged nearly 13 points, 4 rebounds, 2 assists, and 3 steals per game. Her leadership, hustle, and consistent play have made a significant impact on the team's success and reflect the core beliefs we celebrate here in D51.

Since taking over as head coach in June 2022, Jeff Johnson has made a big impact on the FMHS girls' basketball program. Revisiting Secondary Early Release

Clear and comprehensive Early Release plans were developed in the spring of 2023. However, these plans were placed on hold due to:

- The emergence of data in January 2023 which suggested that declining enrollment needed immediate prioritization
 - The closure of East Middle School & Fruita 8/9
 - The need to develop a viable response to declining enrollment (EDEC and A&M)
- While we continue to navigate the challenges of budget and enrollment, the need for **consistent and coherent** professional learning at secondary continues to be evident

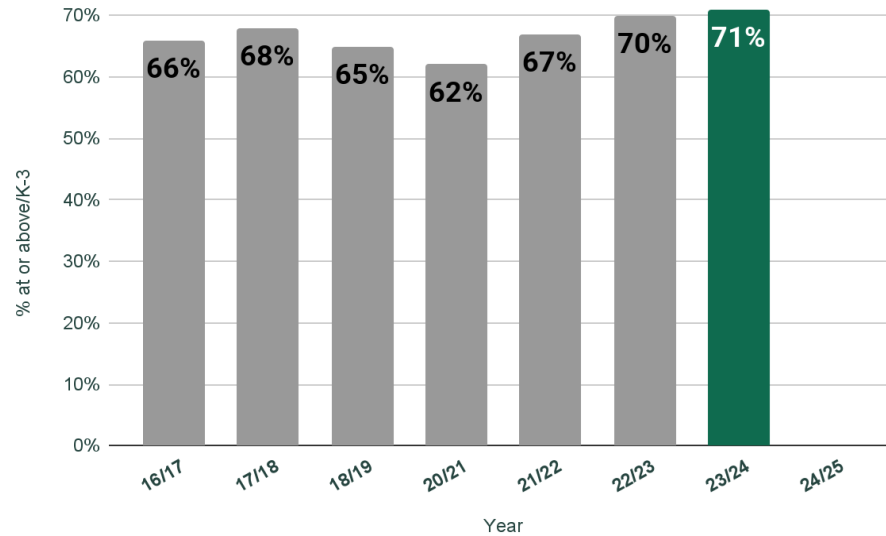

K-3 DIBELS Percent At and Above Benchmark EOY 23/24

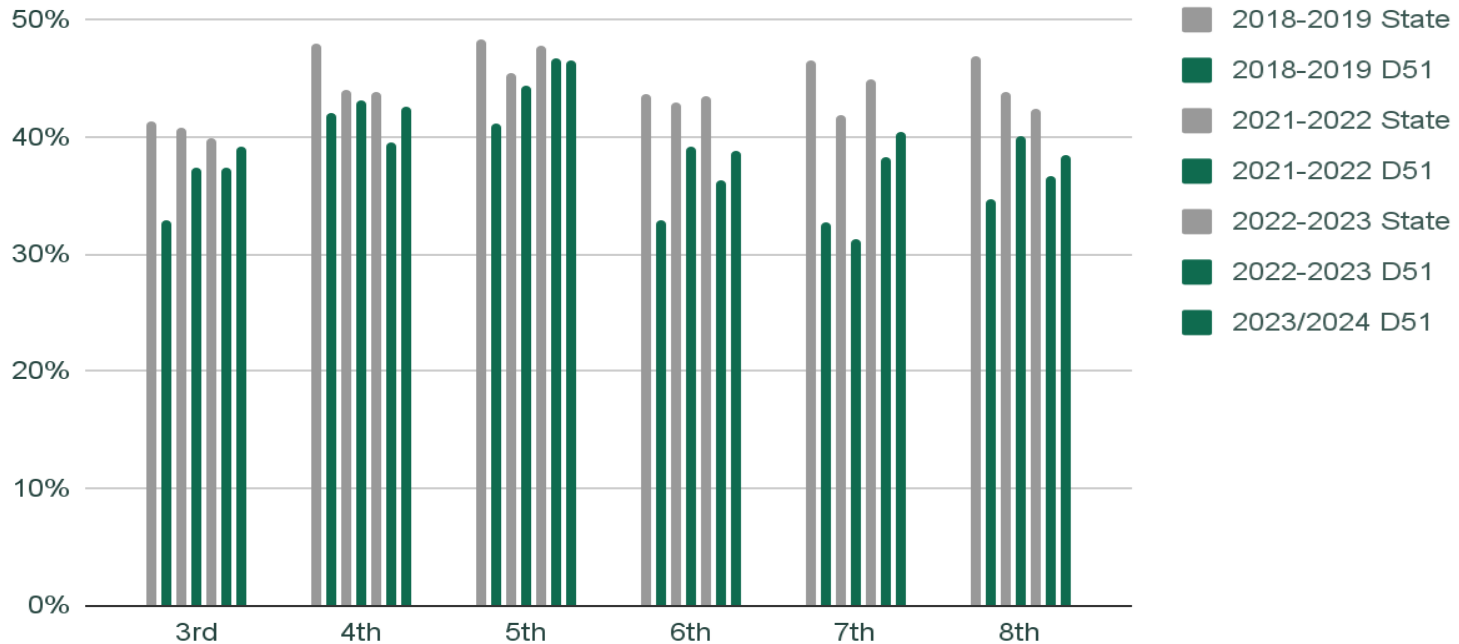

Consistent and Coherent Professional Learning:

- Focuses on desired student outcomes
- Is sustained with a regular and frequent cadence
- Is relevant to educator and school practices and goals
- Involves feedback to teams and individual educators
- Is empowered by collaboration

Early Release Leadership Study Group

Studied the concept or idea of a D51 K-12 weekly Friday early release by...

- Developing a shared vision and outcomes in alignment with D51 Strategic Plan priorities
- Studying and developing models and designs that balance school context and district Strategic Plan priorities
- Considering the logistical elements and implications of moving to a system-wide early release

Getting Clear on “Must Have” Elements & Considerations

- Each school must have an explicit MTSS focus/ process/protocols as one recurring element
- LCplanning time needs to be guided and outcome based
- Not in place of master schedule common plan/ LCtime
- Monthly/Weekly Cadence Outline shared with Site Director and PL Office
- One “District Friday” per month to lift STRIVE and other Strategic Plan aligned professional learning (NEW)

Study of Early Release in 2023 across Colorado large districts Found that most districts have some form of Early Release...

- Large variability in frequency and format
- Some links to district Professional Learning (PL) days
- Many medium to smaller districts have a four day week with a PL focus on the 5th day
- High performing networks of schools, such as DSST or STRIVE almost always have this structure

- ◆ First Quarter PD: We evaluated what a cycle could look like
 - ◆ Give the common Assessment (IA)
 - ◆ Grade norm
 - ◆ Grade the assessment
 - ◆ Create the data
 - ◆ Look over the data to see what you notice
 - ◆ How do we adjust after noticing the data
- ◆ 2nd Quarter PD: Modeled what Rigor looked like through critical thinking vs giving students a lot of work
 - ◆ Had staff look at a historical picture
 - ◆ 1st level, Evaluating facts
 - ◆ 2nd level, Exploring structure
 - ◆ 3rd level, Analyzing context
 - ◆ Evaluating Concepts/Transfer

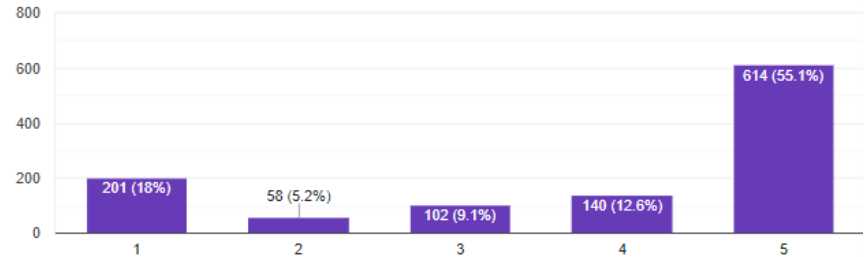
Support for Secondary Early Release: Parent and Community Input

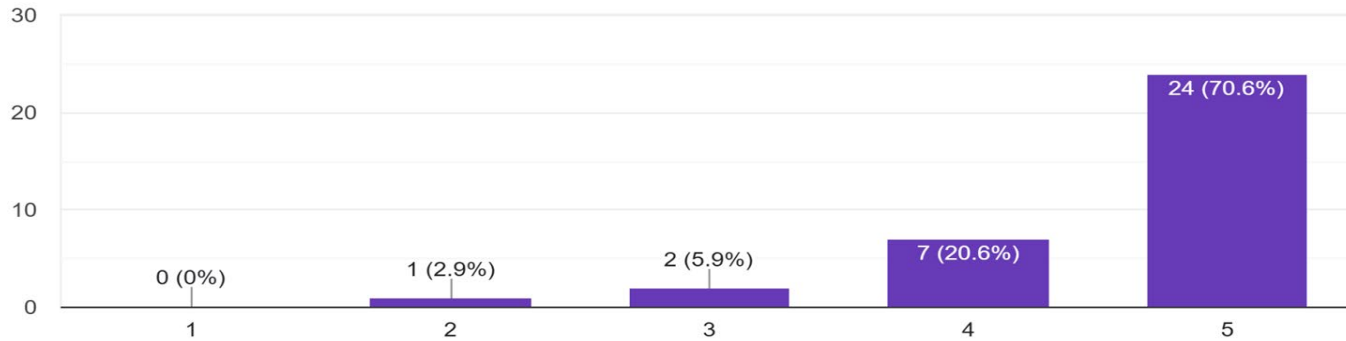

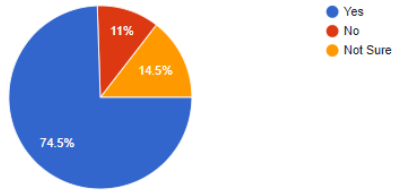

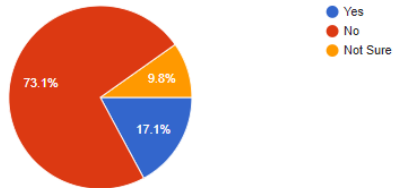

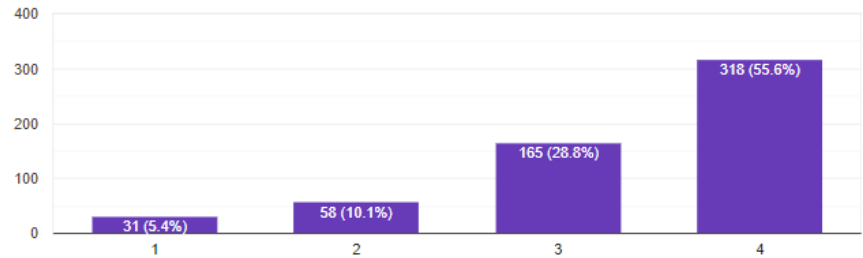

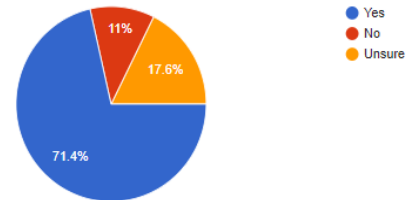
