**MINUTES AND RESOLUTION AUTHORIZING SALE OF BONDS**

The Board of Education of Elementary School District Number 29 of Oklahoma County, Oklahoma, met in Special Session at the Auditorium, Fine Arts Building, Oakdale Public Schools, 5701 E Hefner Rd, Oklahoma City, Oklahoma, in said School District on the 13th day of February, 2024, at 5:50 o'clock p.m.

Notice of this special meeting was given in writing to the County Clerk of Oklahoma County, Oklahoma at 3:00 o'clock p.m. on the 12th day of January, 2024, forty-eight (48) hours or more prior to this meeting, and public notice of this meeting, setting forth the date, time, place and agenda was posted on the south (Main) entrance of the school and the Kim Lanier Fine Arts Building, in prominent view and open to the public twenty-four (24) hours each day, seven (7) days each week at 3:00 o'clock p.m. on the 5th day of February, 2024, being twenty-four (24) hours or more prior to this meeting, excluding Saturdays, Sundays, and State designated legal holidays, all in compliance with the Oklahoma Open Meeting Act (as attached hereto).

A resolution fixing the amount of bonds to mature each year, fixing the time and place the bonds are to be sold, and authorizing the clerk to give notice of said sale as required by law.

Whereas, the issuance of \$11,755,000 of General Obligation Building Bonds by Elementary School District Number 29 of Oklahoma County, Oklahoma, has been duly authorized at an election held for that purpose;

Now, therefore, be it resolved by the Board of Education of Elementary School District Number 29 of Oklahoma County, Oklahoma:

SECTION 1.

That the \$11,755,000 of General Obligation Building Bonds of Elementary School District Number 29 of Oklahoma County, Oklahoma, voted on the 9th day of January, 2024, shall be offered for sale at the Auditorium, Fine Arts Building, Oakdale Public Schools, 5701 E Hefner Rd, Oklahoma City, Oklahoma, on the 14th day of March, 2024, at 11:30 o'clock a.m.; said Bonds to become due:

\$3,755,000 in two years from their date, and \$4,000,000 annually each year thereafter until paid.

That the Clerk of the Board of Education is hereby ordered and directed to cause notice of the sale of said Bonds to be given as required by law.
