**MINUTES OF BOARD OF EDUCATION MEETING**  
August 22, 2023

The Board of Education of Jordan School District met in study, general, and closed sessions on Tuesday, August 22, 2023, beginning at 4:02 p.m. at JATC South (Board Conference Room), 12723 S. Park Avenue (2080 West), Riverton, Utah. The sessions were also provided electronically via YouTube.

President Miller presided and conducted. The Board of Education met in a study session to discuss the following:

**A. 2024 Summer Capital Projects**

President Miller said this agenda item would be discussed after item B *Title III Policy Update*, as two Board members had not arrived yet.

**B. Title III Policy Update**

Associate Superintendent Michael Anderson gave a brief history of Title III, noting it aims to ensure that all English Language Learners attain English proficiency and develop high levels of academic achievement. He said part of the Title III funding requires the District to have a policy in place, and he invited Michelle Love-Day, director of Equity & Compliance, to share more information about the development of this draft policy which was shared with the Board.

Ms. Love-Day said House Bill 302 *Educational Language Service Amendment* requires English Language Learners (ELL) and their parents to be offered services through the school district. This administrative policy uses Title III funding to provide language services. Ms. Love-Day said the District currently services 4500 language learners and additional funding was received this year to accommodate increasing students due to a large influx of immigrants and refugees. She highlighted other District services that have been provided to these families, including summer school for credit recovery, the District job fair, and Jordan Education Foundation resources.

President Miller said this will be placed on the September 12, 2023 study session agenda for further discussion, with a potential vote on September 26, 2023.

Bryce Dunford arrived at 4:19 p.m. and joined the meeting in progress.

**A. 2024 Summer Capital Projects**

A draft of 2023-24 potential summer projects, including estimated costs for each, was shared with Board members. President Miller explained the process for determining which projects would be a priority for the Board next summer and Board members asked for an update on 2022-23 summer projects.

Lisa Dean expressed appreciation for the work done on the parking lot at West Jordan High School and Mr. Thomas and Mr. Rostrom reported on Bingham High School's gym/bleachers and Valley High School's office remodel. Mr. Robinson praised the work of the Auxiliary Services department and the way the Facility Services department maintains District property.

After discussion about a few of the listed projects, President Miller asked Bryce Dunford, Finance Committee Chair, to discuss the amount of funding available for summer capital projects.

Niki George arrived at 4:27 p.m. and joined the meeting in progress.

Mr. Dunford reported the Finance Committee reviewed the projected 2024-25 budget. He said the committee wants to increase the emergency funds reserve to ensure there would be sufficient funds to construct a new elementary school if needed. In an effort to increase Board reserve funds and compensate for overspending on summer projects the past two years, the committee recommends between \$10 million to \$12 million be allocated to 2024 summer projects.

Following the discussion, Board members indicated their preference for which projects should move forward in obtaining bids for architectural design. The projects were ranked by Board members in order of personal priority with the lowest sum totals determining which projects should be added to the 2024 summer project list until a budget threshold of approximately \$13 million was met. This process resulted in circled items D, F, H, J, U, N and X being deemed as the highest priority. (see attachment 1)

**MOTION:** It was moved by Bryce Dunford and seconded by Niki George to approve the circled summer projects to go out for architectural design.

**AMENDED**

**MOTION:** It was moved by Brian Barnett and seconded by Darrell Robinson to amend the current motion to include items O (grease interceptor only) and E to move forward in the architectural design phase. The other items listed with O may be included as bid alternates.

President Miller called for a vote on the amended motion and it was approved by a vote of five to two, with Mr. Dunford and Ms. George casting the dissenting votes.

President Miller called for a vote on the original motion by Mr. Dunford with the addition of items O and E. The motion was approved by a vote of six to one. Ms. George cast the dissenting vote.

President Miller called for a brief closed session prior to the general session.

President Miller presided and conducted. She welcomed those present. Brad Sorensen, Administrator of Schools, led everyone in the Pledge of Allegiance and offered Reverence.

### **Resolutions of Appreciation**

Marilyn Richards read a Resolution of Appreciation for Robyn Smith, who recently passed away. Ms. Smith was employed by Jordan School District from 2008 to 2022.

### **Recognitions by Board Members**

Lisa Dean said the new West Jordan High School parking lot is beautiful. She thanked Facility Services for their work.

Darrell Robinson thanked Facility Services for their efforts to keep District schools running smoothly and looking good. He also expressed appreciation for the Transportation department and acknowledged Auxiliary Services Administrator Scott Thomas for his efforts to repair a community member's fence in Herriman during inclement weather. Mr. Robinson attended a State event at Jordan's virtual academy and several Back to School Nights. He expressed appreciation for school counselors who provide options for students to meet their needs.

President Miller attended the Utah Teachers Fellows Capstone event and congratulated Jordan School District's three new members of the cohorts: Brenda Straley, Kelli Cannon, and William Shields. She recognized those that helped in the Bluffdale parade, saying it was great. Ms. Miller attended the new teacher welcome event and thanked everyone who contributed. She also took the opportunity to join FFA students at a Bastian Ag Center event.

### **Superintendent's Recognitions**

Dr. Godfrey recognized Carolyn Gough and the Teaching & Learning staff for their efforts in providing a very successful teacher Professional Development Day. He explained that it was the equivalent of three national conferences and included 13 strands with breakout sessions, and content specific to grade level and subject. He thanked those who organized the event and Board members for their support.

#### **I. Public Comments**

##### **A. Comments by Elected Officials**

No mayors or elected officials were in attendance at this time.

##### **B. Patron Comments Regarding Non-Agenda Items**

Kirby Croyle, League of Women Voters, explained that she is associated with the LWV observer corps. She thanked the Board for their service and introduced her colleague, Molly Briscoe.

Molly Briscoe, League of Women Voters, introduced herself as the LWV observer for Jordan School District.

Cindy Mitchell, a librarian at South Jordan Middle School, thanked the Board for their support. She said parents should help their children choose what to read which will foster healthy communication about books.

Jennifer Fullmer, a parent, said her children have had great experiences in the District, but expressed concern about pornographic materials in schools.

Steven Burt, a parent and employee, asked the Board to act consistent with the First Amendment and view books as a whole. He said Jordan District has inspired his love of reading and he wants the same for his children.

Shawn Mathis, a parent, said he is concerned about some inappropriate books in schools and asked the Board to change what they are doing with book reviews.

Esther Bennett, a parent, said she is deeply concerned about harmful reading material in schools. She said she appreciates teachers who provide parents with a syllabus to ensure students aren't reading harmful materials.

Angela Hussey, a parent, said she believes the controversial issues polity is not working, is unclear, and is not being followed.

Nicole Christofferson, a parent, said the book review process and policies are flawed.

Robyn Barnhill, a parent, expressed concern about pornographic reading materials in schools. She believes the Literature Review Committee is not fairly reviewing books.

**A. Comments by Elected Officials**

Seeing an elected official in attendance, President Miller asked Representative Ken Ivory if he would like to take the opportunity to speak. He accepted the invitation and supplied the Board with a few handouts. He read a statement from Riverton Mayor Trent Staggs and asked the Board to follow House Bill 374 and immediately remove all inappropriate materials in schools throughout the District.

President Miller noted Board members have had multiple interactions with elected officials regarding sensitive material in schools. As a District and Board, they take very seriously the responsibility to provide a safe and appropriate learning environment for students. Last year policy *AA424 Literature Selection and Review* was updated to reflect changes in the law and the Board assigned an ad hoc committee to further review the policy and recommend further revisions. She said there will be ample opportunity for public input on future proposed changes and the Board looks forward to continuing to work with legislators on this issue.

Written comments were not read in the meeting, however they were emailed to Board members afterward.

President Miller said this litigation was filed in 2017 and involves multiple school districts. A settlement has been reached which requires a vote of approval in a public meeting. She noted that Jordan School District has taken significant steps in the past few years to address girls' interest in new sports and will continue in this effort.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

**MOTION:** It was moved by Darrell Robinson and seconded by Marilyn Richards to approve Universal Settlement and Release of All Claims in Girls Football Litigation. The motion passed with a unanimous vote.

V. **Information Items**

A. **Superintendent's Report**

Dr. Godfrey thanked the Communications department for their hard work in highlighting the positive things happening in the District. There have been many positive stories in the news recently celebrating Jordan schools and employees, and the Superintendent said he will send Board members a summary of these news reports.

VI. **Discussion Items**

A. **Committee Reports and Comments by Board Members**

Marilyn Richards attended a full-day meeting for Utah High School Activities Association. She said she will send information from this meeting to all Board members.

Lisa Dean felt the need to clarify Jordan "values" mentioned at the last Board meeting. She said she feels the District values diversity of students and families in each community and that everyone has a place in Jordan School District. She also mentioned that there will be a celebration of American Founders and Constitution Month at the State Capitol rotunda on August 31, 2023 at 9:45 a.m.

Niki George said the Government Relations Committee would like to meet with State representatives before they go into the legislative session. The committee proposes holding three separate meetings with legislators at District schools within the areas they represent. She gave the following suggested dates: October 4, 6, 10, or 12, 2023 and said the meetings could be held from 8:00-9:30 a.m. Board members agreed with this suggestion and Ms. George said she will coordinate dates and places with Board members, administration, and legislators.

Brian Barnett expressed concern about the District possibly being overcharged for work provided by external companies and said he would like to find ways to save District funds. He proposed the following:

- 1) Revise the bid process to include more details required in bid proposals.
- 2) Work to make the District more independent – explore options for contracting work with District employees rather than independent contractors.
- 3) Ask the Board's internal auditor to make recommendations for ways the District can "trim the fat."

Board members gave feedback on these suggestions and Scott Thomas was invited to speak about contracted work in the District. He noted that Jordan already has in-house contractors for a wide-variety of projects, including: electricians, general trades, roofing, landscaping, plumbing, electrical, audio-visual, and HVAC and that over 2500 work orders are completed each month by these employees. He said the District ensures outside contractors are bonded, qualified, and certified.

Mr. Dunford said that once the Board secures an internal auditor, the Finance Committee will add Mr. Barnett's suggestions to the committee meeting agenda.

President Miller gave a reminder about the USBA Pre-delegate Assembly on August 25, 2023 and the Delegate Assembly on August 26, 2023 where the following three Board members will vote: Ms. George, Mr. Barnett, and Ms. Miller. President Miller said she recently met with Congressman Burgess Owen's staff at a retreat to discuss ways Congress can support education. She also noted the survey regarding Portrait of a Graduate Strategic Plan was launched this week. Employees, parents, and community members are invited to participate.

Dr. Godfrey said the literature review committees are being formed and trained. He said hundreds of people have responded to the request to be a part of this ongoing process.

President Miller presided and conducted. The Board of Education met in a study session to discuss the following:

**A. Portrait of a Graduate Strategic Plan Project Committee Report**

President Miller recognized Carolyn Gough, Administrator of Teaching & Learning, for all her efforts on Portrait of a Graduate.

Niki George, Board First Vice President, shared the Strategic Planning Timeline, and reported that the committee has been busy with community engagement activities, including a survey and focus groups. She mentioned that the Steering Committee has been selected and will review the estimated 20,000 survey responses on September 21, 2023. Ms. George noted that Education Elements will disaggregate the information and the District will be given access to the data for further review. Initial results from survey questions were included on BoardDocs.

Carolyn Gough, Administrator of Teaching & Learning, explained that the Steering Committee is comprised of twenty individuals, including: administrators, teachers, classified staff, parents, individuals with no children in the District, and two students,.

Dr. Godfrey thanked Ms. Gough and said both she and Education Elements have done a great job to help facilitate focus groups and move this project forward.

Mr. Dunford arrived at 4:22 p.m. and joined the meeting in progress.

**B. Review of Proposed Title III Policy**

Associate Superintendent Michael Anderson asked if this agenda item could be addressed later in the meeting as Ms. Love-Day had not arrived yet. President Miller accommodated this request.

**C. Special Education Proposed Revisions to Policies and Procedures Manual**

Lisa Robinson, Administrator of Schools, said revisions have been made to the USBE Special Education Rules – Policy and Procedures Manual. This requires updates to Jordan Special Education manuals to align with the changes. She shared a draft outlining the areas of change and invited Kim Lloyd, Director of Special Education, to give further explanation.

Ms. Lloyd said the major components include updated definitions and identification categories. She noted the biggest change was an update to the Developmental Delay category of identification which changes the age range to three through eight, rather than the three through seven formerly designated. She requested the proposed Special Education revisions be included on the next Board meeting agenda for a vote. Board members agreed to include this on the agenda for the September 26, 2023 session.

Ms. Lloyd thanked the Board for the additional Special Education funding which allowed for a salary increase for paraprofessionals and additional hiring to address Special Education needs.

**D. Dual Language Immersion (DLI) Rules**

Dr. Godfrey said this item is being brought to the Board because there is a need to bring balance to class sizes and reflect on the DLI process used in other districts.

Carolyn Gough introduced Kaye Rizzuto, Dual Language Immersion consultant, and invited her to present information that would benefit the DLI program and students.

Ms. Rizzuto said there are ten elementary schools, nine middle schools, and five high schools that currently house DLI programs. She said the first grade programs are full, with the exception of a few Chinese programs. However, she indicated that some DLI schools are experiencing a decline in overall student enrollment which directly affects programming.

Ms. Rizzuto shared ways Jordan and other districts select participants, including: siblings of current DLI students, boundary students, out of boundary students, District heritage speakers, or a student lottery process. She proposed school flexibility in how DLI students are selected to allow for a more sustainable districtwide program. She explained that the school would work with its local School Community Council to determine priorities used in placing students in the program.

Dr. Godfrey explained how DLI programs are established in schools, noting the School Community Council initiates the process with a letter to the Board expressing interest. After the community is surveyed, the proposal goes to the State for approval and determination of which language will be taught.

Ms. George suggested it be mandatory that each school accept a certain number of out of boundary students into the DLI program. However, the Board approved flexibility in allocating slots for the DLI programs on a school-by-school basis, with priority being given to siblings, and guidance from the area Administrator of Schools.

**B. Review of Proposed Title III Policy**

Seeing Michelle Love-Day, Director of Equity & Compliance, had arrived, President Miller invited Dr. Anderson and Ms. Love-Day to begin a review of agenda Item B, regarding Title III policy.

Dr. Anderson said State law requires a District policy be in place for English Language Learners to attain English proficiency in order to qualify for funding. Ms. Love-Day shared a draft of the policy, noting that since the last Board meeting there were only two minor wording changes.

Mr. Dunford asked if the department is “stretched too thin” with the growing language needs in the District. Ms. Love-Day said the State is watching Jordan’s growth and has allocated appropriate funding. She said the department encourages teachers to become ESL endorsed and informs them of professional development opportunities.

The Board agreed with placing this item on the September 26, 2023 business meeting agenda for a vote.

**E. Legislative Priorities**

Niki George reported the Government Relations Committee met recently and developed a list of legislative priorities, which she shared on BoardDocs. She asked Board members to review the top five priorities listed as follows and rank their top three on the list:

- 1) Literature selection: focus on how books are admitted into, rather than eliminated from schools
- 2) Fully funding Special Education
- 3) Add inflation to property taxes so we can support referendum legislation
- 4) Competitive pay through WPU increases
- 5) Funding for counselors and behavior specialists

Board members also suggested another item be placed on the list: High growth impact fees being allocated to the District.

Mr. Robinson arrived at 6:03 p.m. and joined the meeting in progress.

Ms. George said the aforementioned priorities will be discussed in small meetings with legislators scheduled in early October 2023. The annual breakfast with legislators will be held December 6, 2023 at a school location yet to be determined.

**F. Discussion on Board Newsletter**

Darrell Robinson, Board Second Vice President, said he would like to move forward on developing a Board newsletter which could share information to patrons from the superintendent, schools, District departments, and the Board of Education.

The Board decided to produce a digital newsletter which patrons could opt-in to receive. It was decided to form an ad hoc committee which will explore options for the newsletter. President Miller invited Board members to contact the Executive Committee if they are interested in being on the committee.

**G. Review of Utah School Board Association (USBA) Leadership Academy 2023**

President Miller invited the four participating Board members and Superintendent Godfrey to share what impacted them at the recent USBA Leadership Academy. The comments were positive and supportive of the Academy.

Board members reported that the District Communications department presentation was very well received and President Miller noted the department has been asked to present at the National School Board Association (NSBA) Conference again this year.

#### H. **Board and Superintendent Reports and Comments**

Bryce Dunford, Finance Committee Chair, said they will be meeting next week. He invited Mr. Barnett to share what he learned at the recent South Jordan Redevelopment Agency (RDA) meeting.

Mr. Barnett said the meeting was well-run and efficient. Brian Preece, director of City Commerce in South Jordan, spoke briefly about approximately 12-20 projects and how they affect taxing entities. Mr. Barnett said Jordan's business administrator, John Larsen, is well respected among the group.

Niki George reported the Government Relations Committee met recently with Representative Stenquist and discussed the political neutrality bill he is sponsoring.

Lisa Dean met with the Jordan Ethnic Advisory Committee (JEAC) recently and discussed a recent conference they attended. Her husband and daughter went to the Language & Culture Services Fall Family Fair and said it was a great event.

Darrell Robinson requested a time for the Jordan Parent Advisory Committee (JPAC) to meet. It was determined the meeting will take place November 7 at 5:00 p.m. He asked Board members to contact him with suggestions on possible topics to discuss.

Mr. Dunford, Licensed Employee Advisory Committee (LEAC) Chair, proposed that all LEAC members elected last year for their first tenure be retained and all others replaced with new representative through school elections. Board members agreed with this suggestion and topics for the first meeting will be discussed at the next Board study session.

President Miller thanked all who attended the Delegate Assembly. She announced next year's Delegate Assembly will be held June 7 and 8, 2024 and gave a reminder about two other calendared events: Jordan Education Foundation's Economic Summit on September 28, 2023 at JATC South, and the USBA Fall regional meeting on September 27, 2023 at the USBA office.

Mr. Dunford requested and was given permission to accompany Superintendent Godfrey to Cupertino, California for one day in November to explore the possibilities that are available through Apple for virtual instruction in general classrooms and to discuss school needs that might help develop better tools in the future.

The Board also gave permission to Tracy Miller to attend the ExcelinEd National Summit on Education held November 15 through 17, 2023 in Atlanta, Georgia.

Superintendent Godfrey said recent school events and meetings have been successful and the Board is well-represented. He said there has been a great launch to the new school year in Jordan District.

**MOTION:** At 7:32 p.m., it was moved by Lisa Dean and seconded by Marilyn Richards to go into closed session. The motion passed with a unanimous roll call vote.

**I. Board Directive**

It is the policy of the Jordan School District Board of Education to include all parents and guardians in the educational process of their students, no matter the language. Communication and assistance will be provided to engage families in the educational process as a partner in the education of their student(s). The Board authorizes the Administration to develop and administer a policy consistent with Utah Code 53G-7-223 (iv) (c) to provide services for English language learner students.

**II. Administrative Policy**

In order to provide support to families with engagement in the event of language barriers, the policy shall be administered in accordance with the following administrative policy provisions:

- A. Coordinating services for English language learner students within the District shall be the responsibility of Language and Culture Services.
- B. The Title III Director and Coordinator will review the policy annually and determine the need for implementation and training. Communication with applicable stakeholders will occur as needed following the review.
- C. Determination of Primary Language
  - 1. Parents or guardians will document the primary language spoken during student registration.
  - 2. If not English, the parent will be notified of rights for assistance to communicate with the school within 30 days of enrollment.
  - 3. Within thirty (30) days of a student's enrollment or re-enrollment, the LEA will make the determination of whether the student and parent require language assistance to communicate effectively with the school.
- D. Language Access Plan
  - 1. Using the student's registration information, including the documented primary language, the District and schools will provide parents or guardians information regarding free translation or interpretation services, including but not limited to:
    - a. Contact information for translation and interpretation services
    - b. Resources on the website for translation and interpretation services
    - c. Interpretation services to parents and students who require such services to communicate with the LEA regarding critical information about their child's education. Interpretation services can be provided at the site location, virtually, or by phone to meet parent needs.

2. Educators will receive an annual review of this policy, including the available translation and interpretation services.
- E. The Title III Director or Coordinator will approve translators or Interpreters. The District's approved provider should be used when needed.
1. Students under the age of 18 may not be used.
  2. Family members over the age of 18 may be used at the parent's request.
  3. Employees should ensure parents know there are District-provided translation services at no cost to the parent.
- F. Translation and interpretation shall be provided for, when appropriate and reasonable, but not limited to:
1. School activities
  2. Impromptu and scheduled office visits or phone calls
  3. Enrollment or registration processes
  4. IEP process
  5. Student educational and occupational planning processes
  6. Fee waiver processes
  7. Parent engagement activities
  8. Student disciplinary meetings
  9. School community councils
  10. School board meetings
  11. Other school or district activities
  12. Other interactions between the parents of a student learning English and educational staff
- G. Utilizing the District's translation and interpretation services to translate enrollment, academic and behavioral documentation, when appropriate and reasonable, may include but is not limited to:
1. Registration or enrollment materials, including primary language surveys and English learning program entrance and exit notifications
  2. Report cards or other progress reports
  3. Student discipline policies and procedures
  4. Grievance procedures and notices of rights and non-discrimination
  5. Parent or family handbooks
  6. Requests for parent permission
  7. Immunizations

8. Any other guidance to improve instruction and assistance by teachers, counselors, and administrators to a student learning English and the student's parent or guardian and family

H. Translation of critical communication will include, but is not limited to:

1. Use of contracted interpreting services for on-site/over the phone interpreter
2. Work with schools to ensure critical communication is communicated with all parents
3. Student-specific critical information will be provided in the covered language for the following, but not limited to, a student's:
  - a. Health
  - b. Safety
  - c. Legal or disciplinary matters
  - d. Entitlement to public education or placement in any special education, English language learner, or non-standard academic program.

I. Responding to Complaints

1. When a complaint for violation of this policy is submitted to the school principal, Title III Coordinator, or Civil Rights Coordinator, responses will follow established grievance procedures.
2. Documentation will include basic information:
  - a. Complainant's name and address
  - b. The specific details and considerations of the complaint include but are not limited to the following:
    - 1) What rights were violated – who, what, when, where, how, and how much
    - 2) Witnesses (where relevant)
    - 3) School or District's alleged discrimination in full detail
    - 4) Date of the alleged violation
    - 5) Action and preferred language
    - 6) Signature of the complainant
3. Documentation of resolution should include specific actions, timelines, and follow-up that was taken to resolve the complaint and by whom.
