Robert's Rules of Order Summary Sheet

The Order of Business

1. Approval of minutes, membership reports, and financial reports
 - a. You say: "You have received the minutes of the last meeting/month membership report/month financial report. Are there any corrections to the minutes/reports? [Pause]If there is no objection, the minutes are approved as printed and distributed to the members."
2. Reports of directors, officers, boards and standing committees. If the reports are printed and distributed before the meeting the chair only needs to ask the member presenting their report "Do you have any additions to the report as printed and distributed to the members? If no, Thank you." After verbal reports are given the chair simply says "thank you".
3. Discussion Items
4. Action Items

Main Motions

"The motion" is sometimes referred to as "the question". Both mean basically the same thing.

The motion process involves the following six steps:

1. A member makes a motion.
 - a. Make sure that the motion states exactly what you want the organization to believe or do.
 - b. You Say: I move that..
 - c. Examples of two different kinds of motions:
 - i. "I move that we form a committee to investigate the purchase of a computer."
 1. This motion only allows the committee to investigate the purchase, not to make the purchase.
 - ii. "I move that we form a committee to purchase a computer."
 1. This motion authorizes the committee to purchase the computer.
2. Another member seconds the motion.
3. The chair states the motion, formally placing it before the assembly.
4. The members debate the motion.
 - a. At this point the motion is considered pending. While a motion is pending, members can amend it, postpone it, put it aside, send it to a committee, and so on. If the discussion gets off track, you can ask: "Is there any further discussion on the motion to...".
5. The chair puts the question/motion to a vote.
 - a. To begin, the chair should restate the motion to remind members of the exact issue they will be voting on. You say: "We will now vote on the motion to...".
 - b. The chair should tell members to express their voice vote. You say: "All those in favor say 'Aye'". All opposed say 'No'".
6. The chair announces the results of the vote. This announcement should include the following four elements:
 - a. Which side has the vote: "The affirmative has it" or "The negative has it".
 - b. Whether the motion passed or failed: "The motion is adopted" or "The motion is lost."
 - c. Effect of the vote: "And we will be purchasing a computer", "Our bylaws have been amended" or "Our bylaws have not been amended and will remain as they currently read".
 - d. The next step: "The next business in order will be the report of the finance committee"
 - i. The announcement will sound like: The affirmative has it. The motion to...is adopted and we will be....

TYPE OF ASSESSMENT

FORMATIVE

- Frequent and ongoing
- Data informs short-term curricular and instructional planning



INTERIM

- Intermittent; however, administered once per year for Developmental Screenings
- Generally aggregate formative assessment data to reveal child growth on a smaller scale and inform short term curricular and instructional changes

SUMMATIVE

- Infrequent
- Data reveals "big picture" growth, and informs long term programmatic improvement

*Colorado high school graduates demonstrate the knowledge and skills (competencies) needed to succeed in postsecondary settings and to advance in career pathways as lifelong learners and contributing citizens.**



Middle School ICAP/PWR – Explore



MS Career Exploration (8th) – ‘By engaging in this hands-on experience, students not only gain a deeper understanding of potential career paths but also develop a clearer sense of their own passions and aspirations.’

Exploratory Classes – “We aim to offer a range of subjects to our students, as an opportunity to try new things that they may not otherwise get to.”

Crew/Advisory (next year) – In development this year

High School ICAP/PWR – Develop & Refine



PCAP (Portfolio/Capstone) (9th) – Students learn “how to freshman” with skill enhancement such as Google Suite, general email etiquette, vetting and citing sources, and avoiding plagiarism in the age of AI. They then move into using the Defined Learning platform to begin building their eventual portfolio, take a career matching assessment, and work on a project that matches their skills and interests.

POG Studio (a part of Advisory) – One day a week, students work on something that has to do with their portfolio, PWR, ICAP, or Portrait of a Graduate competencies.

CTE Classes – Culinary, Business, and Health pathway classes allow students to explore these fields. Next year, we will offer three industry certification tests.

Work Study/Internship – juniors and seniors

Concurrent Enrollment – Students can earn college credit through certain courses, ie Comp 1 & 2, Creative Writing, Intro to Lit, Business Comms, Patient Care Tech

Menu of College and Career-Ready Demonstrations




Local school boards establish high school graduation requirements that meet or exceed the Colorado Graduation Guidelines for the graduating class of 2021.

Local school boards and districts select from this menu to create a list of options that their students must use to show what they know or can do in order to graduate from high school, beginning with the graduating class of 2021. School districts may offer some or all of the state menu options, may raise a cut score on an included assessment and may add graduation requirements in other content areas.

Graduation Guidelines begin with the implementation of Individual Career and Academic Plans (ICAP): 21st Century Essential Skills, and Colorado Academic Standards for all content areas, including Civics.

Students must demonstrate college or career readiness in English and math based on at least one measure.

Districts have the authority to adopt the college and career demonstrations necessary to earn a standard high school diploma to accommodate for English learners, gifted student and students with disabilities.

ACCUPLACER is a computerized test that assesses reading, writing, math and computer skills. The results of the assessment, in conjunction with a student's academic background, goals and interests, are used by academic advisors and counselors to place students in college courses that match their skill levels.

ACT is a national college admissions exam. It measures four subjects – English, reading, math and science. The highest possible score for each subject is 36.

ACT WorkKeys – National Career Readiness Certificate

ACT WorkKeys is an assessment that tests students' job skills in applied reading, writing, mathematics and 21st century skills. Scores are based on job profiles that help employers select, hire, train, develop and retain a high-performance workforce. Students who score at the bronze level (at least 310 Applied Mathematics, Graphic Literacy and Workplace Documents), earn the ACT's National Career Readiness Certificate.

AP exams test students' ability to perform at a college level. Districts choose which AP exams will fulfill this menu option. Scores range from 1 to 5 (highest).

The Armed Services Vocational Aptitude Battery (ASVAB) is a comprehensive test that helps determine students' eligibility and suitability for careers in the military. Students who score at least 31 are eligible for service (along with other standards that include physical condition and personal conduct). Students who take the ASVAB are not required to enlist in the military.

Concurrent Enrollment

Concurrent enrollment provides students the opportunity to enroll in postsecondary courses, simultaneously earning high school and college credit. School districts and institutions of higher education each determine passing grades for credit and concurrent enrollment. An eligible concurrent enrollment course is: 1) the prerequisite directly prior to a credit-bearing course or 2) a credit-bearing course.

A capstone is the culminating exhibition of a student's project or experience that demonstrates academic and intellectual learning. Capstone projects are district determined and often include a portfolio of a student's best work.

Industry Certificate

Industry certificates are credentials recognized by business and industry. They are district determined, measure a student's competency in an occupation and they validate a knowledge base and skills that show mastery in a particular industry.

International Baccalaureate (IB)


The SAT is a college entrance exam that is accepted or required at nearly all four-year colleges and universities in the U.S. The current SAT includes sections on reading, writing and math. The highest possible score for each section is 800.






- **Teacher Qualifications and Hiring**

- **Purpose:** To increase flexibility for bringing in high quality candidates without a license
- **Waiver:** Ability to obtain license within 3 years of hiring date
- **Current status:** C.R.S. 22-60.5-205 - Significant updates to address teacher shortages in 2017, 2018, 2020, and 2022 and allow for multiple pathways for non-licensed teachers to be obtain a license while teaching.

- **Teacher Evaluation (Educator Effectiveness)**

- **Purpose:** To have a system that is high quality and efficient.
- **Waiver:** To use district-approved summative assessments (NWEA) in place of CMAS. Rationale: “Failure to provide results in a timely manner.”
- **Waiver:** To move to a 3 year evaluation cycle for non-probationary (3yr + experience in Mancos). Rationale: Language references time burden and critical that the state evaluation process does not accurately measure “great teaching practices.”
- **Current Status:**
 - Continue to use NWEA as an evaluation measure for student learning within the teacher evaluation process.
 - Continue to evaluate non-probationary teachers every three years.







Colorado's History of K–12 Funding Ballot Measures

Background on SB 26-135 and the Long Road to Stable School Funding

Overview

Education advocates and legislative sponsors recently unveiled [SB 26-135 “State Public K12 Funding”](#), a proposal that would divert taxpayer refunds under the Taxpayer's Bill of Rights (TABOR) to help fund the state's share of K–12 education. If the bill passes the Colorado General Assembly — which appears likely given broad Democratic support — it would go before voters at the November 2026 general election.

CASB is among the coalition of education organizations supporting the measure, which also includes the Colorado Education Association, Stand for Children, and the Colorado Children's Campaign.

The proposal is driven in part by the structural squeeze on Colorado's state budget, which is threatening to delay implementation of the new K–12 funding formula approved in 2024 and could revive the Budget Stabilization Factor (BSF) — the mechanism used for years to reduce state education funding below required levels.

How SB 26-135 Would Work

The bill — still subject to further amendment as it moves through the legislative process — would function as follows:

- For a 10-year period (budget years 2027–28 through 2036–37), TABOR taxpayer refunds would instead be directed to K–12 education through a mechanism called the "Positive Factor."
- Legislative staff analysts estimate approximately \$203.6 million would be distributed annually through the Positive Factor.
- These funds would be supplemental — outside each district's Total Program Funding (the school finance formula) — and could only be used for: increasing teacher pay, improving teacher retention, reducing class sizes, and expanding access to career and technical education.
- The measure is projected to reduce TABOR refunds by approximately \$817 million in the first year (2027–28), with varying amounts in subsequent years.
- After the 10-year period, revenues would revert to standard TABOR disposition for non-education spending.

Supporters draw a parallel to Referendum C (2005), which similarly allowed use of TABOR surpluses — for five years — to fund education, health care, highways, and police pensions.

A Long Record of Failed School Funding Measures

SB 26-135 is the latest in a series of proposals — stretching back more than two decades — in which education advocates have sought new revenue for K–12 schools. Every previous attempt to

increase general education funding through the ballot has been rejected by Colorado voters. The table below summarizes the record.

The pattern is consistent: proposals relying on income tax increases or TABOR diversions have failed across different political climates and economic conditions, with no-vote margins ranging from 54 to 64 percent.

When Colorado Voters Have Said Yes

The record is not uniformly negative. Colorado voters have approved education-related tax measures in more targeted circumstances:

- Proposition MM (2025) and Proposition FF (2022) both raised taxes on higher-income filers to fund the Healthy School Meals for All program.
- Proposition EE (2020) increased taxes on nicotine products; those revenues now serve as a primary funding source for Colorado's universal preschool program.

-
- Referendum C (2005) allowed TABOR surplus revenues to be retained and spent — for five years — on education, health care, highways, and police pensions. It also modified how the TABOR spending cap resets after economic downturns.
 - Amendment 23 (2000) established the constitutional requirement that base per-pupil K–12 funding be adjusted annually for inflation and enrollment changes.

The distinguishing factor in successful measures appears to be specificity of purpose and a dedicated funding mechanism, rather than broad general revenue increases or structural TABOR changes.

Other 2026 Ballot Measures to Watch

SB 26-135 would not be the only tax or finance-related measure Colorado voters could face in November 2026. Several additional proposals are in play, though none have yet qualified for the ballot:

- A proposal to restrict highway-related tax revenues to highway-related uses exclusively
- Creation of a graduated state income tax structure
- A requirement for voter approval of new government fees
- A reduction in the state income tax rate
- Tightening of TABOR voting requirements

The presence of multiple tax-related measures on the same ballot could affect voter attention and the political environment for SB 26-135.

Implications for School Boards

If SB 26-135 passes the legislature and proceeds to the November ballot, school boards should be prepared for questions from staff, parents, and community members about what the measure would mean for their district. Key points for board awareness:

- Funding would be supplemental to — not a replacement for — Total Program Funding under the school finance formula.
- Allowable uses are limited by statute: teacher pay, teacher retention, class size reduction, and career and technical education.
- The measure does not resolve the underlying structural budget pressures that could affect Total Program Funding in the near term.
- Colorado's ballot measure history suggests voter approval is not certain, even with broad coalition support.

CASB will continue to monitor the bill as it moves through the Appropriations Committee process and will provide updated analysis as amendments are considered. Members with questions should contact CASB Director of Public Policy and Advocacy Matt Cook, mcook@casb.org.

7. Reports to the Board of Education

7.A. Board Report Student Voice

Rhett Brown reported that he and Greta are currently reviewing and ranking suggestions submitted through a student survey conducted last month. This process will help prioritize the ideas and concerns identified by students. Rhett is also working with teachers to encourage participation from all students to ensure the survey results reflect a comprehensive range of student perspectives.

7.B. Board Report District Accountability Committee

Sarah Rank reported that the DAC met last Tuesday, with a focus on Student Wellness. Molly and Josh presented on behalf of the behavioral team and discussed the development of a referral system and a tiered framework of proactive, restorative approaches to student behavior and support. One challenge identified is that the SEL curriculum is not currently aligned across the district. A goal moving forward is to establish consistent language and practices across all campuses.

The DAC recommended that the Board consider allocating funding in the budget to support these systems and ensure sustainability. They emphasized the importance of developing an efficient system that can remain consistent through staff transitions, such as changes in deans or social workers.

Adam Martinez, student DAC representative, shared information about a proposed mentor program in which older students mentor younger students across the district. The goal is to develop mentorship opportunities at multiple grade levels.

The committee recommended implementing systems and processes that support efficient transitions in leadership roles while ensuring continuity and consistency in district practices.

Additional discussion topics included improving communication with parents and students regarding trusted adults on campus, so that students and families know where they can go to safely voice concerns.

Other topics raised included the phone and technology policy, including the use of smart watches; an update on the School Resource Officer (SRO) committee; and facility use after school hours.

The next DAC meeting will be held on March 10 and will focus on academic achievement, accountability, and identifying qualities desired in the next Secondary Principal.

7.C. Strategic Plan Objective Report

Mrs. Hazleton and Mrs. Molly Ender, School Social Worker, provided highlights from the presentation. Many of these points were also referenced in the DAC report.

Highlights included the importance of aligning systems and structures across the district to create consistency so that students can fully engage in learning. This work includes establishing clear expectations, securing fiscal support for curriculum, and developing policies that support these efforts.

They emphasized that this foundational work is critical and shared their excitement about the progress that has been made thus far. Efforts are focused on building empathy and understanding with students, noting that repetition and consistent practices help build "muscle memory" for students.

Mr. Tim Hunter would like to remind everyone of the following:

- Family Connection Night on March 11, which will include a free family dinner and childcare. Information will be posted on the district website and shared through the attached flyer.
- The PTA meeting on March 3, with organizers encouraging increased community attendance.

7.D. Board Report LRAC

Ms. Kira Taylor provided the Legislative Review Advisory Committee (LRAC) report.

Discussion included the ongoing state budget process, including efforts to balance the state budget and the continued impact of the Budget Stabilization Factor on school funding. At this time, many of the legislative items discussed are still in the discussion phase.

A new school funding formula bill is expected to be introduced, which may include a proposed 2% increase in school funding and discussion of "DeBrucing" school district budgets, which would exempt school district revenues from TABOR limitations and allow districts to retain and spend revenue above TABOR limits with voter approval.

HB26-1094 - Proposed Guidance Policies Developed by the Colorado Department of Education

This bill proposed creating a Colorado School District Superintendents Council within the Colorado Department of Education (CDE). The council would review and provide input on proposed CDE guidance policies before they take effect, ensuring greater collaboration between CDE and school districts and protecting local control. LRAC expressed support for this bill.

SB26-103 - At-Risk Student Funding Policies

This bill would require school districts and charter schools to adopt policies outlining how at-risk funding is allocated to support students who face additional barriers to learning. The goal is to improve transparency and ensure funds are directed toward programs and services that benefit at-risk students.

Ms. Taylor also shared that she will be attending an upcoming AI Best Practices seminar and will report back to the committee with information from that training.

Finally, LRAC discussed a new federal mandate requiring clarification of legal standards regarding religious expression in schools, ensuring districts clearly communicate and follow constitutional protections for student and staff religious expression.

7.E. Board Report CASB

There is no CASB report tonight

7.F. Board Report Linkage

Mr. Tim Hunter met with Mancos Valley Resources to discuss ongoing collaboration and community partnerships.

Mrs. Hazleton and the Board also discussed the joint work session with the Town of Mancos Trustees held on February 6. The meeting focused on opportunities for collaboration and cooperation between the Town and the School District, including discussion of shared public spaces and community activities.

The School Resource Officer (SRO) position was not discussed during the meeting, and the position has not yet been filled.

A key takeaway from the work session was the desire to develop shared goals and strengthen relationships between the Town and the School District, with an emphasis on understanding how community and school activities may overlap and support one another.

There was also discussion about the possibility of a student trustee serving as a representative between the Town and the School Board.

Mrs. Hazleton and Ms. Heather Alvarez will work to schedule a follow-up meeting in the coming months to continue the conversation.

7.G. Board Report BOCES

Mrs. Rachel McWhirter reported that BOCES leadership has been discussing potential software platforms to revert to for the BOCES financial system. She also noted that the Executive Director evaluation is coming up soon. In addition, pupil counts for the 2024-2025 school year are down approximately 350 students across member districts. While the number of ESS students is decreasing, this decline is having a larger financial impact on services for students.

Mrs. McWhirter also shared that Royce Trantum, executive director, is willing to attend a future board meeting to speak with the board if desired.

Audrey added that there have been discussions about local assessment models and the different ways districts are currently being charged. This topic will be reviewed more closely at the upcoming Superintendent meeting on Wednesday.

7.H. Business Manager Report

The primary focus this month has been on work related to the MLO. The current budget has not changed significantly; however, work on the budget for the upcoming fiscal year will begin in March.

Alice has been working diligently on the MLO spreadsheets, and we are on track to present the information to the board during next week's work session. We are continuing to refine the draft materials that will be shared with the boards.

The MLO committee has been a strong group that has worked hard to review the information, provide thoughtful input, and gather feedback from both the community and district staff.

7.I. Superintendent Report

Mrs. Hazleton highlighted several key updates from her Superintendent report.

Due to the snow day on Friday, staff participated in a virtual professional development day. The day included interactive elements and the introduction and launch of CREW, a structured time for staff and students that is planned to be implemented by August 2026.

Staff training continues to focus on supporting employees in managing fatigue. Doty Shepard recently presented on this topic to new staff members.

A group of teachers attended a PEBC conference in November, funded by PEBC. Those teachers shared what they learned with staff during Friday's professional development day. The framework they are developing is expected to have a draft completed by the end of the school year so it can be implemented in the fall.

Plans are also underway for spring site visits, allowing teachers to observe instructional practices being implemented in other districts.

At the elementary level, i-Ready training continues to support staff in effectively using the program to guide instruction.

PWR/CTE funding efforts are focusing on the district's "big three" priorities: industry certifications, work-based learning (WBL), and expanded career readiness opportunities.

Mrs. Hazleton also recognized Janet Fogel, HR director for her work on improving the district's hiring process. A new recruiting platform has been launched, and the hiring process is continuing to be refined. A team from the district will attend the job fair in Durango on Saturday as part of ongoing recruitment efforts.

Mrs. Hazleton informed the board that Mr. James Hughes resigned from his position on Friday, and communication regarding the resignation has been sent to staff, parents, and students.

Finally, Mrs. Hazleton reminded the board of the upcoming board retreat.


