# District 58 Financial Advisory Committee

## Minutes of March 6, 2026

The Financial Advisory Committee met on Friday, March 6, 2026 at 7:00 a.m. at the Downers Grove Civic Center.

### Call to Order

The meeting was called to order at 7:00 a.m. by Darren Hughes.

### Present

### Approval of Minutes

Boyar Zekiri moved and Jeff Villalobos seconded the motion to approve the minutes from the February 6, 2026 meeting. Motion carried.

### Year-to-Date Report

Dr. Harris reviewed the Year-to-Date report, including revenues, expenditures, and fund balances as compared to the budget.

### Cash Flow Analysis

The District continues to monitor cash flow in preparation for the low cash point in May. Dr. Harris shared a presentation on the daily cash on hand calculation to carry the District through the end of May. He noted that the last payroll of May is higher than the other two because of lump sum payouts to staff. The committee also discussed the difference between 26 pays and 24 pays and the impact on cash flow in May/June.

### Referendum Budget Update

Total referendum revenue is \$211,617,813; referendum proceeds are strictly dedicated to referendum construction and cannot be used for operating expenses such as salary and benefits. Some revenue has

come from DCEO grants, which are available through the state for capital projects. The previous DCEO grant the District received was for elementary playgrounds. The current grant is for elementary kitchen equipment. A potential future grant could be for solar panels.

Summer 2026 referendum projects include Phase III elementary schools (Belle Aire, El Sierra, Pierce Downer), kitchens in Phase I and III schools, Kingsley roof repair, and El Sierra spatial equity renovations.

The committee discussed the impact of projected referendum surplus on fund balances. A referendum surplus would create excess interest revenue, which can be transferred to the Operating Fund to help close the cash flow gap. The committee also discussed other potential options to increase revenue, including facility rentals, student activity participation fees, and reimbursement for transportation costs related to the Interim Housing Center.

### Fund Balance / Capital Projects Policies

The committee discussed proposed changes to the Capital Reserve Policy (4:152) and Fund Balance Policy (4:20). Policy 4:152 would have its title changed to Capital Facilities Funding, and provide for 5-year capital planning along with 5-year financial planning. The revised policy requires a \$750,000 transfer in FY27 (that would grow annually by CPI), and additional language clean up as advised by counsel.

Policy 4:20 includes a ratio to describe fund balance with expenditures as the denominator. It affirms the intention to calculate fund balance on a cash basis rather than accrual, and aspires to a 35% fund balance. The proposed policy mandates a remedy for not projecting at least a 33% fund balance in the annual budget, in which the superintendent delivers a financial sustainability plan to the Board.

The draft policies will be placed on the March Board agenda for first reading.

### Public Comment

There was no public comment.

### Adjournment

Joe Wojciechowski moved and Laura Stone seconded the motion to adjourn the meeting. Motion carried. The meeting was adjourned at 8:10 a.m.

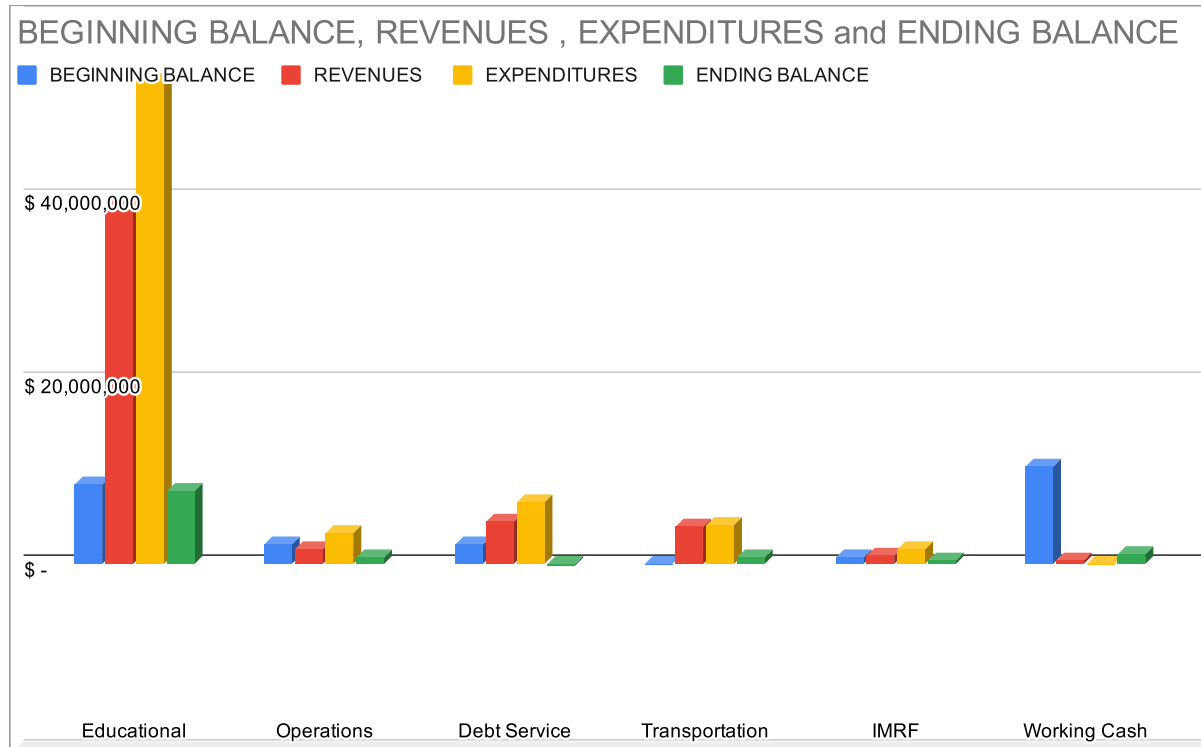
