Introduction

This memo seeks the Board of Education's approval of the Jobs for America's Graduates (JAG) Nebraska program memorandum of understanding (MOU) for year two.

The JAG Nebraska program is designed to support students facing barriers to graduation and to ensure their successful transition into the workforce or higher education. The program is led by a career specialist who utilizes a comprehensive curriculum that includes classroom instruction, counseling, and workplace experience.

Funding and Resources

- The United Way of the Midlands and various government agencies fund the Nebraska program.
- JAG Nebraska covers 100% of the Career Specialist's salary and benefits for the first two years. The District's contribution in year three of implementation is \$10,000 and shall increase annually by \$2,500 until the contribution reaches \$22,500.

Recommendation

We recommend that the Board approve the MOU allowing the District to continue participating in the JAG Nebraska program for the 2026-2027 school year.

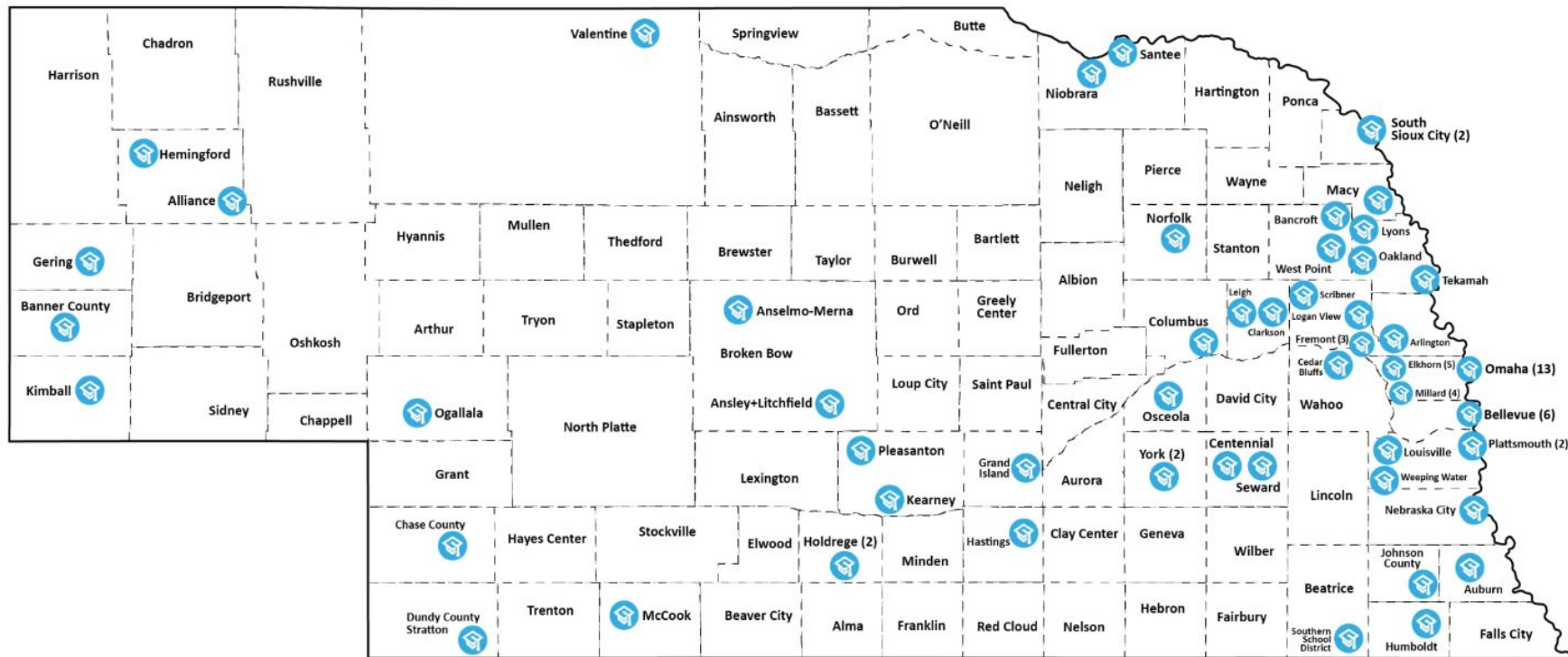
WHAT IS JAG NEBRASKA?

WHO DOES JAG SERVE?

MIDDLE SCHOOL

The fastest-growing JAG program helps 7th- and 8th-grade students transition more successfully to high school by providing a range of services aimed at improving academic performance, school behavior, attendance, participation, confidence and self-esteem.

HIGH SCHOOL

Serving 9th- to 12th-grade students who possess significant barriers to graduation and/or a successful transition to postsecondary schooling or the labor market. The program features 12 months of post graduation follow-up services.

PROGRAM COMPONENTS

Career Exploration—Students have the opportunity to explore various career paths through workshops, guest speakers, and field trips.

Academic Support—The program provides tutoring and mentoring services to help students improve their academic performance.

Leadership Development—Through leadership activities and training, students develop essential skills such as communication, teamwork, and problem-solving.

Job Readiness Training—Students receive practical training in job search strategies, resume writing, and interview techniques.

Postsecondary Education Guidance—The program provides guidance on postsecondary education options, including college application assistance and financial aid advice.

Supportive Adult Relationships—Students are paired with mentors and advisors who provide guidance and support throughout their time in the program.

WHAT ARE JAG CAREER SPECIALISTS?

- **Teachers** who facilitate hands-on learning experiences' and individual tutoring to improve graduation rates and student success.
- **Mentors** who guide and support students during this critical decision-making period of life.
- **Advocates** who extend 12 months of post-graduation follow-up and support services to help young adults access living-wage employment and/or continuing education.

REQUIREMENTS FOR A CAREER SPECIALIST

- A bachelor's degree from a four-year college or university in education, sociology, psychology, or business or an equivalent combination of training, education, and experience
- A teaching certificate in the state of Nebraska
- Experience working with high school students and knowledge of childhood development
- Experience in secondary and/or postsecondary education settings

BENEFITS FOR THE COMMUNITY

When compared to non-graduates, JAG Nebraska graduates:

- are 2.3 times more likely to be employed full time
- have a 20% higher rate of earning
- produce over \$5 million in annual earnings/spending
- are 15% more likely to own homes
- create an economic benefit of over \$50 million
- are 50% less likely to be at risk for poverty

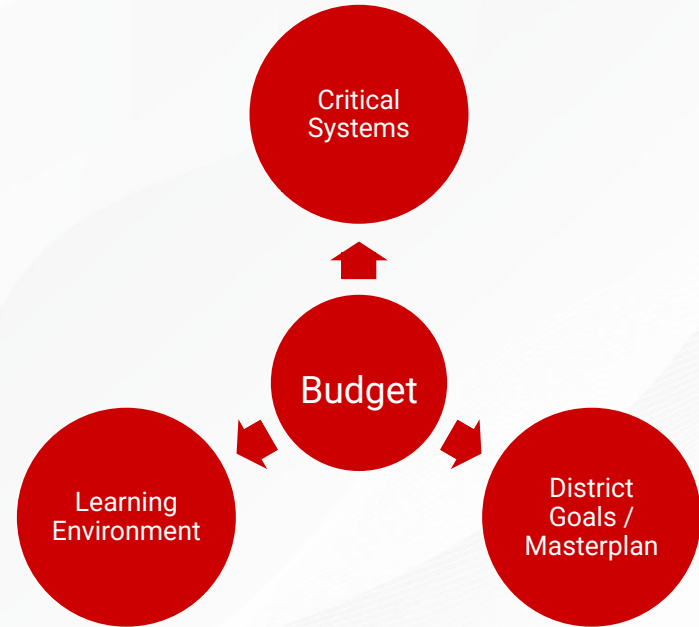

BCDM Facilities Condition Assessment

1 – Critical Replacement / Repairs Needed:

- May result in intermittent operation, rapid deterioration, associated damage, increased future cost, or critical life-safety concerns.
- These items should generally be considered within the next 0–3 years.

2 – Moderate Replacement / Repairs Needed:

- Showing predictable deterioration or approaching the end of their practical service life.
- May create future operational concerns or require attention within the next 4–10 years.

3 – No or Minimal Replacement / Repairs Needed:

- New, recently replaced, or appear to require little to no repair or replacement within the next 10 years.



CRITICAL PRIORITIES & LONG-TERM PLANNING

- **HVAC:**

- Prioritize getting ventilation systems active.
- May be able to repair/maintain some systems in the short term and budget out for full replacement later.

- **Roofs:**

- Critical roofs can be phased over an extended timeframe.

Facilities Condition Assessment

- Critical Replacement - \$8.2M (does not include resurfacing the track - \$450K)
 - Roofs - \$4.3M
 - HVAC - \$2.3M
- *“Based on our assessment, it is clear that the Scottsbluff Public Schools District has made thoughtful investments in its facilities. When we conduct facility assessments, we often find critical needs across all the primary building systems. It stood out to us that the district has already addressed several important infrastructure needs in facilities that are well positioned for long-term use. Upgrades to electrical and technology infrastructure along with continued attention to building finishes, address infrastructure needs while having a direct impact on the student learning environment. While there are still important infrastructure needs to plan for, the district has done a good job of directing resources toward facilities and improvements that are best positioned to provide long-term value.” - BCDM Architects*

Considerations

- What was prioritized in the elementary modernization?
 - Mission: In a fiscally prudent, systemic and future focused manner, to improve the quality of teaching and learning for students and staff at our elementary schools
 - Safe, secure learning environment
 - Welcoming environment for students, parents, and community
 - Classrooms designed for flexibility and future instructional needs
 - Integration of technology
 - Efficient, pleasing working environment for staff
- Changes in the scope of the Elementary Modernization project addressed items such as electrical updates, safety and security updates, and fire suppression at Westmoor, that would have been identified as critical needs in this assessment.

Current Budget and Tax Authority

The District's combined Levy has dropped from \$1.2933 in 2022-23 to \$0.8514 in 2025-26. That is a savings of \$441.90 per \$100K in valuation for Scottsbluff taxpayers!

How do we compare to the 242 other school districts in Nebraska?

- Scottsbluff Public Schools ranks number one in General Fund Levy reduction from 2022-23 to 2025-26.
- Scottsbluff Public Schools ranks fifth in overall levy reduction from 2022-23 to 2025-26.
- Even with an additional 10 cents we will have reduced our levy more than 229 other school districts in Nebraska.

How would the resolution impact taxpayers?

- Total Additional Property Tax Authority (5%) = \$2,186,810
 - School Property Tax Credit would help offset the additional property tax authority.
For 2025, the property tax credit was 28% which would be \$612,307.
- Impact per \$100K of valuation = \$98.81
- Even with adding an additional 9.88 cents to our tax authority we will have reduced our levy more than 230 other school districts in Nebraska.

If we were still at the \$1.3153 levy, the tax asking would be \$29,110,752.

Rationale for Recommendation

- In alignment with our strategic plan, we are seeking Board approval to request an additional 5% in Property Tax Authority in order to secure the necessary funds to execute a short-term and long-term facility plan.
- This plan has been developed to fund critical repairs without the need for a bond issue.
- Not passing the resolution will leave us vulnerable to catastrophic HVAC failure or roofing related building damage.
- Budget cuts to provide these updates will adversely affect classrooms, instruction, and staffing and not align with our budget priority of maintaining financial cash reserves in accordance with Nebraska State Statute.
- This levy authority may not be available in future years.
- 2026 LB 1219 would have put a 2% cap on allowed property tax asking.

Recommendation

Approve the resolution to increase the school district's base growth percentage by 5%.

RESOLUTION

WHEREAS, Nebraska Law generally limits a public school district's base growth percentage, subject to limited exceptions; and

WHEREAS, Neb. Rev. Stat. § 79-3405 includes an exception to generally allow a school district to otherwise exceed the base growth percentage if at least seventy percent of the Board of Education votes in favor of the increased request; and

WHEREAS, a Board of Education of a school district with an average daily membership of more than three thousand forty-four students but no more than ten thousand students may increase its base growth percentage by up to an additional five percent above the base growth percentage; and

WHEREAS, the average daily membership of Scotts Bluff County School District Number 79-32, a/k/a Scottsbluff Public Schools (the "School District") is more than three thousand forty-four students but no more than ten thousand students; and

WHEREAS, due to student and staffing needs, and the need to maintain its budgetary obligations, the Board of Education of the School District hereby desires to increase its base growth percentage by up to an additional five percent or other maximum amount as permitted by law; and

WHEREAS, public notice of this possible increase was published in a legal newspaper of general circulation in the School District at least one week prior to this Board meeting.

NOW, THEREFORE, BE IT RESOLVED that, pursuant to Neb. Rev. Stat. § 79-3405, at least seventy percent of the Board of Education of this School District affirmatively votes to increase to the School District's overall base growth percentage by up to an additional five percent above the base growth percentage, or other maximum amount as permitted by law. The Superintendent or designee is hereby authorized and directed to take any action consistent with this Resolution to ensure that the School District's overall property tax request complies with this Resolution.
