 - C. Provide Board Member training to the members of the _____ Board of Education.
 - D. Provide continuing technical support to resolve any questions, problems or issues concerning BOEconnect.
 - E. Keep _____ Board of Education apprised of any changes/improvements to the BOEconnect program.
- II. The school board agrees to perform the following services:
 - A. Provide TSBA with email addresses and passwords for all users involved in the initial training sessions.
 - B. Provide the computers, internet access and other technology necessary to access and use the BOEconnect service.
 - C. Provide TSBA a location for training that includes high speed internet access.
 - D. Pay the cost of \$3,500.00 for the initial year’s user fee and renewal fees as indicated in the Payment schedule. **(Set-up fee of \$500.00 waived for TSBA policy subscriber)**
